EARLY CHURCHES

OF

OLD PENDLETON DISTRICT

The Baptists and Presbyterians were the earliest and strongest organizers of churches in Pendleton District. Quite a bit later the Methodists, Episcopals and some smaller denominations formed churches. The September NEWSLETTER covered the earliest Presbyterian churches in Pendleton District. It so happened that these were in or near the village of Pendleton, some in what is now Pickens County and some in Anderson County. This article deals with early Baptist churches in Anderson County. The April NEWSLETTER will be about some early churches in Oconee County.

One thing noted while reviewing material for these first two articles is that during the frontier days there were a few people that we would today call activists. The same names keep appearing among those listed for several churches. Apparently, the same pastors and even elders and deacons circulated freely.

BIG CREEK BAPTIST CHURCH

The Baptists earliest church was Big Creek and was then located about three miles from Williamston, SC and formed in 1788. The original church was located about ½ mile north of the present one which is on Big Creek Road (Hamilton St.) south about ½ miles from Main St., Williamston, SC.

The land for the original church was donated by the Williams family which owned thousands of acres in the area bounded Big Creek for which the church was named. Both of the pictured churches still stand. The first services were held in a log building as was so commonly done.

Big Creek was organized by Moses Holland, a native of Culpepper, VA, who had recently settled in the community. He was ordained the first pastor in which capacity he served the remainder of his life.

As in the case of Carmel Presbyterian Church (See September NEWS-

LETTER), many sprang from it. They were:

The Church joined the Saluda Baptist Association in 1803. In 1965, the church transferred its membership to the Palmetto Baptist Association.

There is a cemetery at the church which contains its founder, Moses Holland, b. 17, Nov 1758 in Virginia, d. 8 Sep 1829 and many others, among whom is Dr. James Bruton, b. 1841 in Anderson Co., d. 10 Jun 1921 in Texas. He was President of Mercer University, editor of Baptist Record and Baptist Standard, President of Southern Baptist Conv. four times and faculty member of Southwestern Theological Seminary (Baylor University).

SHOCKLEYS FERRY BAPTIST CHURCH

This church was constituted around 1790 and became extinct in 1826. It took its name from Shockleys (Later Browns Ferry) on the Savannah River near where it was located. A small log house was built about a half mile southeast from the present Shiloh Church. About 1800, Cooper Bennett came into the church and subsequently became its pastor In 1803,

it became a member of the Saluda Baptist Association. In 1806, it had 106 members.

This was the mother church for many Baptist churches in southwestern Anderson County. Prominent among its leaders were James Chastain, Cooper Bennett, Jacob Brazelton, and William Leonard. James Burriss and Richard Madden, both of whomafterward became prominent preachers, were at one time members of this church.

It was the mother church for the present following churches: Salem, Mountain Creek, Starr and Mount Tabor (Now Anderson First. Some of its members helped establish Shiloh and Hopewell.

During its short life, there was much controversy among Baptists regarding whether Baptist churches should do missionary work. In 1823, Cooper Bennett was pastor and a strong believer in missions. He was denounced as a heretic, rejected as pastor by the other churches of which he was also pastor and finally excluded from fellowship in Mountain Creek Church of which he was a member. Shockleys Ferry Church stood by him and as a result was excluded from the Saluda Baptist Association in 1826. As a result, the church withered and died.

ANDERSON FIRST BAPTIST CHURCH

This church started as Mount Tabor about $1\frac{1}{2}$ miles south of Anderson, SC a few hundred yards west of the Lowndsville Road. A few old tombstones mark the site. It has been used as a cemetery by the black people of Anderson. The present church is right in the center of Anderson facing on McDuffie St.

Sometime before 1821, James Burriss began preaching under a bush arbor at the Mount Tabor site. At that time, he owned and lived on the plantation later known as Captain John W. Daniel's mill farm. Shortly, an arm of Shockleys Ferry Baptist Church was established here. A house of worship was built of large hewed logs. It was constituted an independent church in 1821 with a membership of 56 persons.

In 1827, Pendleton District was divided into Anderson and Pickens Counties. The county seat was established for the new Anderson County and a village was soon formed around it. In 1834, the Mount Tabor church was moved into the town and a small frame

building was erected on the present site of Anderson First Baptist.

NEALS CREEK BAPTIST CHURCH

Sometime prior to 1803, an arm of Big Creek Baptist Church was formed in the Neals Creek Community about six miles southeast of Anderson, SC on US76. Moses Holland, pastor of the Big Creek Church visited at stated times and preached there. In time, it became evident that a church was needed at Neals Creek and was organized 19 March 1803 with a membership of 84, most of them being dismissed from the Big Creek Church for this purpose. It was admitted to the Saluda Baptist Association the same year.

The first building was a small log house erected on land owned by John Vandiver and was a about 3/4 mile northeast from the present church. Sometime later a new log cabin church was built near the present site. The church shown at the left was built in 1939. Just beyond it, a new and much larger church is now under construction.

No records are available from 1803 to 1812 but an old church book made by A. Rice in 1830 indicates that regular activity existed during those nine years.

For some reason, membership had dropped to 37 by 1817, less than half its original number. The membership began to build

again although your editors source does not give the number of members. By 1827, the church had outgrown its house of worship and a new frame building was erected on the same site.

In 1847, the church was involved in serious discord which finally resulted in the dismissal of Elder William McGee who had served the church well for 27 years, 18 of which were as pastor.

In 1870, the church was so dilapidated that a new one of brick was completed in 1871



EARLY PENDLETON DISTRICT CHURCHES

It seems that the Presbyterians and Baptists were almost equally active in Oconee Co., Cir. 1800. However, the Baptist churches appear to have had greater growth and continuity. The Rev. John Cleveland was a prime mover in organizing Baptist churches throughout the area. He is found as organizer and part time pastor in Hepzibah, Coneross and Chauga Baptist churches as well as in Shoal Creek Baptist in Franklin Co., GA and many others.

There is conflicting evidence as to the mother church, if any. It must be remembered that much of the early religious activity was spontaneous on the part of the settlers, many of whom were squatters. "South Carolina Baptists" by Leah Townsend credits the Shoal Creek Church of Georgia as the mother church and a list of early members is given stating that such a large number were from across the Tugaloo River in what is now Oconee Co., SC that the church moved across and became Chauga. There is still a Shoals Creek church across in Georgia. The earliest list of members at the Shoals Creek, GA church should have included many of those on an 1808 list of Chauga members. There is little enough duplication to indicate any very close association by the two churches and that Leah Townsend was in error.

There is a Scholes Creek in Oconee Co., SC and there was an early church located there before the Chauga church was formed. This combined with the membership lists is enough to raise doubts about Shoal Creek of Georgia being the mother church. If anyone has more evidence relating to this problem, your editor would like to know about it. If more proof can be found, it will be published later. In the meantime, we do know that the churches did get formed somehow.

CHAUGA BAPTIST CHURCH

The present church is located on Hwy. 141 west of US123, south of Westminster, SC.

Practically no reliable history exists for the early Chauga Church. We do know that the present name was adopted in January 1816. The earliest building was a log structure, built in 1808, a short distance below where US123 crosses the Chauga River and just above the confluence of the Chauga and Tugaloo Rivers. The swollen waters of the Chauga destroyed it. It was replaced by another log structure almost directly across from the present building.



Following are two undocumented Chauga membership lists which are believed to be reasonably accurate. If anyone has access to original documents, your editor would like to be informed of their location.

CONEROSS BAPTIST CHURCH



The Coneross Baptist Church is located on SC183 south of Walhalla, SC. It was constituted in September 1798 with 73 members. The new church joined the Sarepta Association formed in 1799. The first pastor was Littleton Meeks. In 1805, the church had 178 members, nine of them black. and John Cobb was pastor.

The first building for the congregation was built about

1812 on a site nearer to Walhalla than the present location. The present with later additions was built in 1926. The front steps of the church are known as the "hen steps" because they were were constructed with the profits of a hen sale conducted by the women of the church. A cemetery surrounds the church on two sides.

No church records survive for the years 1798-1833. An extensive history of the church* gives much detail about occurences after 1833. Included are membership lists and statistics. These will be published in a later newsletter as space becomes available.

HEPZIBAH BAPTIST CHURCH

Old Hepzibah Baptist Church was organized in 1803 and has remained on the same site since then. Todays church building was erected on the foundation of the early log structure. It is located about 6 miles south of Seneca, SC on the left side of Hwy. 21 (Walnut St. in Seneca).



If visiting Old Hepzibah Church, do not confuse it with another unrelated church organized in 1924-1925 and calling itself Hepzibath Southern Baptist Church. It is on the right side of the same road as Old Hepzibah and is of brick and stone construction.

The Beaverdam Baptist Church began as an arm of Hepzibah. For its story, see the January 1983 NEWSLETTER.

There seems to be a complete dearth of records from which to create a story on the history of the old original church which is one of the earliest in the area.

GEORGIA LAND GRANTS IN SOUTH CAROLINA

Recently, your editor ran across the following data which Mrs. Shuler had compiled and a copy of which she had placed in the Pendleton Hist.& Rec. Commission files. At least some genealogists know that a piece of South Carolina was claimed by Georgia. During that time, many land grants were issued by Georgia for land now a part of South Carolina. The following data relates to land grants for land then in Franklin County, Georgia. Many of these were in what is now a part of Oconnee Co., SC. Mrs. Shuler took these from the Index in Book 40, Georgia Grants in SC in the South Carolina Archives.


