



CORNELIUS KEITH: Robert Hicks, Sr. of Prince George Co., MD who settled later in that part of Surry County, VA which was added to Brunswick Co., VA in 1732, patented 580 acres on the north side of the Roanoke River adj. the land patented by Robert Munford and John Anderson. Robert Hicks gave 100 acres of this tract to Cornelius KEITH in 1734 for seating and cultivating a part of the land. He gave the remaining 480 acres in 1735 to Samuel Clark, Jr for true love and natural affection. This tract of land on the north side of the Roanoke River was opposite the tract of land patented by John ALEXANDER in 1727.

Between these tracts of land was the famous "Horseford" Captain Hicks, noted as an Indian Trader, undoubtedly had selected this tract of land on one of his many trading trips to trade with the Southern Indians. The Trading Path into the Carolinas crossed the Roanoke River at this point. Near this point, Cornelius KEITH was granted a license in 1739 to keep a ferry over the Roanoke River from his own landing below the Horseford to Alexander's landing. Cornelius KEITH apparently discontinued the operation of the ferry, however, for in 1741 Martha ALEXANDER, widow of John ALEXANDER, petitioned the Brunswick Court for a license to keep the ferry from her landing over the River to Cornelius KEITH'S landing, which was granted. Cornelius KEITH sold his land in 1742 to Thomas Twitty.

Cornelius KEITH was undoubledly a first generation immigrant for in a deposition 3 May 1739, in the Brunswick County Court, he stated that he has resided 30 years in this Colony since his importation. He had apparently come to Virginia as an immigrant in 1709.
