Elizabeth "Betti" Earle ROBINSON and John V. MOORE lived in Anderson, SC. John V. MOORE died on 3 Sept 1862 from wounds he received during the 2nd Battle of Manassa. Elizabeth had one child to survive: William Robinson MOORE. Wm. R. MOORE was born abt 1858\9 in Anderson District, SC. His mother deeded him her house located on Greenville Street in Anderson in 1885. The last transaction from William Robinson MOORE found 22 Feb 1905 was a deed. Looking for information on this William Robinson MOORE.

Also need information on John V. MOORE'S parents. John was born abt 1833 in Anderson District, SC. He attended University of VA obtained law degree. He was also Editor of the "TRUE CAROLINIAN" newspaper. His parents are believed to be James MORE 53 and Mary G. 38 from Anderson District, SC. The 1850 Anderson Census shows: John V. MOORE'S siblings are as follows: William G. 18, Elaib V. 14, Mary Ann 13, James A. 10, Elizabeth 9, Thomas E. 7, and Matilda W. MOORE age 3. Need info on this line to verify John V. MOORES' parents.

Thompson TIPPENS, my g-g-g-g-grandfather, was b. in SC ab 1813. I have traced the TIPPING\TIPPENS name from England to Maryland to NC, then to Old Pendleton District of SC. Ir is very dangerous to assume anything in genealogy, but George TIPPENS and Millie TIPPENS were the children of John TIPPINS b. ab 1750 in NC. George and Millie both migrated from Pendleton District, SC to Hall Co., GA in the 1820's. Millie TIPPINS and family finally settled in Cobb Co., GA. George and Thompson TIPPENS both appeared in the 1840 Census of Cherokee Co., GA. I am assuming that George is the father of Thompson. If anyone can prove or disprove this it would be greatly appreciated.

NOTICE: Is hereby given that application will be made to the Board of Commissioners of Roads for the 5th Regiment of SC Militia for the discontinuance of the Reed's Ford Road—The Mauldin Ford Road, and so much of the old Road leading from Pickens Court House to Pendleton as is not used by the Greenville road or the new road from Pickens to Pendleton. Sg: E.G. Gaines, H.L. Gaines 7 Jan 1851. Keowee Courier, Saturday 29 March 1851.

JAMES CALDWELL: (Several James')

Rev. Pension No. S8163 South Carolina. Born Oct 1757 County Antrim, Ireland d. 28 Oct 1847. Enlisted while residing in Lexington District, SC in late Dec 1778 under Capt. John Kerisler (Kensler?) and Col. Charles Hicksley. In Nov of 1779 under Capt. Godfrey Dreher. Under Capt. Jonathan Owens in May 1780 and under Capt. Gabriel Fridign in July 1780.

James Caldwell sold, 13 Dec 1803, 177 acres on both sides of Rocky River in Abbeville District SC for \$100 to James Gilliland of Pendleton District bounded by David Caldwell, John Still, Thomas Drinnan, Joseph Drinnan and Charles Wilson--part of tract granted to Caldwell. Anderson Co SC Conveyence Bk G pg 460-461

A James Caldwell m. Williams d/o Washington Williams of Laurens District SC--SC Equity Records Vol 4 pg 175-179 dated 1830.

BANKRUPTCY RECORDS: Following the Civil War many bankruptcy notices appeared in the area newspapers. Many of the people were prominent, such as Dr. T.J. Pickens, or notorious, such as J.R. Cochran, or renowned for other reasons, such as M.R. Hunnicutt, whose son was killed in 1867.

Bankruptcy always has been a federal matter, so those records are located at the Southeastern regional branch of the National Archives in Atlanta (1557 St Joseph Avenue, East Point, GA 30344; Tel: 404-763-7477).

The records are similar to inventories in estate papers, listing assets and debts. The National Archives staff at Atlanta prepared the following list of their files for the post-Civil War era (earlier and later records are also there). Anyone interested in business history may note the records of several general stores or other businesses; much farming information also appears with details of tools, machinery, crops on hand, etc. Submitted by: J.W. JAMES STANDRIDGE: Pickens Co., SC Probate Court Box 7 No. 94
1 August 1837: Where Isaac Standridge hath made application for letters of Adm of the goods etc. of James Standridge late of Pickens District, SC and the kindrid and creditors of the said deceased to appear at the Court of Ordinary of Pickens Court on the first Monday of Sept next. Sg: James H. Dendy.

5 Sept 1837 We Isaac Standridge, Wm Simpson and John Rider are holden and bound unto James H. Dendy, Esq. in full the sum of four thousand dollars: the condition of the above obligation that if the above bound Isaac Standridge of State and District adm of the goods etc. of James Standridge Sr deceased made a proper inventory which has or shall come into the hands or possession of Isaac Standridge I shall pay unto such persons as are entitled to the same by law of if it shall here after appear that any last will and testament was made by the said Deceased and the same be proved in Court I will letters of Adm to the Court. Sg: Isaac Standridge X., Wm Simpson.

OBITUARY--MRS FRANCIS B. SHIRLEY: died on Monday night the 19 August last, Mrs Francis B. Shirley, wife of Thomas Shirley in the 28th years of her age. She has been laboring under a disease of the chest, thought to be dropsy. She left a widowed mother, husband, and three small children. Anderson Gazette Issue: 20 Sept 1844

TOWN CREEK BAPTIST CHURCH:

On the 4th day of Oct 1903 a number of persons assembled at Town Creek School house for the purpose of organizing a Baptist Church after a service by Rev. B. Holder. A council was formed by the election of Rev. B. Holder, moderator and C.E. Robinson clerk. The Presbytery consisted of Rev. O.S. Galloway, B.E. Gravley, J.B. Trammell and B. Holder, Deacons J.H. Vaughn, W.J.N. Burton, T.H. Hunnicutt, M.B. Chappell, J.E. Cox and C.E. Robinson. Letters of discussion was presented by the following persons: F.P. McAlister from Concord Bapt, M.D. Chappell from Rocky Botton Bapt, these two bretherings were received: Luther Pace, Lucius Pace, Alice Pace, Cora Chapell, Lula Earle, Pinkie Earle, Lillie Chanceller all applied for membership. Church agreed too apply for membership in the Pickens Baptist Association. 5 March 1904 Committee found a place for church-between brother McAlister and A. Pace but agreed to wait until a better turn out, very cold cloudy day.

3 April 1904 Charge brought by Bro McAlister against Sister Pinkie Earl for going of with a man said to have a living wife--she was excluded. Sister Galloway joined by letter from Rocky Botton Church and Mrs Berry Pace from Methodist Church.

OBITUARY: MRS FRANCES BROYLES: died at her place of residence on the 7th inst. Mrs Frances Broyles consort of Major Aaron Broyles in the 72nd year of her age. She complained at times of a difficulty in breathing. Many years a member of the Baptist Church. Anderson Gazette Issue: 17 Sept 1841

DIED: At Thomas D. Morgan's in Pickens District on the 9 Nov 1857, after a long and painful illness of Paralysis, Mrs Mary Cannon, wife of the late James Cannon in the 84th year of her age. The deceased had been a member of the Baptist Church for upwards of thirty years. She leaves many relations and friends. Keowee Courier Saturday 28 Nov 1857

JOHN FOSTER SMITH FAMILY: Need concrete proof that John Foster Smith was son of Zacheriah Smith. There is no concrete proof on some of these Smiths. Oldest Business in Pickens County

BRIEF HISTORY of THE PICKENS SENTINEL by
JERRY L. ALEXANDER, Publisher, 1993

For some 122 years the flow of vital information to an ever-growing population scattered across the Blue Ridge Foothills of Pickens County has been uninterrupted through the pages of *The Pickens Sentinel*, "a newspaper with a conscience." From the first recorded thoughts of owners D.F. Bradley and J.R. Holcombe in 1871, to those I humbly try to convey in 1993, we have always had the best interests of Pickens County at heart.

The first issue of The Sentinel was published in July 1871. This date was obtained from the issue of Sept. 13, 1877, "The Pickens Sentinel started out six years ago in July." The Sentinel has never missed printing a weekly issue, except the week of Christmas in later years, and it is the oldest continuous business in Pickens County. Once, when the newsprint did not arrive by train for the March 6, 1873 issue, due to heavy shipments of fertilizer, the newspaper was condensed and printed on old-timey Blue Horse notebook paper. This issue is unique in the annals of South Carolina journalism.

By the fall of 1873 D.F. Bradley was editor and proprietor of the newspaper. Under his ownership, J.H. Carlisle had charge of the editorial department for the winter of 1875. During 1876 and 1877 J.C. Thompson served as printer.

The August 26, 1886 issue of The Sentinel ran the following ad: "The entire interest in The Pickens Sentinel is offered at a private sale. The paper has a good circulation, is on a good financial basis and is a good investment. For prices and terms contact D.F. Bradley, Columbia, South Carolina." J.E. Boggs, editor bought the interest of Major D.F. Bradley in the newspaper. Boggs soon informed his subscribers that, "a sheep is just as current at this office to pay subscriptions as greenbacks." Editor Boggs wrote the letter placed in the cornerstone of the second Pickens County courthouse and which was reinterred in the the cornerstone of the present courthouse. Under Editor Boggs leadership, L. Clyde Boggs learned the printer's trade. When Mr. Boggs, a prominent lawyer, became solicitor, he sold the paper to J.L.O. Thompson, a distinguished newspaperman from Oconee County and H.A. Richey, Mr. Thompson's father-in-law.

The Sentin el has had many employees, some of the issues prior to 1900 give the names of some of these men. Joe E. Kinch, of Lamar, Missouri, became foreman of the paper during the winter of 1889 and was still employed in that position in 1894. P. Eugene Alexander left the newspaper in 1895 and moved to Atlanta, Georgia. Charles E. Robinson was editor during 1897 and Homer A. Richey, Jr. was working on the paper and in 1901 Walter O. Hester was foreman.

The Sentinel showed good progress during the late 1800's,

however, competition developed on the scene in 1891 when The People's Journal appeared. The new paper was edited by T.C. Robinson and was backed by such prominent citizens as W.T. Field, B.J. Johnson, J.E. Burroughs, J.T. Boggs, J.D. Cureton, Laban Mauldin and Matthew Hendricks. The Journal's life span was not long and the Sentinel and Journal were merged. For a number of years the masthead carried The Sentinel-Journal title.

During this time the newspaper was printed on a press turned by hand. A strong Negro man named Bill Bowen and his son, Hovey, turned the flywheel on the old-timey press. The first automatic typesetting machines were installed by Mr. Thompson and the work was speeded up considerably by the Simplex -- a forerunner to the modern day Linotype.

After the turn of the century the Sentinel suffered a severe setback and the owner was forced to sell the paper. The editor severely blasted a school teacher for a whipping given a lad which the editor felt was too severe and for expelling the child from school (who incidentally was the editors son). The quarrel developed into such a fracas that a boycott by local merchants was called, forcing the editor to get advertising from Greenville and other area towns. Advertising soon dwindled and the paper was sold.

In 1912 Mr. Thompson sold The Sentinel to a stock company headed by J. McD. Bruce. At this time Rev. D.W. Hiott was asked to take charge of the paper and he brought in his two sons, Gary and Whitsitt, who had learned the printing trade in Greenville and Athens. The Miotts operated the paper for several years before Gary went to The Greenville News and Whitsitt began his own print shop in West Greenville. W. Lesley Mattheney operated The Sentinel following these changes.

Gary Hiott moved back to the newspaper for a short span of time, sold The Sentinel to the late F.V. Clayton and continued his writing on The Greenville News and Abbeville Medium. In 1927 Gary came home again and bought back the newspaper from Mr. Clayton. During the late 20's and early 30's the quips and paragraphs by the editor were widely circulated and published in the leading periodicals of the day, notably The Literary Digest. Gary Hiott died in 1950 and The Sentinel was then published by his wife and two sons, Gary, Jr. and David.

The Sentinel has weathered several depressions and during the thirties would have changed hands, as many papers did, had not Mrs. Hiott been postmaster at Pickens. She used much of her income to finance the newspaper operations. During these difficult times the paper had only four pages and the barter system helped keep the paper going; eggs or firewood would pay for a years worth of news. The payroll was \$27 per week: \$25 to the Linotype operator and \$2 for the printer. During the 40's the paper had the assistance of Robert Hiott, who worked on the paper at night during World War II in addition to his regular day time job. The Hiott Printing Co. and the Hiott family have been involved

with the publication of *The Sentinel* for almost 80 years. In 1993 the paper is still printed by the Hiotts.

When the Hiott family decided to get out of the newspaper business, they made the decision to sell the paper to someone willing to continue the tradition of community service. In 1978 they sold the paper to Ben Bagwell, then editor of The Sentinel and Jerry Alexander, a veteran newspaperman, then associated with The Anderson Independent. After a few years, Bagwell sold his interest in the paper to Alexander, a Pickens County native who has remained as publisher for the past 15 years. Don Hunt is now General Manager of the paper. The Sentinel still carries the famous motto, "a newspaper with a conscience". This motto helps guide the staff in decision-making every day. Alexander also publishes six specialty magazines through a separate company known as Leisure Media, based in Pickens.

The Pickens Sentinel has had several homes over the years. First, a wooden building on Main Street, two separate locations on Ann Street, on the corner of Ann and GRIFFA Sts. and then the former American Legion building. Several other locations were used for a short period of time before the need for more space caused the paper to move to Johnson Street. The current Sentinel office is located on Garvin Street.

Local Historian, Marvin Gravely, grew up in the Twelve Mile area and saw his first Sentinel at an early age. Since it was the only newspaper around, Gravely said, "We looked forward to getting it every week." He remembered several tidbits about the paper that most have never heard; at one point an editor of the paper wrote a story which predicted the outcome of a trial before it was brought to court. According to Gravely, the judge took offense to the prophesier's article and called the editor to court, found him guilty of contempt of court and without hesitation fined him \$100. At the time Gravely was a boy, citizens of Pickens County could subscribe to The Sentinel for \$1 a year or \$25 for life. Most could not afford the lifetime subscription rate but those who did still receive their weekly edition of The Pickens Sentinel. We will continue to honor these lifetime subscriptions.

Six generations of local families have depended on The Sentinel to provide them with the news. No longer is the weekly paper the only source for news and local happenings, it has been augmented with radio and television. Times constantly change as does The Sentinel. The staff of The Pickens Sentinel is proud to have played a roll in the local information needs of the most wonderful county in South Carolina. We hope the citizens of Pickens County will see fit to read The Sentinel for the next 122 years.

It is this rich history that authors Peggy Rich and Marion Whitehurst have chronicled in this book. They are extremely competent and have done a tremendous job in creating this volume. Readers should consider it an extremely valuable research tool.
