A.B. VANN b. SC. In 1830 census of Walton Co., GA he was head of his own household and married. In 1840 census of Campbell Co., GA, he and wife had 4 children 2 sons and 2 daughters.

In 1829 Ansil/Ansell (Ben A.) had land transactions in Walton Co., GA in 1831 and in Campbell Co., GA. Other names on these deeds were Seaborn, Seaborn J., James O., and Martha VANN. In 1833 Seaborn VANN with James WARD sold land in Cherokee Co., GA to Samuel HALE of Richmond Co., GA. In 1835 Joseph VANN sold land in Coweta Co., GA. In 1835 David VANN sold land in Campbell Co., GA. In 1836 Rhubin VANN sold land in Coweta Co., GA. In 1837 Seaborn J. VANN sold land in Cherokee Co., GA to Uriah POPE of Muscogee Co., GA. In 1838 Seaborn J. VANN sold the above piece of property, again, this time to Oliver COWARD, Ansell B. VANN witnessed this transction. He also witnessed the land transactions for Seaborn VANN.

Ansell, Josiah and Seaborn J. and wife Tabitha VANN are next found in 1850 census, Washington Co., FL. In Ancil's household were: Ancil b. 1803 SC, Josiah b. 1808 GA, Seaborn J. b. 1839 GA, Tabitha A. b. 1840 GA, Susan b. 1846 FL and Louis C. b. 1848 FL. Not shown was William J. VANN b. 1835. Next door was Seaborn J. b. 1805 GA and wife Tabitha b. 1817 GA.

Who was Martha VANN, David VANN, James O. VANN, Rhubin VANN, William May VANN and Joseph VANN. Who were their ancesotors and descendants? Are they related?

ESTATE--GEORGE S. SMITH: This copy was found mixed in with other papers and out of sort. I found only part of this Estate: I have not been able to fine the rest of estate in any of the files at Pickens County, SC Courthouse "Annex."

Written on side of this copy is: George S. Smith b. 5 Aug 1805 d. 1864/5 by his son George Washington Smith:

VIZ: insufficient for payment of debts. That the real estate consisted of a tract of land containing 158 acres more or less on waters of Little Brushy Creek in this County bounding lands of Alexander Orr and others. That the heirs at law of said Intestate are the widow Elizabeth Smith and the following named children to wit, Mary Ellen Spencer wife of Lane Spencer. Zaney F. Dickinson wife of John Dickinson, William Smith, Linda Hammond wife of Hoke Hammond, Lucinda Sears wife of George Sears, Susan Pilgram wife of Elford Pilgram, Joseph L. Smith, Eugena Smith, Elizabth R. Smith, Timothy T. Smith, Leonara J. Smith wife of William R. Smith and your petitioner (George Washington Smith). That all the parties live in Anderson County SC except Lucinda Sears who resides in Oconee Co., SC and Leonara J. Smith who lives in DeKalb Co, State of Alabama. That the tract of land above described was brought to sale by Robert Jenkin late Ordinary of (The End)

WILL: ALEXANDER OLIVER: Pendleton District, I Alexander Oliver being in a low state of health etc. This 28 Nov 1821--to my beloved wife Mary Oliver my house I live in and all the house hold furniture and kitchen furniture and a comfortable support off my plantation during her life also a negroe woman named Lett and hir increase during hir life--to my son John Oliver one dollar--to my daughter Gome White one dollar--to my son Samuel Oliver one dollar--to my daughter Jamima Casin one dollar--a negroe girle named Charlotte also another girle named Ann to my son James Oliver--to my daughter Mary Oliver one dollar--to my daughter Susannah Oliver one dollar-to my son Andrew Oliver all my plantation with the exception of the above reservation to his mother--all tools, stock, cattle, horses, hogs, waggon and blacksmith tools, and the following negroes to wit: Old Sam, Ben, Candis, Leah, and the negroe woman Lett and her increase above mentioned at the death of my wife and son Andrew pay the above legacies and my just debts and collect what debts are due me. Exor: son Andrew Oliver. Sg: Alexander Oliver. Wit: R.M. Cann X, Susannah McMahon X. Docias King X. Prov and Rec. 16 Aug 1830. Anderson Co SC Will Bk A pg 419.

(NOTE: Samuel Oliver was in Columbia Co GA in 1791-James Oliver m. Martha who d. 2 July 1877 Anderson Co SC their daughter Prudence E. Oliver b. 1822/3 married Jonathan Harvey Smith b. 26 Jan 1821 d. 11 June 1850 age 29 buried Slabtown. Prudence E. Oliver Smith m. 2nd William Smith Pickens

NEW HOPE BAPTIST CHURCH HISTORY: Oconee Co., SC

Early records now lost were: the Church Book turned over to the Church 25 July 1835 by Henry Cobb and the Historical Account of the Church written by Martin Moss in June 1840.

The first recorded conference was 25 July 1835 but New Hope was organized before the nineteenth century began. The Head of Enoree in Greenville Co., SC was organized about 1789 then in 1827 changed its name to Reedy River. This church began keeping records in 1799 and states at the first conference: A report was made of the constitution of the Keowee and Little River brethern, named Shoal Church. This church was constituted with thirteen Charter members:

George Tubb, Solomon Raber, Jacob Waldon, William Taber, Genies William Taber, Mary Tubb, Susanah Taber, Sarah Tubb, Elizabeth Tubb, Mary Taber, Anne Reed, Lyda Shepperd, Anne Flor, Isaiah Stephens became a member in 1800 and later pastor.

In 1811 Eden Wimpey was a delegate, Morgan Morgan and Henry Head delegated in 1814 and Benjamin Laurence in 1815. In 1818 the name of Shoal Creek Church in Oconee Co was changed to NEW HOPE. In 1821 Robert Kell was delegate.

The first church stood near the Isaiah Hammond home place on the east side of Little River near Robinson shoals on the road leading from Old Pickens to the Jarrett bridge on Tugaloo River. James Morgan owned the land where the church stood.

Other members named: Rev. A.A. Cobb, John S. Cobb who was given a letter of dismission 12 Sept 1835, Henry Cobb and his wife Abigail were given letters of dismission 7 Nov 1835. George Head and wife Angelina letters of dis. 26 Nov 1836 because he was going to travel. Henry Head and wife Mary and daughter Sarah removed 24 Dec 1836. Eden Wimpey, Benjamin Laurence, Robert Kell and Benjamin Head all removed before 1835. Morgan Morgan was a messenger to the association in 1814. He died 14 Jan 1836. Thomas Morgan was messenger in 1825.

Joseph Brewer and Ezekiel Hunnicutt were ordained deacons in 1825.

Other names in church records:

R.M. Morgan, R. Hood, A. Jackson, John McAlister, John Bearden, R. Roberson, B. Garrett, William Hood, John Fringe, Robert Wilson, E.C. Hunnicutt, J.B. Crenshaw, Joseph Dawson and J.E. Hunnicutt, E.H. Kennemur was pastor from 1852-1854.

12 Sept 1835 there were 12 colored female members and 6 colored male Charlotte. Delilah, Jane, Vine, Hannah, Hannah, Jane, Mary, Patsy, Drilla, Milley, Binah--Mose, Adam, Glasgo who belonged to Joseph Gresham was baptized in 1835 with his master, Matt, Abram, George, Jack.

White members: Morgan Morgan, Jeremiah Hubbard, James Cannon, William Watkins, Joseph Brewer, Ezekiel Hunnicutt, Patrick Hubbard, Henry Cobb, James S. Horton, Hiram Wooten, Milton Reese Hunnicutt, Martin Moss, Joseph Gresham. Leland Clanahan, J.R. Hunnicutt, Benjamin Sego. Elizabeth Morgan, Mary Cannon, Ruby Swafford, Abigail Cobb, Sarah Clanaham, Elenor Hunnicutt, Jntheberry Hunnicutt, Belinda Ann Horton, Jane Smith, Aney Hunnicutt, Dicey Brewer. Susannah Massengill, Susannah Kelley, Mourning Barton, Elizabeth Brewer, Elizabeth Bullard, Rebecca Moss, Harriett N. Clanahan, Sarah Ann Clayton, Elizabeth O'Briant, Lydia House.

James R. Smith was choosen as pastor in Jan 1836.
Elijah Collins was given exhortation to use his gift 25 Mar 1837
John Garrett Turner and Stephen Smith were liscensed to preach in 1841
Brother Thomas Dawson was pastor in 1839
Lewis Fendley was elected to serve in 1841
Daniel Butler was pastor in 1857
John Owens began his second term as pastor in 1860.

Also listed: Brether Gresham submitted a statement of the Arm of the Church at Pickens Court House. He was informed on the 18 June 1834 Sister Lydia Hughey was received by letter: 1 Aug 1834 Colored Sister Sarah Curtis was received by letter: 21 June 1835 Colored Sister Jane, belonging to Major Keith, by letter: 19 July 1835 Colored Sister Mary belonging to Tarleton Lewis by experience: 16 Aug 1835 Frances Foster by letter, Sarah Ann Clayton and Elizabeth O'Briant by experience, Colored Jack belonging to S. Reid, Colored Hannah belonging to A. Craig, Colored Pricilla belonging to Bro. Gresham: 6 Sept Patsey belonging to Col. Morton, Hannah belonging to Mr Reid and Milley belonging to Bro Gresham were received. All by experience were baptized in Keowee River.

Very interesting Church History, much to large to name everyone listed.

OBITUARY--JAMES STUART SR: Killed on Tuesday morning 16th inst. by a waggon wheel, passing over his body, loaded with a heavy stock of timber, which he was carrying to a sawmill. He survived the accident only a few hours. He was upwards of 80 years of age and buried by the side of his father, who when he died had attained his 96th year and by his father-in-law who died at the advanced age of 116 years. Anderson Gazette Issue: 26 April 1844

OBITUARY--MRS JANE RICE: died at her residence near this village on the 26th inst. after an illness of three days, Mrs Jane Rice, relect of Mr Hezekiah Rice Jr deceased, in the 40th years of her age. A member of the Presbyterian Church. A little more than eleven years ago after becoming the mother of five interesting children she was bereft of a kind husband by the hand of death and had the care of a young and helpless family. Anderson Gazette Issue: 30 April 1847.

PENDLETON ISBEL--Pickens Co SC Probate Court Box 1 No. 7 South Carolina Pickens District Dated 25 May 1829--The condition that is the said Pendleton Isbel adminstrator of Pendleton Isbel Sr. farmer, dec'd to make a true and perfect inventory of all the goods credits etc. of said deceased. Sg: Pendleton Isbel Jr. Wit: Francis Burt, Silas Kirksey. to this State [it's unclear if he means North or South Carolina] when I was quite young. My father was old and infirm, and my mother was bedridden. I have had to take care of them and of several sisters, one of whom was a cripple and could not move without the aid of crutches. since I was a child. I am now twenty-three years of age and will be twenty-four on the 24th of next October--if I live. The revenue officers want to capture me for the sake of the rewards which have been offered for me--it is easier for them to make their money in that way than by working for it.

"My father owned a still all his life, as did all the farmers about here, before the revenue laws were passed; and I worked it for him. We were very coor and he could do very little. I worked on the farm all day and at the still at night to make a living for us. I have often worked all day ploughing and then run the still all night until breakfast. I would be so tired the next day that I have gone to sleep in the corn row between the plough-handles and wake up only when my horse stopped at the end of the furrow. This kind of life was too hard for me and soon proke me down, so that I got to working one night at the still and sleeping the next. I worked on the farm every day at the same time. They (the revenue officers) pressed he so close after awnile that I quit distilling and went to hauling whiskey and selling it in North Carolina. They found out that I was doing this and a warrant was issued for my arrest.

"The first trouble I had with the revenue officers was all on my side, as they captured and destroyed for me one hundred and twenty-three gallons of whiskey. I had paid one dollar per bushel for the corn that made it, besides eighteen dollars to a man who ran the still. The officers out up and emptied three barrels of the whiskey, and kept two barrels for their own drinking. They kept these two barrels had in the woods and would come back and get it by the jud full whenever their supply gave out. Among those

who got some of it were Chisohm and a fellow named Hampden. Several people have told me that they drank some of my whiskey that was captured at that time. An old man told me the other day that when they came for the last of it they arrested him and took him off and all the officers stopped on the side of the road and filled their jugs with the whiskey which they told him was Redmond's. They carried off twenty-three gallons at this load.

"The next morning. it was Sunday, the officers rushed into my house and presented their guns at my father and captured him. He was seventy-eight years of age and my mother, who was confined to her bed with palsy, was nearly as old. Father begged them not to alarm her, she was badly frightened, and he would surrender. They asked for me, but I was at the spring when they came up and saw them and so escaped. Father told them I was not far off but I kept out of the way and they took him down to the church near by. They captured several other men in the church and the preacher stopped in the midst of his sermon and sat down. My father and several others gave bail, the rest they took away with them. My mother was badly frightened by it all and died in a few days afterwards. My father had to go to Asheville. The journey and exposure made him ill and he died a few weeks later.

was then keeping out of the way as the revenue officers were watching for me every time I went to see either of them. I did not see my mother buried but when my father died too and my sister were left alone in the house. I determined to go home and attend his funeral and see after them at any risk. On the road from the house to the grave when we were following his body to burial we met a revenue officer. He looked at me very hard, but he was alone and seeing that I had some of my friends with me, he passed on and arrested several of the neighbors who had dug the grave and were

resting on the roadside.

"After the funeral I still kept out of the way and as my sisters were alone and helpless. I had to dodge in and out and try to take care of them as best I could. This was the beginning of my troubles."

Exactly when these early events took place is not explicitly stated, but was most likely in 1975. Neither is where. In October 1925 Mr J Lewis Bell of Brevard, NC answered an inquiry about Redmond from Mrs Caldwell, editor of the "One Minute Page" column of the CHARLOTTE OBSERVER. In the letter by Mr Bell he states that "Redmond was reared on the east fork of the Frend Broad river about ten miles from Brevard."

Mr C McKinley's interview with Resmond in June 1978 took place somewhere north of Pickens. a late right's ride into the mountains." From his discription of the journer to meet Redmond a good guess would be near Rocky Bottom. Anion makes it difficult to determine which state they were in at the time of the interview.

CIRCUMSTANCE OF DUCKWORTH'S DEATH

Redmond's next rin-in with the revenue officers was in the Fall of 1876 in Transivania County North Carolina.

Redmond's words. "When Deputy Marshal Lee was discharged from the revenue service he had in his accession a warrant against me, which he turned over to Frank Case. This warrant Alfred Duckworth, who had been recently appointed on the revenue force, tried to get from Case, who refused to let him have it. Duckworth then swore he 'would take me, warrant or no warrant, or would kill me in the attempt.' 'He had taken one highflyer,' he said, 'and by God he intented to take another.'

"Duckworth had been almost raised with me from childhood, and we knew each other well. He was very bigoted and was always bragging and doing rash things. He code one day by his own grandfather's house, where there was a

COMPUTER AND ON-LINE CLASS by Herman Geschwind

Last month we covered GEDCOM import, or how to add information from a GED file to a new or existing Family Origins Database. This step is simple and rather straightforward.

To export data from a Family Origins Database does have a number of options that need to be considered. When the EXPORT feature is invoked, the first screen has three sets of options:

The topmost panel deals with the type of GED to be created (1) General, (2) Ancestral File and (3) Temple Ready. The default is General which is just right for normal GEDCOM file exchange. The other two formats have to do with special requirements of the LDS Church.

The bottom panel has options to include notes associated with each record, sources, addresses, and to preserve word wrap for attached notes. The defaults are to include notes, include sources, ignore addresses and to preserve word wrapping. Again, the program defaults are right for most purposes. If notes should include some snide remarks about a maiden aunt that the rest of the world should not see, then it pays to uncheck the box marked "Export Notes".

The middle panel has some real interesting options as to which individuals should be exported. The default setting is "Entire Database", which is the easiest to handle. The other option is to "Select Individuals", which is a very powerful feature with which we deal later.

The GEDCOM File to Create menu has some powerful options which are not quite obvious. The normal choice for transmitting a GEDCOM file as an E-mail attachment is to specify a directory and file name on the hard disk, such as C:\AOL\upload\Smith. Family Origins will automatically add the correct file extension to the file name. Now, assuming that you want to mail diskettes with your database. Here the path will be: A:\Smith. The nice thing about the GEDCOM standard is that if the Database to be exported happens to be larger than what one diskette will hold, then the program will fill the first diskette to capacity and then prompt for a second diskette, etc., until the entire selection has been written to diskette. When you specify diskette output, just make sure that the diskettes have been formatted error-free and are properly labeled. Another consideration is that the output to diskette is not compressed, so that when the database contains several thousand records, quite a number of diskettes will be required [to put the 125,000 record OPD Database on diskettes would require 24 disks -ouch].

Quite often the intent is not to export the Entire Database put only specific family lines or individuals. Here is where Family Origins does provide some unique features. Invoke the option "Select People to Export". When this is checked, the Family Origins browse window comes up. Type in the name of the starting person such as SMITH, Joe and then double click on his name. The next choice is to mark either all the descendants or ancestors of the selected person. So, if you want to exchange the entire SMITH family line, find the oldest SMITH in the database and then select "His/Her Descendants". Normally with this option you should also check "Include Spouses of Individuals". Family Origins will ruminate for a while doing the marking and then invoking "OK" will get the file creation started.

The revers option would be to select a given SMITH and then mark "His/Her Ancestors", again including spouses.

Another feature of Export Selected Individuals which I believe is unique to Family Origins is that with the selection window up, you can click on any individual to have her/him included in the file. Back to our SMITH example. We want to export ALL the Smiths in our Database. Some are the descendants of SMITH, Zachariah but we have a number of others which may be descendants but are as yet unlinked. Here the steps are to select and mark Zachariah and all his descendants. The selection window will show all the SMITHs that have been automatically marked by a little "x" to the left of the name. Now we can go back and manually mark all the others SMITHS by highlighting and double clicking the unmarked names.

The ability to Select Individuals also comes in handy when you receive a GEDCOM that contains several family lines and you want to examine and even merge only specific groups of individuals. Assuming that you received a file that contains Mercks, Evans, Gaines and Smith and you want to work with the Smith line only. Here you can use the Export Selected Individuals to mark only the descendants of a given individual, then create a mini-GEDCOM which can be re-imported into your main database and then merged and linked. A handy and powerful feature which will save a lot of keystrokes and eliminate possible transcription error.

R. D. Edens (died in 1927) is believed to have been a Confederate soldier, but he has not been positively identified as such.

William J. Edens served in Co. B, 2nd SC Rifles (Moore's Regt.), and he died of battle wounds in VA; he was a son of William and Mary Edens of the Oolenoy section.

Charles H. Edge served as a _th cpl. in Co. H, 2nd SC Rifles (Moore's).

Benson Ellenburg served in Co. F, 22nd SC Regiment and resided in Hurricane Township of the eastern division of Pickens District.

Francis Marion Ellenburg (1836-1895)
was a son of Martin and Rebecca
Ellenburg; he served in Co. F,
22nd SC Infantry, Volunteers.

George Ellenburg served in Co. H, 2nd SC Rifles; Was this George W. Ellenburg who married Winny A. Bolding on May 12, 1860?

H. W. Ellenburg was born about 1847 and served in Co. K, 1st SC State Troops. (Is this the H. W. Ellenburg who was buried at Carmel Presbyterian Church in Pickens County?)

Joe Berry Ellenburg served in Co. H, 2nd SC Rifles; his wife was Minda Ellenburg (1843-1916), who was buried at Secona Baptist Church,



Robert Canady King (b. ca 1834 - d. 1862 Company E, 1st SC Rifles (Orr's Regt.) He died from wounds received Dec, 12, 1862, during the Battle of Fredericksbur

John Anderson Ellenburg (1842-1913) was a son of Martin and Rebecca Ellenburg; he served in Co. F, 22nd SC Regiment and resided in the Pumpkintown area.

Marcus Lafayette Ellenburg (1844-1921) was listed on the 1899 Civil War pension list in Pickens County.

Martin Ellenburg (1822?-1862) died during the Civil War; he left a widow CONTINUED ON NEXT PAGE

- and six children. In 1888 his 84year-old wife was the recipient of a Civil War widow's pension.
- Nathan Greene Ellenburg served in Co.

 A, 20th SC Volunteers; he died Oct.
 2, 1919. In 1923 his widow, Martha, was a recipient of a Civil War widow's pension. She died abt 1827.
- Edward Hardy Elliott enlisted in Co. E, th SC Volunteers at Fair Play, SC, on April 14, 1861; one source noted that he received a medical discharge from the Confederate Army, but he was listed in another source as killed at Spotsylvania, Virginia.
- Rifles (Orr's Regt.); he attended the 44th reunion of Orr's Rifles, which was held at Seneca in 1916.
- Gideon Ellis, Jr. (1824-1905) was a son of the Rev. Gideon Ellis (1786-1850) and Lucy Easley Ellis (1786-1855); his wife was Adline Mc-Whorter Ellis (1824-1905).
- Jesse H. Ellis (1817-1901) was a brother of Gideon Ellis, Jr. (see above); his name was included on the 1899 list of Civil War pensioners in Pickens County.
- John W. Ellis served in Co. E, 2nd SC Rifles (Moore's Regt.) and was wounded at Campbell's Station; he lost a limb as a result of wounds.
- Hugh A. Ellison (1829-1905) served in Co. H, 1st SC Field Artillery; his wife was Lucretia Young Ellison. He was buried at St. Paul Methodist Church south of Easley, SC.
- James Monroe Ellison was born abt 1838 and enlisted in Co. F, 2nd SC Cavalry under Capt. John Westfield; he was a brother of Archibald Henson Ellison, who also served in the Confederate Army during the Civil War.
- James Wilson Ellison, Jr. was a son of James Wilson Ellison, Sr. and Mary "Polly" Cox of Anderson County. He married Lucretia Ann Day, daughter of Hradwell Day (1806-1870).

- M. H. Ellison (1845-1892) served in Co. F, 2nd SC Cavalry and was buried in the Easley City Cemetery.
- Ellison (first name unknown); in 1899
 C. C. Ellison, a Confederate widow,
 was the recipient of a pension in
 Oconee County.
- Andrew Washington Elrod (1845-1928)
 served in Co. D, Palmetto Sharpshooters; he married Mary J.
 Quailes (1843-1904). They were
 buried at Friendship Baptist Church
 in Oconee County.
- E. L. Elrod served in Co. D, 4th SC

 Volunteers (Sloan's). Note: A
 Confederate soldier named Elrod
 (first name unknown) was killed
 or died of disease during the war;
 his widow re-married and her second
 husband was killed during the latter
 part of the war. She had a daughter
 named Annie Elrod, who married
 Joseph Findley, father of William
 Elbert Findley of Pickens, SC. Can
 anyone provide more information?)
- Elias Franklin "Frank" Elrod served in Co. D, 4th SC Volunteers (Sloan's). On May 10, 1922, he attended a memorial service for William Mauldin, another Confederate veteran, at Easley Methodist Church.
- S. P. H. Elwell was a one-armed Confederate veteran who once served as minister of Grace Methodist Ch. in Pickens. He lost his arm as a result of a battle wound. He has been described as "the true old fashioned Methodist type: a burning hell for the unsaved and a shouting congregation."
- J. A. Emerson served in Co. I, th SC Volunteers (Sloan's); he resided in the eastern division of Pickens Dist.
- Edward N. Emerson was born about 1832; he was a son of Robert Emerson and Mathurza Norton Emerson.
- Joe Emerson served in Co. E, 2nd SC Rifles. Is this Joseph Emerson who died following an accident at Mrs. Hunnicut's Mill in 1892?
