ESTATE of RUSSELL CANNON: Will of Russell Cannon, Clerk of Court Pickens Co., SC Pack 99

Whereas Russell Cannon of Pendleton District, SC being but poorly in health but of sound mind and memory, calling to mind the certany of death, and the uncertainty of life have appointed this my will and testament revoking and disannullin all other will or wills before me made this only to be my last Will and Testament, in manner form following: First I commit my soul to God who gave it, me and my body to be decently buried at the discretion of my Executors hereinafter named at funeral charging and all other wordly debts to be paid. I give and bequeath to my wife Jean Cannon negro Simeon for her own proper use to dispose of as she sees proper, and likewise Rose Willis and Kate during her natural life time, and at her decease, to be sold and equally divided amongst my lawfull heirs, and likewise for my wife Jean Cannon to have two head of horses, Ten head of Cattle her choice of my stock at my decease, and likewise all my stock of hogs, I shall posess at the time of my decease and likewise all my personal property that I have not previously disposed of to my children VIZ: I give and bequeth to my daughter Harriett Duke negro Ann to her and theirs of her body forever. All my other property either real or personal not disposed of at my decease to be sold and equally divided amongst my children. I appoint my wife Jean Cannon and my son Elijah to act and see the accomplishment of this my last Will and Testament according to the true intent and meaning thereof. Dated 10 July 1824 Sg: Russell Cannon X wit: James Hunter, James E. Hart,

Proven in Anderson District, SC I Herbert Hammond, Ordinary of Anderson District hereby certify that the above and foregoing is a true copy of the last Will and Testament of Russell Cannon on file in my office and recorded in Will Book A page 296 and admitted to probate on oath of James E. Hart on 6 Sept 1824 before John Harris, Esq Ordinary and on same day qualified Elijah Cannon as Executor. Dated 15 June 1855. Pickens Co, SC Equity Pack 99

State of South Carolina, Pendleton District: Know al! men by these presents that I Russell Cannon of said state and district do hereby give unto my son Ransom Cannon a tract of land to be his own right and property at mine and his mothers death. lying on the south side of Wolf Creek the waters of Twelve Mile River adj. Waggon Road, long Branch Bridge, Bensons line, containing ten acres. Dated 7 July 1824 Sg: Russell Cannon X. Wit: Sheriff Haines X, James E. Heard. Proven 28 Jan 1826 in Pendleton District. SC Rec. 30 March 1827.

Anderson District, SC by Elijah Webb, Clerk of Court of Common Pleas and Register of Mesnes Conveyance and by law keeper of the Records of Pendleton District recorded in Bk S pg 89 dated 25 June 1857. Equity, Pickens Co., SC Pack 99

Abraham Duke and his wife Harriet Duke and Ranson Duke sheweth that Russell Cannon dec'd who at the time of his death was of that portion of Pendleton District which has since been laid off and established as Pickens District,

who being the father of the said Harriet Duke was in his life time and at the time of his death owned a certain piece of land containing 300 acres lying on both sides of Wolf Creek and now adjoining lands of William Gilstrap, Mary Haynes, Reese Bowen, G.W. Davenport and others. Russell Cannon died about the year 1824 leaving a will. His wife Jean Cannon has recently departed this life. His son Elijah Cannon left this State many years since. His heirs were his wife Jean Cannon and children: Harriet wife of Abraham Duke, Ranson Cannon, Elijah Cannon, Martha Cannon who afterwards married William Brown, William Cannon, Carter Cannon, James Cannon, Margaret Marchbanks wife of Cyrus Marchbanks and Judy or Judith Kendricks. Since Russell Cannons death, Ransom Cannon has departed this life leaving no children but leaving a wife Malinda who has since intermarried with Joseph Dolleson. William Cannon is also dead leaving children: Benjamin Cannon and Washington Cannon and perhaps one or more others whose names are unknown. Cyrus Marchbanks the husband of Margaret Marshbanks has also died. That \_\_\_\_Kendricks husband of Judy or Judith Kendrick is also dead. Jean Cannon the widow of Russell Cannon is also dead. Russell Cannon bequeathed to Jean his wife, 3 negroes to wit: Rose, Willis, and Kate for and during the term of her natural life and at her death to be sold and divided among her children. Elijah Cannon about the year 1844 did wrongfully sell one of the said negroes a boy named Willis for \$525.00. Joseph Dolleson and his wife Malinda reside in Georgia, Benjamin Cannon, Washington Cannon and the other heirs of William Cannon dec'd reside in Mississippi, Carter Cannon resided in Texas, Margaret Marshbanks resides in Texas, James Cannon resides in Mississippi, Elijah Cannon and Martha Brown reside in Texas, Judy or Judith Kendrick resides without the limits of this State in parts unknown. Dated 17 March 1857. Equity, Clerk of Court, Pickens Co., SC Pk 99

Gideon Roper swore: I live near Mrs Dukes, Andy a negro boy was four or five years old when he went there, which was near 8 years ago. It was worth \$40.00 a year to provide for and maintain him. I knew Kate her condition was bad, one fourth of her time she was helpless. She was taken care of and fed which was worth \$40.00 also a year. Hannah was hired part of the time. She stayed at Mrs Dukes one year. During this time she was sick for 3 months. It was worth \$2.00 a week to take care of her. Mrs Jane Cannon was at Mrs Dukes for 8 years, her condition was very bad. She was old and as helpless as a child most of the time. It was worth \$400.00 a year to take care of her. Mrs Cannon was at Elijah Cannons before she went to Mrs Dukes. Her condition at first was not so bad as afterwards. Kate the negro woman was only sick at times. The boy Andy was worth his borad for the three or four last years. Kate when well would have hired for \$4.00 permonth. Hannah was sick about 3 months in the year. She was when fully grown worth \$40.00 a year. Mrs Cannon died 8 March 1855. Equity, Pickens Co., SC Pack 99

Elijah Cannon to Reese Bowen: I Elijah Cannon of Grayson County State of Texas have appointed Reese Bowen, Esq in the District of Pickens State of South Carolina my lawful attorney to ask and recover my portion or share in the Estate of Russell Cannon dec'd of Pickens District, SC. The said Russell Cannon was my father and I am entitled to a distributive share of said Estate. My attorney is authorized to sell or dispose as he may see fit. Dated 23 Dec 1858 Sg: Elijah Cannon Wit: S. Bostick, James Galloway. Proven by James H. Smith an acting Justice of the Peace of Grayson Co, TX 23 Dec 1858.

OBITUARY--MRS SARAH J. BRANYAN: died at the residence of William Jolly, in Pickens District, on the 2nd ult, Mrs Sarah J. Branyan, consort of the late Thomas Branyan, of Abbeville District aged 63 years. She had gone to visit her daughter, Mrs Jolly and while there experienced an attack of billious fever. Departed this life on the 29 March 1856 at her residence in Anderson, SC, Martha Smith, aged 80 years or upwards. JONES: The Methodist brethren especially and many others among our readers will regret to learn of the death of Rev. S.B. Jones DD, which took place in Spartanburg last Saturday morning. Many years ago he resided in this community and taught in the old Presbyterian Seminary under the presidency of the late Ebenezer Pressely DD, and at the time taught a private school for boys during the half day in the grove which then stood where Mr W, A. Watson now lives at which this writer was a pupil. His first wife was a daughter of Bishop Capers who then lived where Mr E.A. What appears to be the final auditing of Henry Smith's estate, by Abraham and John Smith adm. York Co SC Minute Bk B--7 Feb 1792.

Henry Smith lived in Mecklenburg Co NC in 1767 after he moved from Augusta Co VA after 1764.

27 Sept 1764 Henry Smith, farmer and Amelia to Adam Stephen of Frederick Co 170 acres conveyed to Henry by Silas Hart 1 June 1756 on South Fork of North River of Shanandoe Augusta Co VA.

Issue of Henry and Amy/Emi Smith of York Co SC

A. ABRAHAM SMITH Baptised 2 Oct 1748 according to Baptismals as done by Rev John Craig of the Old Stone Church later called the Augusta Presbyterian Church d. 31 May 1808 Union Co SC (m. Mary "Molley" Guyton) d/o Joseph and Hannah Whitaker Guyton

Will of Abraham Smith of Union District SC 31 May 1806 prov 14 June 1806--Being in a low state of health and weak of body etc. To my son John Smith two hundred acres of land joining Clanton land being part of the tract where he now liveth and what money he oweth me. To my daughter Polly Humphries I will and bequeath one hundred acres of land it being the place whereon she now liveth also negro. To daughter Hannah Alexander negro she received of me named Winneg. To my grand child Polly Alexander a negro girl. To my grand child Abraham Alexander my young mare or filly. To my son Henry Smith the old survey whereon he now liveth in York District at the Ford one hundred acres also the land adj. to him formely granted to Bridges including the place granted to his grand father wheron Joseph Luck (Lusk) lived--negroes To my son Joseph Smith the remainder of that tract of land upon Thickety Creek formely called Stocketits land adj. below his brother John--negro. To my son Daniel Smith a part of the land whereon or adj. to that I live on beginning upon Youngs line, east side of the Creek, where Murpheys School house stood--upper Kelleys old field--Morgans land--negro. To daughter Sally Smith negroes-bed-funiture and a proportionable to what her married sister has already received. To my well beloved wife Molly Smith the remainder of my land whereon I now live for her natural rite during her life or widowhood, negros--to raise and educate my two youngest children. To son Moses Smith the remainder of my land whereon I now live at his mothers death or marriage--negroes when he of full age. executors to sell the remainder of my land and wife divided among my children as she thinks best and the Merchantable product ready made to be equally divided amongst my unnammed children. Exors: wife Molley Smith and son Joseph Smith. Sg: Abraham Smith X. Wit: Nicholas Corry--Henry Good--Spencer Morgan. Union Co SC Wills Vol 1 Bk A pg 210-211

1 March 1809 Exors (Mary and Joseph Smith) of Abram Smith vs adm. of John Martin and others. Case deals with Abram Smith buying land—the said Abram Smith was an illeterate man and not skilled in the law and as such did not know the difference between a Joint and Several Bond. Western Circuit Equity Journal, SC pg 18 (May be different Abram Smith)

### GENEALOGY BIRDS

THE FROUD CRESTED SAP SEEKER: This bird is determined to trace his linage back to some famous historical figure, in spite of an overwhelming lack of evidence. He consistently claims descent from Geo. Washington or Queen Elizabeth I, in spite of the fact that both of them died without issue. His nest is built of old rusted coats of arms that he picks up wherever he finds them, claiming them for his own. It is drafty and full of holes.

THE GIMLET-EYED NAME COLLECTOR (commonly known as the copycat bird): An ambitious fellow, he is most often found in libraries, reading and copying every bit of information having to do with the names of his lines. He accepts and records as truth everything he finds. He does not bother to verify the information. He is concerned with quantity, not quality. His nest is loosely constructed of old pedigree charts and family group sheets, held together by one or two slender threads of evidence. It is always destroyed by the gentlest breeze of truth, leaving the bird homeless.

THE HAND-WRINGING WAILER: His song is familiar to everyone-I can't, I can't, I can't. He is a very sad bird and tiresome to those who have to listen to him. He is aware of his responsibilities but is unwilling to do anything about it. His conscience bothers him. His first few attempts were unsuccessful, so he made up his mind that tracing ancestors is an impossible task. This bird does not build a nest. He flies around looking forlorn and unhappy, hoping some other bird will build it for him.

THE ADDLEPATED ROADRUNNER: This bird wants to do everything by himself, and tries to go all directions at once. He is aware that others might be doing the same work but he cannot be bothered to pause to see what has already been done He runs madly hither and yon, working on all lines at once, often missing important information because of his speed. When he compiles a reasonably goodsize family record and submits it to the archives, he generally finds most of the work has already been done by someone else. He thinks he is too busy to build a nest and is so intent upon his task that he never rests. This species is short lived, usually succombing from exhaustion.

THE BUCK-PASSING STALLER: Probably the most common of birds, he is seen and heard everywhere. He is a brother to the Hand Wringing Wailer-it is hard to distinguish between their songs. If one listens closely, however, it becomes easy to hear this bird singing, "I don't have time. And anyway, Cousin Gertrude is doing it. "He tries to make up for his lack of interest by keeping busy in other ways. But no matter how many other things he does, he can't quite excuse himself. So like his close relative, he bores the other birds with his constant excuses. His nest is of generally good construction, but it lacks architectural quality because he has not used all the materials necessary for an eternal dwelling.

THE RECORD-CLUTCHING TIGHTWAD: This bird is unique among genealogy birds. He has spent a lifetime and many dollars collecting a vast amount of genealogy. He has in his possession priceless records. But this unfortunate bird is busy guaring his records so that he can never fly to the heights. He is a very lonely tird. He does not have a song, but instead a strident, raucous call: "This is mine you can get your own! "His nest is an impregnable fortress. Ornithologists fear that this bird is heading for self-destruction, because he will not come out of his nest, nor let others in.

THE HARD-HEADED FACT FINDER: This bird is a cautious, slow-moving creature. His rarely heard song is a soft, melodious, "Study, search & pray. "He sings only when he has something to sing about, yet he is a gregarious fellow. He is often found among flocks of other birds but is hard to identify because he looks so much like the rest of them. This bird must see for himself & never goes on assumption or hearsay. He is happy to share what he has with all who are interested. His nest is large & strongly built to withstand the worst tempest. Bird watchers are delighted to notice an increase in his numbers, for he is, without doubt, the From: Relatively Speaking-Alberta, Can. Gen. best of all the genealogy birds. Society-Mrs Emily Smith.

William Hendrick Holcombe (1847-1887)

Captain, 1st South Carolina Rifles (Orr's Regiment) Confederate States Army Warren Franklin Fitzgerald was born ca 1835, and he served in Co. F, 1st SC Riflea (Orr's). He died of disease at Richmond, VA. He was a bro. of Thomas William Fitzgerald, who also served in the Confederate Army.

Abram Fletcher came to Walhalla from England to work on the construction of the Blue Ridge Railroad. He was a Confederate soldier during the war, having served in Co. C, 2nd SC Rifles (Moore's Regiment).

Fitzgerald (first name unknown)

Elizabeth Fitzgerald, widow of a Confederate veteran, was the recipient of a Civil War pension in 1902.

H. D. (or H. T.) Floyd was listed on 1899 and 1902 pension rosters of Oconee County, SC.

James A. Floyd (1830-1903) served in Co. E, 2nd SC Rifles (Moore's Regiment); he was wounded at Wills Valley, Tenn.

Andrew Wilson Ford was born in 1841.

He was a son of William Harrison Ford (1818-1877) and Mary Martin Ford, and he died during the Civil War, having served in Co. K, 4th SC Volunteers.

William Walker Ford (1847-1932) was a brother of Andrew Wilson Ford (see above). In 1922 he was the recipient of a Civil War pension. At that time, he resided in Easley, SC.

J. E. Forrest enlisted in Co. B, 37th
Virginia Cavalry on Jan. 1, 1863, at
Pickens Court House on the Keowee.

Wade Forrester served in Co. F, 22nd SC Regiment.

William Hendrick Holcombe was a son of R. E. Holcombe, founder of Easley.

- Tandy Fortner served in Ferguson's Artillery and died during the war.
- Tracie (or Tracy) Fortner was a member of Co. H, 2nd SC Rifles; he was killed at Richmond, Virginia.
- William A. Fortner (1839-1921) was the husband of Sarah McJunkin Fortner (1846-1920), and he served in Co. H, 2nd SC Rifles. He and his wife were buried at Pleasant Grove Baptist Church in Pickens Co.
- <u>William T. Fortner</u> (Could this man be the same as the above soldier?)
- Zion W. Fortner (1844-1909) served in Ferguson's Artillery, and he survived the war. He was married twice; one wife was Laura (?) and the second wife was Malinda (?). He was buried at Cedar Rock Baptist Church in Pickens County, S. C.
- Fortner (first name unknown); in 1888
  Arminda (or Malinda) Fortner was
  the recipient of a Civil War
  widow's pension. She resided in
  the Table Rock Community.
- Holbert Fortune served in Co. H, 2nd SC Rifles, C.S.A.
- Columbus Lafayette Foster (1848-1929)
  served in Co. D, 2nd SC Rifles; he
  was a son of Robert Foster, Jr.
  and Alzara Foster. He was buried
  in Westminster East View Cemetery.
- Edward Foster served in Co. D, 22nd SC Volunteers. He resided in Oconee County in 1915, but his name was not on the Civil War pension roll at that time.
- Joe E. Foster (1846-1940) resided on a farm in the Peter's Creek area of eastern Pickens District. He was a member of Co. B, 37th Battalion Virginia Cavalry and was wounded at Liberty Mills. After the war, he became a well-known minister of the gospel and conducted numerous weddings and funerals.
- John Foster received a Civil War pension in 1899 in Oconee County.

- P. A. Foster was sent to the front in Virginia in 1861; he resided in the Three and Twenty Community of Pickens District, S: C.
- R. B. A. Foster (1846-1937) served in Co. D, 1st SC State Troops and was discharged at Spartanburg, SC, on April 9, 1865. In 1902, he was the recipient of a Civil War pension. At that time, he resided in the Marietta/Dacusville area.
- James Fountain was born about 1843, a son of Simpson L. Fountain (b. ca 1812). He died at Richmond, VA, while serving in Co. F, 1st SC Rifles (Orr's). His wife was Mary Abbott Fountain.
- Coleman Carlyle Fowler was born ca 1820, a son of Coleman Fowler (b. ca 1774). He served in Co. C, 2nd SC Rifles (Moore's) and died of disease at Richmond, Virginia.
- David S. Fowler served in Co. K, 12th SC Infantry; he survived the war.
- George W. Fowler (1846-1914) served in Co. F, 4th SC Volunteers; his wife was Mary C. Fowler (1852-1904). They were buried in Neville Cemetery (Oconee County, S. C.).
- L. D. Fowler was killed in battle at Malvern Hill in Virginia while carrying his regiment's colors. He was a member of Co. C, 2nd SC Rifles (Moore's).
- John Fox (1836-1916) served in Co. C, 5th Tennessee Cavalry; he was buried at Fairview Methodist Ch. in Oconee County, Couth Carolina.
- William Frady was one of the two men with the same name who served in the Confederate Army from Pickens Dist. This one was a member of Co. C, 4th SC Cavalry; he survived the Civil War.
- William Frady, the second man with this same name, was killed at Gettysburg, PA. He served in Co. G, 12th SC Infantry, in which he was a private.

591 Gray Road Canton, GA 30114 could and Amos Ladd said, 'I surrender.' I said nothing and turned over to get my pistol from under my pillow and saw that Hendricks had run around behind me and had my pistol within a few inches of my head. Several of them jumped upon me at once and held me down and pinned my arms and then they turned me over on my back and Barton and Gary tied my wrists close together. It was all done in a moment but when they jumped on me I thought to myself, 'if there were only two of you, how quick I could turn you under.' If I had done so, however, they would have riddled me with buckshot and balls so I thought I would wait.

"When they were tying me they used a small strong rope and they pulled mighty hard on it. I had a 'rising' on one wrist and they hurt me pretty badly; they broke the rising and cured it. 'Here is the rent now.' he said, laughing. But if they had torn my arm off I wouldn't have said a word.

When I was tied, Barton asked me if I was Major Redmond? I said yes! He said, 'Yes, G-d d--n you, you are theman who wanted to kill me.' I replied, 'I have not wanted to kill you; I could easily have done so if I had wanted.'

"He ordered me to get up, but pulled so hard on the end of the rope he had me tied with that I couldn't get up. It is no easy thing to rise when you are on you back with your hands tied. I tried to do so, but couldn't get up quick enought to please him and then he kicked at me, his boot grazing my side! If he had kicked me squarely he would have hurt me. Though I don't think he could have hurt me much, that night, whatever he did, but that was enough. I felt like I ws as strong as three men, and sprang up I don't know how.

"I kept quiet, however, and they held me and Barton ran his hand into my pocket and took out my pocketbook. I had one hundred and eighty-six dollars. He asked me if it was mine. I said. 'Yes, put it back in my pocket. You have not right to take my money.' He said, 'You have no right to

it,' and kept it. I then said, 'Look here. I want my boots.'

"Barton dropped the end of the rope he had been holding and started past me to get the boots which were lying by my pallet. I was mad because he had kicked me and felt as tall as if I were three feet above the floor. I turned my hands in the rope and 'whopped' my arms into Gary's breast and knocked him down. I knocked Moore down in the same way on the other side; the others were all standing two deep between me and the door. I kicked at Charley White, who gave way; the rest scattered, and I jumped out of the door like I had been greased.

"My wagon was in front of the door, fortunately; so I ran around it, gathering up as I ran the rope with which I was tied to keep it from tripping me. I knew they would catch me if I fell. They dashed out after me. Bang, bang went their guns. The balls struck all around me and knocked up the snow. I heard one of them say, 'By G-d, I know we have killed him!' but I knew they hadn't and kept on. I was still tied so tight I couldn't get loose, though I kept tugging at the rope as I ran. I had one pistol in my pocket and twisted my hands around and got it out, but dropped it in jumping a big chestnut log.

"There was a fence in the way but I went over it without any trouble. I think I flew over, I got over it so easily. The officers turned back; they were afraid to follow me very far. And then I stopped and untied the rope with my teth and knew I was safe.

"The snow was thick on the ground and I was without hat or coat and in my stocking feet. I knew they had my pistols, but as they had Amos, too. I determined to rescue him or die. I thought they wouldn't stay long about there after I was loose so I ran across the field in my stocking feet to a neighbor's house. I won't tell his name but when I got there the soles of my stocking were cut to pieces by

the ice and the legs were clinging around my ankles.

"I knocked and he let me in, and I told him those 'hell fired devils' had captured me and my driver and I intended to take him away from them. ### Old Pendleton Database Project by: Herman Geschwind

Here is good news for members with Internet accounts [CompuServe, Prodigy, or other Internet Service Providers]: A **GEDCOM** file of the Old Pendleton Database is now available for download at the following address:

Depending on your connect speed and network congestion, the FTP [Internet File Transfer Protocol] download should take around 30 minutes. If the network is congested and FTP indicates that the download will take longer than 30 minutes, cancel and try again at a different time.

The file is compressed as a standard ZIP file and requires PKUNZIP.EXE or a similar unZipper. If you do not have PKUNZIP search the Internet for a shareware copy and instructions on how to use PKUNZIP.

System requirements: The Old Pendleton Database by now is a big file. The compressed FEB07.ZIP is slightly larger than 5 megabytes. 30 megabytes of free hard disk space will be required to Unzip or extract the GEDCOM from the compressed file. To import all of it into Family Origins or a similar GEDCOM compatible program requires an additional 70 to 90 megabytes of free hard disk space. [Once the GEDCOM import succeeds, the ZIP file and the GEDCOM can be deleted - but ample free disk space is a must]. A Pentium class system will be a big help but even with that, the GEDCOM import into a genealogy program can take anywhere from as little as one hour to as long as several hours, so be patient, there is a lot of information to be processed. Note: All this applies to PC compatible computers only, we cannot assure that this service will work for MacIntosh users.

As we receive additions and updates to the Database Project, new versions will be posted to the above WEB site on a monthly basis, usually around the 10th of a month.

Members who are subscribers to America On Line [AOL] will continue to receive their monthly updates as a file attachment to an Email message. If you are an AOL subscriber and would prefer to receive a copy via AOL, please post a message to my attention at: Geschwind@aol.com, and you will be added to the distribution list.

As of February 1998, the Old Pendleton Database now contains information on 150,000 individuals and 51,000 families with roots in the Old Pendleton area, principally Pickens County, but Oconee, Greenville and Anderson Counties are also covered to some extent.

To recap what the Database is and is not, here is a brief summary: For individuals the Database will show names and dates and places where born, married and died and buried. There will be links to spouses, children, parents and siblings. Many family lines are reasonably complete and will cover many generations and decades. To conserve space, we cannot include source citations and lengthy text files.

The data for the file came from member contributions and many other sources. While we do our best to assure program consistency and integrity, we cannot verify the information submitted to us by others. For that reason the Database should be viewed as a research tool and ready reference and as a guide to further research and genealogical proof.

This is very much of an ungoing project and as new information becomes available, not only will individual and family records be added, but information contained in existing records may change. So, as new versions are posted, the old version should be deleted and the new one used for reference.
