William HOLLIDAY Sr. married 2nd Sarah COTHRAN/COCKRUM, sister of John and James COCKRUM/COTHRAN of Greenville District, SC.

In 1850 census William and Anne HOLLIDAY resided in Eastern Anderson District, SC. Their neighbors were know relatives of Anne and relatives (COOLEY'S) and friends from Greenville District, SC.

LUSK: The LUSK family name originated in the Ukraine, Russia and migrated to Scotland, Ireland and eventually to America.

There is a town of Lusk in Ireland about twenty miles north of Dublin.

Nathan Lusk b. 1685 Scotland d. 14 Sept 1748 Augusta Co VA emigrated to Virginia were he lived in Rockbridge, VA now Augusta Co. He m. Elizabeth.

James received three royal land grants recorded in SC at the Archives dated 27 April 1765, 6 Aug 1765.

Will of James Lusk 3 Jan 1786 Prob. 5 Nov 1804

I James Losk of Abiville Co District of Ninety-Six SC, Freeholder, being very sick and weak in body etc. I give to Eleanor Loosk my dearly beloved wife one horse saddle and bridle, one bed and furniture and all singular wearing apperrel, one flax wheel and wood shed and chack reel one half of this hundred and fifty acres of land which contains my improvement one half of my household furniture and one half of all my plantation expreminence also to my beloved son Robert one half of the remainder of this plantation epreminence and house furniture and the remainder of this land and of household furniture and the plantation eprimimence to be equally divided between my two daughters Elizabeth Gray and Elenor Baty and all the horses and neet cattle sheep and hogs belonging to my plantation to be equally divided between my wife Eleanor and my son Robert and my two daughters Elizabeth Gray and Elenor Baty in the same manner as above and to my beloved son Nathan Losk fifty acres of land joining lines with me and William Alexander on Long Cane and to my beloved son Henry Losk one hundred and fifty acres of land on the head of Armstrongs Creek and to William Losk my grandson one plantation of land containing two hundred acres bounded plantation and William Alexanders and Mathew Youngs and Hugh Bessleys and two hundred acres -to be put through the office by my invent and then to be???? Exors: sons Nathan Losk, Henry Losk and William Baty and friend Samuel Foster Sr. Sg. Jas Losk wit: William Foster, Nat Weed Jr, John McCiddy X. Recc. Will Bk 1 pg 299 Abbeville Co SC.

Nathan was among a number of other families who gathered in 1805 to organize Bethel Presby Church in the Picket Post Community off Hwy 11 near Walhalla in Oconee Co SC. His name is listed on a monument in front of the church. He also served in Orr's Reg. in Civil War.

Nathan's Family Bible gives births and death dates. The Bible was in the possession of Clara Lusk Grant Rt 1 Box 254 Salem SC 29676 in 1983

GAMBRELL: A letter written 4 July 1927 from H.D. Ward of Houston Texas states: Two Grambrell Brothers came from France about 1676 (but first took refuge in Ireland and from Ireland to America) went up the Potomic and settled in Virginia and Maryland, later they had a misunderstanding and broke friendship. John Grambrell of Anderson Co SC was a grandson of one of these two brothers (from J.B. Gambrell who was the grandson of David Grambrell and his parents moved from Anderson Co SC to to Tippah Co MISS in 1842). The old Grambrell Graveyard is near Manassa and Williamsburg VA.

From H.D. Ward taken from material that she has been writing down for over 40 years told to her by her father and grandfather: John Grambell a grandson of one of these brothers settled in Anderson Co SC some time before the Rev. War. He married Barbary Bruton a descendant of a French family. To John and Barbary was born 5 sons: Henry, David, James, John and Matthew, one of these 5 brothers was a one-legged old batchelor because he lost his leg in the War of 1812, his wound was a constant irritant to his temper so he drank to excess. You can see that John Grambrell Rev. Soldier was the grandfather of my father and Uncle Madison. He was also great-grandfather of J.B. Gambrell. My grandfather was Matthew Gambrell (son of John) he was a Baptist preacher and died a suicide on 12 Aug 1843 he married Lettice Madison d/o James Madison. Matthew Gambrell lived on his fathers home place. My father and uncle Madison are the only sons of Matthew Gambrell to survive the Civil War. My father left Painesville AL and moved to TX in 1857.I believe that Daniel Gambrell was the grand-father of John Gambrell

NOTE: by Linda Cheek--I believe that John Gambrell married Barbary Vaughn and that her (Barbary Vaughn's) mother was Barbary Bruton\Brewton m. William Vaughn. Sure would like to have this proof.

John Gambrell d. Sept 1834 Anderson District SC m. Barbary Bruton (Vaughn) a descendant of a French family early settlers in VA for whom the Bruton Memorial Chapel at Williamsburg is named. John Gambrell was in the Rev with Marion, he was a Scout because he had a stiff arm and could not fight.

John Gambrell left will at Anderson Co SC dated 10 May (March) 1830 proven 27 Sept 1834 naming: Wife Barbara Gambrell children: William Gambrell, Henry Gambrell and wife Susannah, John Gambrell, James Gambrell, David Gambrell, Matthew Gambrell, Elizabeth Cox, Nancy Breazeal (Enoch). My other children. Exors: John Gambrell and Matthew Gambrell sons. Sg. John Gambrell X. Wit: Sam I. Hammond, Elijah Griffin, Barbara Casey. Anderson Co SC Will Bk A pg 500-501 microfilm roll 228 pg 425-426 Gambrell burying ground near Dorchester Church in Belton SC.

William Vaughn, planter, of Craven Co Province of SC and wife Barbary to John Stone 200 acres on North side of Beaverdam Creek of Enoree River part of 400 acres granted 16 Jan 1772. Dated 10 Dec 1775. Laurens Co SC Deed Bk C pg 159

Will of Elizabeth Cox--Anderson District SC 14 April 1848 prov and rec. 4 Feb 1856. I Elizabeth Cox of Anderson District State of South Carolina being desirous to dispose of what wordly goods it hath pleased God to bless me with: Viz--

1st I will that all of the property which I posses of every kind be sold by my son William Cox whom I appoint as my executor to execute this my last will and testament--upon such terms and at such time as he may think most to the interest of my heirs and then devide the same after he is paid for his services among each of my children (he being one) equally--viz:

2nd. The heirs of John Cox dec'd an equal share, Thomas Cox and equal share, Polly Ellison and equal share Elizabeth Davis an equal share William Cox an equal share and Barbary Harper to have the interest of an equal share and at her death each of her children to have the share of their mother equally divided among them share and share alike--

3rd. My will is that John Harper and William L. Harper sons of my daughter Barbary Harper receive from my executor the share whereas I desire my daughter to have the use of and for them to keep it at interest as long as she may live and each and every year she is to have the Interest for her use and benefit so that she may enjoy the proceeds of it for her comfort and at the death of Barbary Harper (my daughter) my will is that each of her children receive an equal portion of that amount devided to them by my trustees John and William C. Harper--

4th. Diaries of Ida Virginia Bradley 1879-1889

The diaries of Ida Virginia Bradley, written between 1879-1889, begin with a description of an eighteen-year-old girl's solitary journey from her impoverished home in Cartersville, Georgia to Pickens, South Carolina, to live in the home of her more affluent uncle, David Franklin Bradley. Uncle Frank and Aunt Mary, who have no children of their own, treat her as a beloved daughter—companion. Ida is expected to assist with the housekeeping chores, sewing and other types of handiwork, and entertaining guests. Infrequently, she also performs secretarial duties in the printing office of the Pickens Sentinel, which Uncle Frank founded and continues to edit. A nephew, Milt, who lives with the Bradleys and is treated as a son, works in the printing and newspaper office.

Uncle Frank, a Civil War veteran and South Carolina senator, periodically goes to Columbia to "pass a bill," such as that of prohibition mentioned in Ida's January 24, 1880 entry. She refers in the January 30 and subsequent entires to his efforts to bring the railroad to Pickens.

Ida's Cartersville intervals reflect a great deal more home chores and responsibilities. Her family (Civil War veteran father, mother, nine children, and maternal grandmother at times) are close-knit and devoted, but ever struggling to survive financially.

The last entry in Ida Virginia Bradley's diaries was made in July, 1889. Two years later, when she was thirty years old, she married Aunt Mary's nephew, Charles Hovey Clyde of Easley, South Carolina.

Edwin D. Gaines (1844-1862)
served in Co. E, 2nd S. C.
Rifles (Moore's Regt.) and
died during the Civil War.

Elisha Pendleton Gaines (18231907) was a son of Richard
George Gaines (b. ca 1760 d. 30 Jan 1832) and Mary
Dunlap Gaines (17 Mar 1779
9 May 1851). He married
Susann Garvin on 18 Feb
1844, and went to Texas,
where he lived near Campbell (Hunt County) before
and after the Civil War.

James Gaines served in Co. B. 2nd S. C. Rifles (Moore's) and died in Tennessee during the Civil War.

James Henry "Jim" Gaines (1848-1935) served in Company D, lst S. C. Regt. (State Troops?). He was an early mayor of Central, S. C., and was an outstanding blacksmith of that town after the Civil War.

John Gaines died of typhoid fever in 1862; served in Co. A, 1st S. C. Rifles (Orr's).



Marshall Benjamin Gaines (1844-1928) was a member of Co. E, 29th S. C. Volunteers and also served in Co. D, 19th S. C. Cavalry. After the Civil War, he resided in the Seneca area of Oconee Co. His first wife was Loutitia Isabell Mattison; his second wife was Eliza Gantt (1867-1931).

- William B. Gaines (1832-1906) was a son of Reuben Gaines (b. ca 1794) and the husband of Lucy Hammond Gaines (1837-1887). He resided in the Central, S. C., area of eastern Pickens Dist. (Pickens Co.) after the war.
- William P. Gaines (b. 20 July 1843)
 was captured by Union troops
 during the war and sent to
 Hart Island, N. Y. He moved to
 Mississippi after the war.
- Manassa Galbreath, a Civil War soldier, was buried at Wolf Stake Baptist Ch. in Oconee Co.
- James M. Galloway (1822-1887) was a resident of Eastatoee Twp. in the eastern division of Pickens District, S. C. In 1922, his widow Elizabeth M. Galloway was receiving a pension, and she resided at Cateechee, S. C.
- Mathison M. Galloway joined Co. E, lst S. C. Rifles (Orr's Regt.) when he was eighteen years old. He was killed at Cold Harbor, Virginia, during the Civil War.
- James Madden Gambrell was a tanner who lived in the Pickensville area of Pickens District, and he died about 1876.
- John Pegg Gambrell (1847-1932) resided in the Madison area of Oconee County in 1930 and received an annual Civil War pension of \$240.00. His wife was Mary Dorothy "Mollie" Hughes Gambrell (1849-1891).
- Newton J. Gambrell (1843-1921) was a member of Co. B, 16th S. C. Volunteers. His wife was Julia M. Gambrell (1844-1934). In 1915 this Confederate veteran resided in Oconee County and received a Civil War pension.
- David Ganett served as a private in Company B, 2nd S. C. Rifles; he survived the war and was living in May 1898.

- Thomas Ganett (or Garrett) served in Company B, 2nd S. C. Rifles (Moore's Regt.)
- William Ganett (or Garrett) served in Co. B, 2nd S. C. Rifles and was discharged from that unit during the war.
- Benjamin F. Gantt (1838-1899) served as a first sergeant in Co. K, 2nd S. C. Rifles and was wounded at Fort Harrison. After the war, he was postmaster of Pendleton, S. C., and he also taught school. He was buried at the Old Stone Church.
- J. A. Gantt served in Co. G, 12th S. C. Infantry and was lost during the war.
- Melmith Gantt was born about 1835, and he served in Co. G, 12th S. C. Inf. He was a son of Martin Gantt (b. ca 1813) and Sarah Gantt (b. ca 1811).
- John A. Gantt was a son of Redmond

 Gantt, and he served in Co. E, 2nd
 S. C. Rifles (Moore's). He lost his
 life during the Wilderness Campaign.
- John Cunningham Gantt joined the Fort Hill Guards at Pendleton, S. C., in June 1861.
- William M. (Harrison) Gantt (1844-1919)

 was a brother of John A. Gantt (see above). His wife was Leviser Vashti (Louise) Roper Gantt (1848-1929), daughter of the Rev. Charles Roper (1815-1883) and Elizabeth Higgins Roper (1823-1860).
- James Garrett resided in Hurricane Twp.
 of eastern Pickens District and
 served as a private in Black's Co.,
 Butler's Cavalry, C.S.A.
- Lewis H. Garrett enlisted at age 18 in Co. C, 1st S. C. Rifles (Orr's Regt.) and was killed at Fredericksburg, VA.
- Milton R. Garrett (1848-1918) served in Co. F, 1st S. C. Rifles (Orr's Regt.)
 He was a son of Stephen and Martha Garrett and a brother of Lewis H.
 Garrett (see above). He was a resident of Hurricane Twp. in the eastern division of Pickens District.

Hubbard Garmany. Garmany had been arrested for violation of the internal revenue laws and placed in the Greenville jail. He managed to break out and presumably returned to his farm some fifteen miles north of Greenville. WF Gray and Hendricks, acting in capacity of US Marshals, went to arrest and return him back to jail. Hendricks apparently advanced on Garmany, shooting at him twice and saying, 'damn you, I will take you or kill you.' This Hendricks did even though Garmany was holding his child in his arms at the time and the child crying, 'don't shoot pa.' Garmany returned one shot which killed Hendricks almost instantly. Hendricks was buried on the family homestead near Liberty.

During the July term of court, Garmany was tried and acquitted on the grounds that it was done in self defense.

REVENUER RAIDS ON CITIZENS

The revenuer raids on citizen's homes began with violence in the case of Mr J M Porter. In March 1877 a party of revenuers entered began a search of his dwelling. Mr Porter, a respected citizen of the county, objected to this "high handed outrage" and demanded their authority for searching his premises. "They fell upon him and beat him severely with pistols. One of them attempted to shoot him crying, 'Kill him, d--n him, kill him!' All because he demanded some authority shown to him." They then arrested Mr Porter on charges of resisting an officer in the course of performing his duty. On appearing in court the charges were quickly dismissed after it was made know that their were no warrants for his arrest or to search his home.

For this outrage he had the officials arrested for assualt and battery on a state warrant. Before the next session of court, writs of habeas corpus were issued by the United States court thus transferring the case to that court. They were immediately released and a year later the case was 'still sleeping' there.

Along about the last of April 1877, revenue officers

Barton, Gary and others visited the Little Eastatoe community where they enlisted Alfred McCrary to guide them through the mountains. Whether he volunterred or was compelled to go was questionable. The purpose, of course, was to find violators of the revenue laws and the 'habitation of the notorious Redmond.' He went along with the revenue officials on their hunt, but if they found any stills or made any raids, none were reported in the papers.

On 25 May 1877 McCrary was hoeing in his field while his little son was plowing the same field. From the woods came the report of a rifle and McCrary reeled and fell, dying in a few minutes from a ball through the lungs. The murderer kept himself securely under cover of the woods and made his escape.

The commentary included in the PICKENS SENTINEL 30 May 1877 report of the murder expressed distain for the killing as well as the recruitment of citizens by revenue officals.

".... whether Mr McCrary acted voluntarily in this matter or by compulsion, grievously has he paid the penalty with his life. Such acts of violence and reckless disregard of human life are ever to be deplored,...all good citizens should make every effort to bring to condign punishment the purpetrator of this foul murder. We think that revenue officers should not press in citizens to perform a work which they are paid to do." No one was ever charged with the crime.

Also in April and May 1877, a widow lady and her son had their own encounter with these revenue officers. Mrs Mary A Hinkle and her son Silas Hinkle Jr lived some twenty miles northwest of Pickens. On April fifteenth Silas was returning home from the fields for dinner. He heard shouts of 'Halt!' and turned to see three men coming across the field. He didn't stop and they fired three shots, two he heard pass over his head. After the second shot he began to run with the men chasing him for about a half mile before

letting him go on. Silas recognized the men as revenue officers. He had even talked with them some days later, but they made no attempt to arrest him.

Almost a month later on the eleventh of May, Mrs Hinkle saw about twenty-five men riding up the road towards and then past her home. They stopped some three hundred yards up the road then turned back. Wm Gary, E H Barton and John Scruggs were among the group and they proceeded to enter her home and search it. Barton went through her trunk then joined Gary in searching the whole house as well as the smokehouse. They found two double and one single barrelled shotguns which they took outside but returned them shortly. Barton stood in the house cursing and swearing about the guns and told Mrs Hinkle 'to tell Redmond they had been to see him and hoped he would call on them again.' Silas and his brother returned a couple of hours after they had left and their mother told what had happened. They examined the guns and found them 'bent and broken and rendered utterly unfit for use.'

Not one to be treated such, Mrs Hinkle went to Sheriff Joab Mauldin and Commissioner Thornely who issued a warrant against Barton and Gary along with another revenue official named Springs. At the preliminary hearing in July 1877, the widow describe the events that happened in her home and deputy collector Scruggs corroborated with his testimony. Barton and Gary were bound over for the August term for trial. Scruggs stated the Springs was not part of the raid and was discharged.

Revenue officers were not only in search of illicit whiskey, tobacco products required excise stamps and there seemed to be a law on the number of tobacco plants a farmer could grow. Neither was Pickens County the only county to suffer the 'wrath of revenuers.'
