James William KILGOAR b. Scotland/Ireland died 1771 in Cumberland Co., PA and his wife, Elizabeth JACKS KILGOAR died 1792 in Cumberland Co., PA leaving wills. My ancestor in SC is their son, Col. Benjamin KILGORE 1742-1810, of PA and Laurens District? and/or Spartanburg District of SC.

The brother of James William KILGORE 1720-1771 of PA is one, Charles KILGORE named as Exector or witness. This might be the same Charles KILGORE, or an uncle, of Kings Mountain NC Rev. Battle.

Does anyone have a record of the brothers and sisters of the above named JAMES WILLIAM KILGOAR/KILGORE (1720-1771) This James W. KILGORE was born in Scotland/ Ireland 1720? And came with his parents and siblings to PA about 1727 or so. His father, John KILGOAR died by 1730 or 1731 in Chester PA.

James W. KILGORE traveled to NC with his brother-in-law, Patrick JACKS, a signer? of the Mecklenburg Declaration of Independence, and who carried that document to Philadelphia, PA from Charlotte, NC. My source In 1993, Mrs J. William Davis, 23 Augusta Court, Greenville, SC 29605.

Does anyone have information on KILGORE persons in Kings Mt Battle of Rev. War?

Also any GILLESPIE persons who fought at Kings Mountain? One James GILLESPIE/GALLESPIY/GLISSPIE, born 1823 NC is in Union Co., GA census with family by 1870. His son, Alexnder GILLESPIE born 1866/68 lived in Union Co., GA and died in 1941, Hall Co., GA. His son is Sylvester GILLESPIE 1887-1960 who lived in Union and Hall Co., GA and is buried in Union Co., GA.

Willis Garrett resided in Hurricane Township and served in Co. B, 2nd S. C. Rifles (Moore's Regiment).

W. D. Garrison (1847-1908) served in Co. B, 16th S. C. Infantry. (Is this William David Garrison who was buried at Antioch Methodist Church in Pickens County?)

Frederick Garvin (b. 1843) was a member of Co. B, 2nd S. C. Rifles, and he was killed at Sharpsburg during the Civil War.

L. Armistead Garvin served to rank of second lieutenant in Co. G, 12th S. C. Infantry and was killed during the Wilderness Campaign in Virginia. He was born in 1832.

Robert May Garvin (1848-1865) enlisted at age sixteen in Co. I, 20th S. C. Infantry, C.S.A., and died of measles during the Civil War. He was a son of James Jefferson Garvin (1821-1894), who also served in the Confederate Army during the war.

William Thomas Garvin (b. 1837) enlisted in Company I, 4th S. C. Volunteers (Sloan's Regt.) at Pendleton, S. C., on April 14, 1861. He was a son of Green S. Garvin (b. 1817) and Mary C. Garvin. His wife was Martha M. James Garvin.



Joseph Carson Alexander (1844-1923)
Company B, 16th South Carolina Infantry, C.S.A.

Samuel J. Gary (1845-1862) was a son of Thomas R. and Elizabeth Gary. He enlisted in Co. D, Hampton's Legion at the age of sixteen years and was wounded at the Battle of Seven Pines in Virginia. He died a few days later at age seventeen.

Thomas N. Gary (1847-1865) was the only child of Samuel A. and Lucinda Gary and he died at Charleston, S. C., on January 1, 1865, at age seventeen.



CONFEDERATE SOLDIERS OF PICKENS DISTRICT, S. C. (Continued)

Clayton Gassaway served in Co. E, 2nd S. C. Rifles and died during the Civil War.

George C. Gassaway (b. ca 1837) was a son of Coleman Gassaway and Elizabeth Gassaway. He served in Co. E, 2nd S. C. Rifles and received a discharge from the army in May 1862.

Henry Gassaway, Jr. (b. ca 1828) was a private in Co. C, 2nd S. C. Rifles, and he lost his life in battle in east Tennessee.

N. G. Gassaway moved to Atlanta, GA, after the Civil War. In 1930, his widow, Margaret Gassaway, resided in Atlanta, but her name was on the widow's pension list for Oconee County, South Carolina.

Phillip N. Gassaway served in Co. E, 2nd S. C. Rifles (Moore's Regt.)

S. J. Gassaway served in Co. D, 22nd South Carolina Volunteers, C.S.A. In 1899, he was the recipient of a Civil War pension in Pickens Co.

Thomas H. Gassaway, Jr. was captured by Union troops at Wills Valley, Tennessee, and lost. He served as a private in Co. E, 2nd S. C. Rifles. He was a brother of John E. Gassaway, who also served in the Confederate Army.

W. C. Gassaway (Could this be Wesley Gassaway, son of Thomas H. Gassaway?) He served in Co. E, 2nd S. C. Rifles (Moore's Regiment).

W. H. Gaston was the recipient of a Civil War pension in 1902 in Oconee County, South Carolina.

James Geer (or Greer) died February 3, 1863, of smallpox while serving in the Confederate Army. He resided in the Zion Church area south of present-day Easley, SC.

James W. George died of disease at Richmond, Virginia, on May 4, 1863. He served in Co. E, 1st S. C. Rifles (Orr's Regiment).

John N. George (1838-1880) enlisted in Co. E, 1st S. C. Rifles (Orr's Regiment) when he was 22 years of age. His wife was Sarah "Sallie" Moody George (1851-1905), and they were married February 24, 1867.

Thomas Henry Gerard enlisted in the Fort Hill Guards at Pendleton, SC, on June 2, 1861. His unit became Co. K, 4th S. C. Volunteers, C.S.A. He resided at Tunnel Hill in what is presently Oconee County, SC.

Abselom Gibson (1837-1864) was a son of George Washington Gibson, and he served in Co. E, 1st S. C. Rifles (Orr's Regt.). He was killed in battle June 22, 1864, at Wilcox Farm, Virginia. His wife was Margaret Capehart Gibson.

David Gibson was a member of Co. C, 4th S. C. Cavalry, C.S.A., and he survived the Civil War.

Augustus A. "Gus" Gibson attended the first annual Confederate Veterans Day celebration at Pickens, S. C., on June 3, 1903. He served in Co. G, 2nd S. C. Infantry.

Hiram Alexander Hamilton Gibson was born a Capehart, but he changed his name to Gibson. He was wounded in battle at Frayser's Farm in Virginia during the Civil War. He was appointed sheriff of Oconee Co. in 1888, replacing Sheriff Brezeale, who died in office.

James Gibson (1837-1912) served in Co. C, Polk's North Carolina Regiment. He was buried at Richland Presbyterian Church in Oconee County.

J. A. Gibson was one of the 32 Confederate veterans who attended a memorial service for William Mauldin, C.S.A., which was held at Easley Methodist Church, Easley, SC, May 10, 1922.

James H. Gibson served in Co. I, 4th S. C. Volunteers, C.S.A. He enlisted at Pendleton, South Carolina on June 2, 1861.

that the revenue detectives have been going around through some portions of this county with a new scheme for invading the rights of our citizens. They claim that no man can have more than fifty stalks of tobacco, and have in some instances pulled up the overplus owned by some of our farmers."

The article went on to suggest that warrants be written against this officials and have them arrested. They would learn that the rights of peaceable citizens cannot be so wantonly invaded with the trespasser being properly punished. The commentary of the PICKENS SENTINEL concurred and went on to say "Revenue officials have become a great nuisance in this section. They seem to delight in oppressing our citizens by violating the very laws they are sworn to execute. It must cease. Our courts must be invoked to shield the innocent from their unlawful proceedings."

A month later the ANDERSON INTELLIGENCER again reports a 'tobacco raid,' this time a store. "On Friday 14 April 1877 revenue officers visited the store of Smith and Sloan in Pendleton and at the time of their entry both of the proprietors were absent and their clerk had gone into a back room with a customer for some meal. When the clerk returned, the officers asked to examine the tobacco boxes which was granted and they were found to be properly stamped. The proprietors had by this time returned and the officers asked to see their license to sell tobacco. Upon looking in their showcase, where it was kept, they found the license gone. It could not be found anywhere. The license was seen in the showcase the day before by several customers and the suspicion that it was removed by the detectives is very generally indulged at Pendleton.

"..... The gentlemen Smith and Sloan stand as high as any in the State and no person will doubt for an instant their statement of the matter.... The circumstance of the

transaction are all against the detectives, who ought to be indicted for larceny. The revenue officers of South Carolina are generally of a class of men who are a disgrace to the public service of any State.... [President Hayes can speedily gain the people's favor] by removing the infamous gang of revenue officials and detectives who have worried and oppressed our people than by any other single act."

Over in Wahalla, the revenue detectives had another scheme to catch violators of the law. In one store they requested to examine cigars from a box. This the clerk did and, after they were finished, tossed the cigars over toward the box where they landed on the shelve. The next day the officers returned and saw that the cigars were still outside the box which had the excise stamps affixed. The loose cigars were considered contraband.

For this violation of the revenue laws eight store owners were "carried off to Columbia, one hundred and five miles distant," and arraigned before a United States judge, who demanded that this wilful infraction of the law could only be appeased by the payment of from one to two hundred dollars each."

MARCH 1878 JAIL DELIVERY

The winter months passed without much excitement of other raids without warrants against citizens. But by March 1878 deputy U S marshals were now brought in from other areas and stationed in Pickens. On one Saturday, 9 March, they had been out in search of violators for which they did have warrants. They eventually found them and brought the prisoners to the Pickens jail where Sheriff Joab Mauldin took charge of them.

About nine o'clock that evening the sheriff had just secured his inmates for the night in the upstairs section of the jail and returned to his family's living quarters on the first floor. There was a knock at the door and he answered it thinking it was a friend or neighbor. Four men rushed in

and all had guns drawn and aimed at the sheriff. He was asked "in very polite tones to deliver up the jail keys." He protested as best he could, but the men demanded them again. This time using more forceful tones and "free use of adjectives and other parts of speech not found in the grammar."

By this time a crowd had gathered into the hall with others heard out in the yard. The sheriff yielded and delivered up the keys when the guns were once withdrawn from his chest. The sheriff asked that only the three men for which they had come 'to deliver from jail' be released. This they did, leaving other violators of the revenue laws and some for murder. As soon as they had their friends in hand, they rushed down the stairs, out the door and mounted their horses which they lead off toward the mountains at a gallop. The whole 'jail delivery' took less than fifteen minutes.

Sheriff Mauldin immediately went to inform Commission Thornley who then sent for the deputy marshals. The Sheriff stated that he did not recognize any of the men and after consultation among themselves determined it was not advisable to pursue them that night.

It was not reported in the papers that a pursuit of rescuers and rescuees was attempted on Sunday. On Monday 11 March Sheriff Mauldin sent a telegram to Governor Wade Hampton describing the events of Saturday night and stating that he along with Captain Hoffman, the revenue officer who lead the initial capture, would do all that was necessary to recapture all involved. He does not state that Redmond was involved in the rescue.

Governor Hampton replied the he expected him (Sheriff Mauldin) to use all means necessary to bring the offenders to justice and a reward offered for their apprehension. He also states, "Our people must learn that the laws are to be enforced and that all violations of them will be punished."

The petition of Elijah Alexander respectfully sheweth that your petitioner on her petition by the Honorable Court at a previous term made application by Bill of Partation of the Real Estate of Bailey Barton. The deceased father of your Petitioners, ward at the instance. Therefore one of the tracts of land was assigned to the ward. The appraisal value worth one thousand seven hundred and thirty five dollars in equal annual instalments of three years. The said land know as the Silman (Tilman?) Tract containing six hundred and seventy acres in Pickens District on each side of Twelve Mile River and described in Plat No 2 certified by John Bowen DS 10 June 1847. But now so it may please your Honor in consequence of **a charge of recovery had against the Estate of said Bailey Barton by the decree of this court requiring the surrender of a family of Negroes as well as on a more exact account of the Estate on which your petitioners Ward will be entitled it is apparant** that the lands aforesaid will constitute her principle. Not these lands through valued of one having other resources out of which to improve on from which a precent might be devised yet in their present condition they will fail all together as a source of annual income at all equal to the annual interest. The ward has a mother and also brothers who have attained full years. Sg: Whitner Harrison. Dated 1848

A little info on Bailey Barton and what kind of man he was, taken from Twin Springs and A Grove of Trees--Mountain Grove Baptist Church Researched by: Blanche Hannah, Written by: Effie A. Porter.

Page C-3 as told by William Madison "Cap" Cantrell: About Bailey Barton's tombstone: "Mr Cantrell, Jim Porter and two other men were horse-back riding and went by Mountain Grove Baptist Church. A thunder storm came up very quickly. The men sought temporary shelter under a grove of trees by the road near Bailey Barton's grave. While they waited for the shower of rain to pass, they began to talk. I bet Barton thought that the devil couldn't get to him in that grave, Porter remarked. He concluded with, You know he left instructions concernig his burial, another man asked, Reckon even the Lord will be able to get him out of that box? Immediately, lightning was seen and thunder heard. The air even seemed charged. The men stood in awe as a hugh tree which had been struck by lightening fell on the marble box over Mr Barton's grave. The box was split across the middle. Without futher words, the men silently rode away as the sun emerged from the clouds.

Lewis Eaton--Lewis Reese states that about 15 years since (1844) Lewis Eaton his father-in-law moved from Pickens District SC to the State of Kentucky and carried with him a family of negroes, his slaves to which he was very much attached. Sometimes after his removal **one Bailey Barton went** on to the state where the said Lewis Eaton was then residing, and seized the said slaves **under a pretended claim** and brought them back to Pickens District, except one which he left to wait on the said Lewis Eaton and his wife, who were very old and feeble. Some short time after his return to this state, the said Bailey Barton died (1847) and the said Lewis Eaton brought his suit in Equity against the admnrs. of the said Bailey Barton for the slaves thus taken from him and which slaves were at that time in the possession of his said admnrs. Jane Barton and Pleasant Alexander. The suit came to a hearing at June term 1848, the said slaves were ordered and decreed to be delivered to Lewis Eaton, which was done by the defendants Jane Barton and Pleasant Alexander. After the delivery of said slaves to the said

Lewis Eaton, his Solicitors who had the management of the said suit, refused to let him carry off the said slaves till their counsel fees were paid. Consequently the said slaves were left in possession of Watson Collins a son-in-law of the said Lewis Eaton, residing in Pickens District, till the said Lewis Eaton could return to Kentucky and procure the money to pay the fees and charges of his Solicitors. This caused the old man one or two trips to the State of Kentucky. He finally succeeded in paying off the Solicitors. The said Watson Collins then refused to deliver up to the said Lewis Eaton one of the slaves a girl then about 5 or 6 years old, till he was paid \$500.00 off his pretended services in assisting the said Lewis Eaton in his suit against the admnrs. of the said Bailey Barton for the said slaves. Not being able or willing to pay this unjust and groundless charge, the said Lewis Eaton was forced to leave the girl in the possession of the said Watson Collins, and shortly after his return to Kentucky with the other slaves, the said Lewis Eaton departed this life, intestate, in the State of Indiana.

Lewis Reese states that soon after he rec'd the notice of his Lewis Eaton death thru a letter from one of the slaves, carried off, he applied to the Ord. of Pickens Dist. for letters of Admnr. on the personal estate of Lewis Eaton in SC but the Ord refused. Nothing more was done in the case till last year he renewed his application for Letters of Admnr. and they were granted to him by W.J. Parsons Ord. of Pickens District. In the meantime the said slave remained in the possession of the said Watson Collins till he sold her to James E. Haggod of Pickens District for the sum of \$800.00. Whether the deeds for the lands conveyed to Watson Collins by Lewis Eaton were not made to enable him to sell the same for the benefit of the said Eaton. Whether he ever paid any thing for the said lands? How much money he recd. for Lewis Eaton of Esquire Gillespie, of North Carolina, (note: from Lewis's father John's Estate) and whether he ever paid it over. That the said James E. Hagood do answer whether he did not know when he purchased the said girl slave of Collins, that Collins had no title to her, and that she was claimed as belonging to the estate of Lewis Eaton--Filed 27 April 1859. 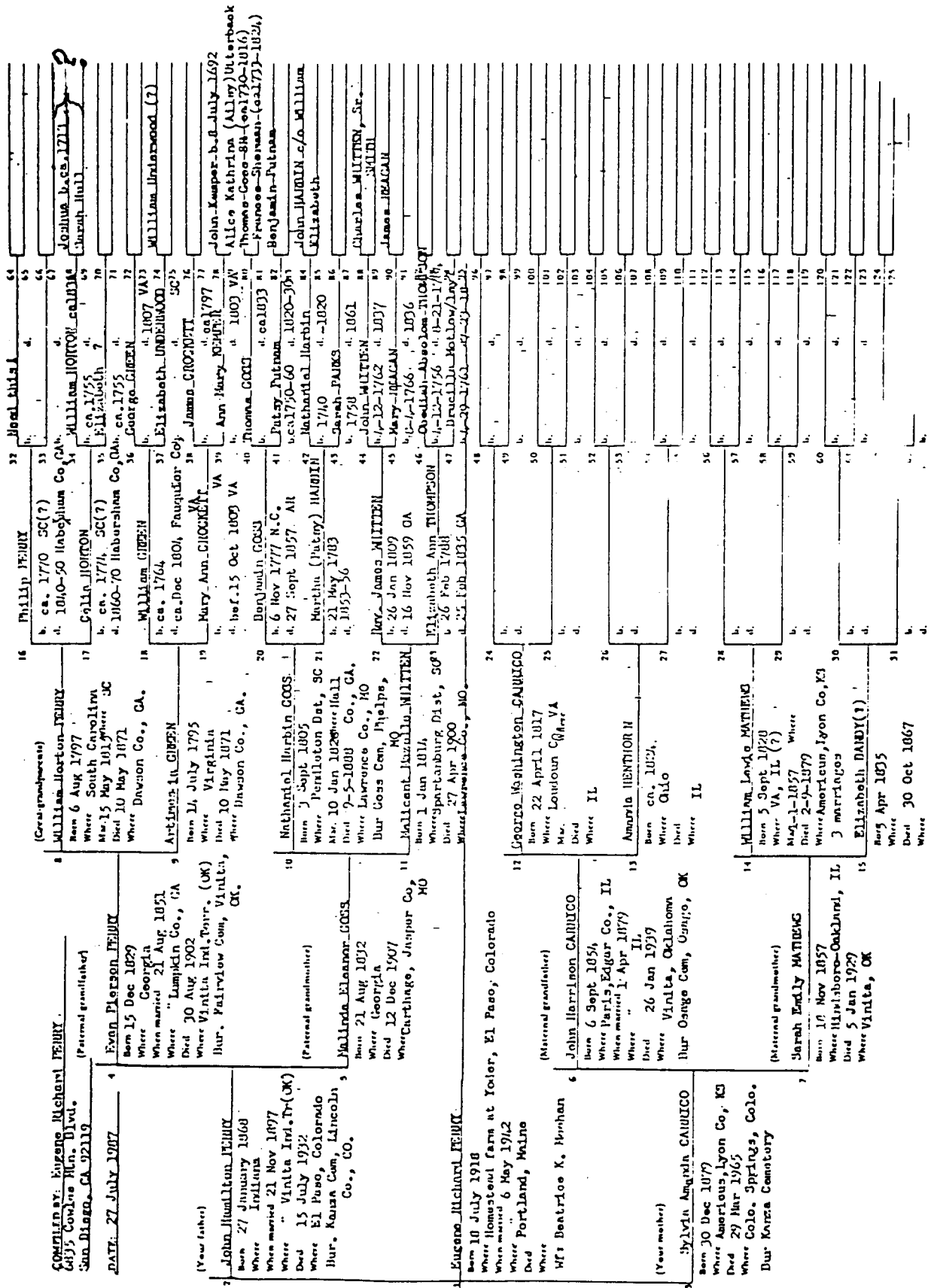
