December 11, 1813

Married on Thursday the 2nd inst. by the Rev. **A. Brown**, Mr. **William McClure**, to Miss **Elizabeth White**, both of this district.

South Carolina Senate proceedings. Bill ratifying and confirming a provisional agreement entering into between the State of South Carolina and the state of North Carolina, concluded at **McKinney's** on the Toxaway River, the 4th Sept. 1813. was read a third time and passed. Presentments were submitted by Col. **Moore**, from the grand jury of Pendleton District; all referred to the committee on the judiciary.

Charleston. Major General **Pinckney**, with his suit, left town yesterday morning for the Frontiers of Georgia, to assume the command of the army going against the Creek Indians.

Extract of letter from a gentlemen at Sapela in Georgia to his friend in Beaufort, SC, respecting growth of the sugar cane. Mentions names and plantation in Jamaica.

January 15, 1814

Orders from the Adjutant General. Rendezvous at Abbeville Court House on Tuesday the 25th on the way to **Fort Hawkins** where they will be joined by a detachment from North Carolina. The group will go against the **Creek Indians**. Six companies of the infantry and one of cavalry are to meet at Pendleton Court House on Thursday the 20th inst. from whence they will proceed to Abbeville.

William McGuffin intends having a beef market at Pendleton beginning the middle of June.

To the Citizens of Pendleton District. I am happy to have it in my power to state to the citizens of this district, that the accusation set forth in an affidavit, sworn to by **Richard Robertson**, implicating the character of **Richard Tarrant**, Esq. appears to be false; which the following letter, receiving by me, from General **Mays**, will more fully explain. Signed **Samuel Taylor**. Edgefield District. Dear Sir: I have lately received a copy of an affidavit made by **Richard Robertson** of Baldwin County, GA, in which the said **Robertson** states, that he heard one say, at the house of **Richard McMillan**, in Charleston, in September last, that it was by bribery that his Excellency **Joseph Alston** gained his election, and the last vote. I believed was **Richard Tarrant**, of Pendleton District for which he received \$200. I have not been in Charleston for upwards of two years and do declare that I never made use of any such language about those gentlemen, either in Charleston, or anywhere else. You are at liberty to make use of this should it be necessary and do justice to the character of either of the gentlemen who have been insulted. **Samuel Mays**.

January 29, 1814

[*Difficult to read*]. Creek War. On Sunday last, about 500 hearty fine looking men of the _____ took up their march from this place for the **Creek** nation; about three fourths of them from the upper part of this district, and the remainder from the upper part of Greenville. On their march they were joined by another company from the lower end of this district and at Abbeville, by one more from Greenville, which with reinforcements from Edgefield and Abbeville, had increased their number on Thursday morning to 901 [?]. They are by this time, the day's march in the state of Georgia, and if we may judge from the number who, since their departure have followed on from this neighborhood, to join them as Volunteers, they are now 1000 strong. These are a part of the quota of this State of 100,000 Militia drafted nearly two years since for their _____ of the United States, and now called for by General **Pinckney**. Of the number marched from this place was Captain **Kelly's** troop of Cavalry party from here and partly from Greenville district, whose appearance and equipment does them credit, uniformed in black of their own manufacture, a well mounted and _____ up, they were a [*rest is difficult to read*].
