EVANS' BRIGADE and the OLD PENDLETON DISTRICT:

Stone Family Connections

The Old Pendleton District furnished approximately 10% of the men of Evans' SC Brigade of the Confederate States Army. This brigade was initially formed in Charleston in July of 1862. of the 17th, 18th and 23rd SC Regiments and the Holcombe Legion Infantry Regiment. The 22nd SC Regiment was added a month later at Gordonsville, VA, and the 26th SC Regiment was added in May of 1863 as the Brigade left to attempt to relieve Vicksburg.

Six of the 60 companies of the full brigade originated in the Old Pendleton District. The Anderson District furnished Company D of the 18th Regiment and Company G of the 22nd Regiment, and the Pickens District furnished Companies D, F, H, and K of the 22nd Regiment.

Of particular interest to me is the fact that Company D of the 18th Regiment was organized by William Bramlett, the schoolmaster at the Brushy Creek School, at the Mountain Spring Muster Ground in December of 1861. Captain J. R. Bramlett's former assistant schoolmaster, John Francis Stone and my great-grandfather, joined the company as a 2nd lieutenant. Interestingly, John Francis Stone had signed up to join the 4th regiment when it was formed at Anderson Court House in April 1861. One can imagine that when he returned home from signing up in the excitement of the surrender of Fort Sumter his father (with 340 acres to plant) said "You did what?!" The next day he scratched his name from the signup list.

Albert N. Stone and Benjamin M. Stone also joined Captain William Anderson's Company (Company J) of the 4th SC Volunteers in April of 1861. These two men were the sons of neighbor Hampton Stone who were listed in the 1860 census as 19 and 21 respectively. A recent Civil War book, Portraits of Conflict, by R. B. McCaslin included a photo of Albert N. Stone and noted that he and his three brothers (Benjamin, Thomas, and Stephen) moved with their parents to Jasper County, Texas, in 1866.

Albert and Benjamin were probably close friends and/or relatives of John Francis Stone because Confederate Records show that George W. Stone followed the 4th Regiment to Camp Pettus, VA, and enlisted in Company D on August 1, 1861. He died of typhoid fever in the CSA General Hospital in Farmville, VA, on April 14, 1862.

Waddy Stone, a younger brother of John Francis Stone, also joined the 18th Regiment. He was mortally wounded in the brigade's first real fight, the Battle at Rappahanock Station, VA, in August of 1862.

Evans' Brigade saw service in Charleston and at Second Manassas, South Mountain, Sharpsburg, Kinston, Jackson, the effort to relieve Vicksburg, Bermuda Hundred, the Siege of Petersburg, Five Points, and at Appomattox. Its most famous fight was the Battle of the Petersburg Crater on July 30, 1864. The brigade had the unwanted distinction of being positioned directly over the blast, and it was the 18th and 22nd SC Regiments which lost about 275 men in this battle. John Francis Stone was lucky enough to be captured rather than killed, and he completed the war at Fort Delaware Prison.

John Francis Stone returned home to find that his father, George Stone (1808?-1865) had just died, leaving him to support his mother and two sisters, one of them widowed with two small children. In 1868, John Francis Stone married Emily Caroline Richardson of the Shiloh Community and they had seven children before she died in childbirth in 1882.

In the mid-1880's, John Francis Stone married Sarah Isabel Elrod (5/1/1860-2/21/1915), of the the Brushy Creek community. Her father, Elijah B. Elrod, had enlisted in Company D of the 18th SC Infantry along with John Francis Stone (of the 158 men who served in this company, fifteen were named Elrod). Elijah Elrod went off to The War leaving his 29 year-old wife Elizabeth, a 4 year-old child Ida (?or Richard I.), and twin girls M. Estelle and Sarah Isabel, aged 2 years. Elijah died of the measles in Charleston, SC, on July 22, 1862. Who would have predicted that his compatriot would marry his very young daughter twenty years later?

My interest in learning of the Civil war experience of John Francis Stone resulted in a ten-year Research project which culminated in the book, <u>Wandering to Glory: Confederate Veterans Remember Evans' Brigade</u> (USC Press, 2002). This is the only history of any of these six regiments and thus it should be of interest to any of your readers whose ancestors fought in this brigade.

EASLEY — Local author Brantli Jane Owens compiled over 200 vintage photographs to present the story of Easley's development since the times of the Industrial Revolution. The photographs in Easley demonstrate the growth of a small township named for General William K. Easley; to a town comprised of several mill villages, each with their own schools, churches and cultures; to the thriving city of today.

Some of the highlights of

Population of Pickens District in 1840

A total of 14,356 persons resided in Pickens District in 1840, according to U.S. Census statistics. Of that number, 11,548 were white, 2,715 were slaves, and 93 were listed as "free colored." Based on these numbers, about nineteen percent of the residents were slaves, and they were not considered as citizens of the district-but properties of citizens.

Some Facts about Slavery in Pickens District, S. C.

Within Pickens District, eighty-one percent of the 1840 residents did not own slaves. Moreover, most of those who did held only a few on their relative small farms (as evident from the list of slaveholders provided earlier herein.) That statistic stands in sharp contrast to slavery of the Low County and Midlands, where owners of large cotton plantations often held thousands of blacks from Africa in bondage. For example Wade Hampton (1818-1902) of Columbia, S. C., owned 5,000 slaves. He was one of the wealthiest persons in the South during his day, and served to the rank of lieutenant general in the Confederate States Army.

Moral Society of Pendleton District Was Established in 1816 in Pendleton S. C.

In September 1816, some leading citizens of Pendleton District met at the courthouse for the purpose of organizing a Moral Society. It was created to suppress vice and to encourage virtue. The following persons were chose as officers: Major General Andrew Pickens, president (He died in office during the following year.); vice president, Rev. James Hembree; secretary, John T Lewis, Esq.; and treasurer, Joseph Grisham. A committee of council was appointed at the meeting; its members were: the Rev. Henry Gains: John Pickens, Joseph Reid, Esq., George Reese, Sr.; and William Hillhouse. A committee for correspondence was also appointed as follows: the Rev. James Hillhouse; Samuel H. Dickson; and John T Lewis, Esquires. Fines to be imposed by the justice of the peace for the following moral offenses were: breach of the Sabbath or Lord's day, five shillings; sporting or gaming on Sunday, five shillings for each person offending; offering goods or merchandise for sale on Sunday, forfeiture of such goods; tayern keepers entertaining or suffering any person except strangers or lodgers to be in their houses, out houses, yards, orchards or fields, drinking or idly spending their time on the Lord's day, five shillings; for masters, mistresses, or overseers of slaves who encourage a servant or slave to work on Sunday, five shillings for every such offense; for each profane oath or curse, two shillings (and for the second offense, double-for the third offense after a second conviction, triple). Subsequently, various individuals were convicted for offenses, especially for swearing profane oaths. Charter members of the Moral Society were the following prominent citizens of Pendleton District:

September 5, 1832

Pendleton District Sunday School Union will meet at Farmers' Hall on Monday next at 12 o'clock. A meeting of the Pendleton Bible Society will meet at 1 o'clock.

Mr. J. Marek will present a concert of vocal and instrumental music at Mr. Hubbard's Long room tomorrow evening at 7 o'clock. He will perform on the following instruments: piano, violin, guitar and French Horn. He will sing in English, French, Spanish and German. Tickets 50 cents, children half price. He is prepared to tune and repair pianos. Inquire at Mr. Hubbard's Hotel.

Henry G. Dreffsen is selling is house at Pendleton, adjoining Maj. Sharpe's.

John S. Lorton asking for patrons to pay bills owned to Benson & Lorton.

Pendleton Jockey Club on Thursday, 4 Oct 1832. The first day, 3 mile heats; 2nd day, 2-mile heats; and 3rd day, one mile heats. The weights to be carried as same as Charleston Jockey Club. [More information in article.]

September 12, 1832

Henry Cobb announced he is a candidate for SC House of Representatives. He writes his views on State Rights and Tariff.

Report on the Meeting at Pickens Court House on 3rd Monday in September. [Report in last newspaper. It is different from this report.] Those who attended were mostly nullifiers. On motion, Thomas Gassaway Esq. was appointed chairman and Thomas Watson Esq. was appointed secretary. Nine were appointed to Report Resolutions Committee: Joseph G. Evetts, Jeptha Norton, Robert O'Barr, David McKinney, Jeremiah Field, Esq., John G. Coe, Elijah Alexander, Sr., John S. Edwards, William Whitmire. Resolutions are printed in newspaper. Col. Grisham and Capt. Maverick addressed and supported the resolutions.

Union and Anti-Nullification Meeting met at Pendleton on 6 Sept 1832. On motion of Samuel A. Maverick, Esq., Benjamin Dickson, Esq. was called to chairman and Miles M. Norton, Esq. was appointed secretary. Col. Grisham made some observations. Edwin Reese, Dr. William Anderson, Archibald Lawhorn, James C. Griffin and Wm. Dickson of this district and Hon. David Johnson of Union and Hon. John B. O'Neall of Newberry be appointed Delegates to represent this District in the Convention. The following were appointed to the Resolutions Committee: Benjamin Dickson Esq., Samuel Maverick, John Grisham, Edwin Reese, Captain Adam Todd, Archibald Lawhorn, David Hendrix, James C. Griffin, Esq., James Osborn Esq., Elijah Alexander Sr., Jeremiah Fields, Col. Jeptha Norton, Halbert Acker, Maj. James M'Kinney, John M'Pherson, Capt. Jos. G. Evett, Rev. Levi Garrison, Dr. William Anderson, S.J. Hammond Esq., and Col. John Harris. Col. Grisham, Colonel Norton, Benjamin Dickson Esq. and Samuel A. Maverick Esq. be appointed a Committee to invite such gentlemen from other districts to address the meeting.

It having been understood on Thursday, the 6th inst. that a meeting of a political character was assembling in Pendleton, at a house belonging to Col. Grisham, a committee of Maj. Jos. T. Whitefield, Maj. John B. Ferrell and Hugh Gaston, Esq. to go and invite them to their State Rights' meeting. Together they had 69 people. Col. J.B. Bonham motioned that Edward Harleston Esq. be Chairman and Maj. J.T. Whitefield appointed Secretary. Others at the meeting: Capt. Warley, Col. Bonham, B. Hasell Esq., Capt. D.R. Towers, Dr. F.W. Symmes and John E. Lewis.

J.T. Whitefield is withdrawing his name from the list of candidates for the Legislature. More information in the article.

John Sitton Jr., a candidate for SC House of Representatives. He writes his views on tariff and state's rights. Married on Thursday last, by Miles M. Norton, Esq., Mr. John Caminarde to Miss Polly Miller, all of this place. Married on the 6th inst., by Rev. Robert Gaines, Mr. Robert Copeland to Miss Sarah Neil, all of Pickens District.

Married on the 19th August, by Joseph Cox, Esq., Mr. Smallwood Dalton to Miss Rebecca Erskew, both of Anderson District.

Died on the 8th August 1832, Mr. John Mills in the 67th year of his age . . . a Native of North Carolina, removed to this State in 1800, an inhabitant of this district ever since.

A political meeting at Pickens C.H. will be held on 21 Sept 1832.

A meeting of the Anti-Nullification to be held on 19 Sept 1832. The State Rights and Free Trade party will have a meeting at the same time.

Meeting at Pendleton at Farmers Hall on the 17th of the free trade and State rights party. Col. S. Warren appointed to Chair and T.J. Pickens was appointed Secretary. Hearing that the Union party was also holding a meeting, the group sent Maj. J.T. Whitfield, Col. J. Harris and G. Washington Liddell Esq. to invite them to their meeting. Resolution Committee chosen: Gen. Whitner, Col. Anderson, Col. Pinckney, Dr. Symmes and Francis Burt Esq.

In 1851, "Colonel" John Hunter brought suit against A. M. Duke for possession of a slave.

In 1830, J. J. Burch sued J. J. Pickens for possession of a Negro boy named Ulysses.

In 1857, Robert Elliott Holcombe sold M.C. Alexander 531 acres of land on Eighteen Mile Creek for the sum of \$10,400. In partial payment of the land, Mr. Holcombe accepted a slave named Charles, valued at \$1,220.

Stephen Clayton gave Elvira E. Allgood of Blunt County, Texas, a six-year-old Negro girl called Ann.

In 1864, <u>Isaac Miller</u> left Mahaly, a slave, to his wife and made the stipulation that the slave was to be set free after his wife's death.

Owners of Four Slaves

Elias Mullinax (Note: Only one person was listed in the U.S. Census records as having four slaves, and no enumeration of the owners of three, two or one slave(s) was provided—even though some local residents were known to have held these numbers of slaves in 1840.) Matilda Gassaway, was to get a slave named Rebecca.

The April 12, 1830, will of <u>Daniel Stephens</u> provided for the transfer of two slaves, <u>Simon and Mary</u>, to wife Morning Stephens.

In 1836, Enoch B. Benson of Pendleton, S. C., brought suit against Elward Cater for possession of a twelve-day-old male slave. The baby boy was sold at a sheriff's sale.

According to John Cassell's 1853 will, which was filed August 14, 1861, wife Fanny (Wilson) Cassell was to inherit a twenty-year-old Negro girl named Jinny. Also bequeathed to Mr. Cassell's daughter Rosey Ann was Casia, a six-year-old slave. Isham, a Negro boy of about seventeen years, was to become the property of son Ephriam Cassell. Moreover, a three-year-old slave named Agga was destined to be given to Mr. Cassell's daughter Louisey, and a son Nathaniel Anderson Cassell was to receive Dick, a Negro boy of seven years of age. An additional slave, Bob, who was one year old, was scheduled to be passed on to Francis Marion Cassell, a son.

In Samuel Earle's will of November 15, 1831 (proved March 10, 1834), a son, Baylis John Earle, was bequeathed Joe, a male slave, and Sidney, a female slave, along with their three oldest offspring. To another son, Elias Theron Earle, Mr. Earle gave an entire slave family: Harry and his wife Phebe, plus their six children. In addition, Mr. Earle's granddaughter, Harriet Maxwell, was to inherit a Negro named Betty and Betty's son, Marlow.

A will prepared by Susanna A. Anderson on June 2, 1837, provided that her mother, Fanny Knox, was to receive a Negro girl from her estate. The will also contained a provision that at the mother's death the slave should then be appraised, after which Susanna's sister, Sarah McClure, was to pay her brother William Knox one half of the appraised value and then give the slave to her daughter Susan.

The will of Andrew P. Reeder specified that most of the slaves owned by him were not to be sold, but given to his wife. But two slaves named Harrison and Polly were to be sold, and the twin slaves named William and Jack were to be given to Mr. Reeder's son, Thomas Milton Reeder. The will also contained the following instruction: "If any of my Negroes become

unmanageable in any way, they are to be sold and the money put on interest for the benefit of my wife and children."

Mary Duff's will, written in 1841, bequeathed a Negro boy (Eli) and a Negro girl (Sarah) to the benefactor's daughter Naomi L. Duff. Mrs. Mary Duff was the widow of James Duff.

The August 7, 1861, will of Henry Cleveland Hunt bequeathed four Negroes (Bob, Mina, Margaret and Joe) to his wife. To son Esly Marion Hunt, the will required that he receive a Negro boy named Elias. Another slave (Berry) was passed on to son John Harlston Hunt, according to the will. And to daughter Nancy Aghtire Hunt, a Negro girl named Angeline was willed. Another son, Lawrence Cleveland Hunt, was scheduled to receive a slave named Henry. Mr. Hunt's daughter, Mary Vandalin Hunt, was to receive a slave named Jane, and another daughter, Martha Evaline DeAmbery Hunt, was to receive a female slave named Texana.

In a will written on December 29, 1864, <u>Isaac Miller</u> directed that his wife, Mary, was to be the recipient of land, stock, houses, hogs and a slave known as Mahaley.

Francis Burt, Sr., who owned a 705-acre farm on waters of Eighteen Mile Creek, bequeathed twenty-six slaves to heirs as follows: to wife Catherine Burt the Negroes named Stephen, Milley, Sam, Rose, Israel, Moses, Archer, Dick and Ed, all of whom were to eventually become the property of his children after Mrs. Burt's death; to his two daughters, Eliza and Permelia, Mr. Burt willed slaves named Jacob, Patt, Zeny, Beckey, Lora, Ister, Mariah, Isam, Margaret, Allick, Pender, Lucy and Spencer; and to his son Erasmus Burt, slaves named Roger, Humphries, Warren and Mary Ann were willed.

In 1846, <u>Pendleton Isbell's</u> wife, Clarky Isbell, was designated as the recipient of a thirteen-year-old Negro named Harriet. Mr. Isbell's will also specified that the slave (Harriet) was to be passed on to his youngest daughter, Eliza Admarinder, after his wife's death.

The 1839 will written by John McWhorter required the transfer of a Negro girl named Phillis and her increase to his wife Mary. The will also required Mr. McWhorter's heirs to sell the same slave after his

Under provisions of the 1836 will of Lindamira Lewis, a slave named Ben was bequeathed to the benefactor's nephew, Joseph McDowell. Also, a slave named Rose was left to Elizabeth McDowell, and a small slave named John was left to Edward Henry Shanklin. The benefactor's remaining slaves were to be equally divided to her two brothers, John E. Lewis and James Overton Lewis.

In 1836, George Hill willed his slave named Willis to his daughter, Melinda Hill Hendricks.

In 1831 Harvey Cleveland Hunt passed on four slaves to his wife. Their names were Bob, Mina, Margaret and Joe.

According to Thomas Caradine's will of October 12, 1859, a slave named Charlotte was to be given to his wife, Elizabeth Caradine. To his son Johnny Caradine, Mr. Caradine left a Negro boy named Joe. Additiononally, he specified that a slave named Nancy was to be given to daughten Avaline. To daughter Patsy, Mr. Caradine left a Negro girl named Arrena. A son, Thomas Cardine, was to receive a slave named Billy. Mr. Caradine also stipulated in his will that a slave by the name of Peter should be allowed to choose which one of his master's offspring would become his new owner.

According to the November 22, 1829, will of Richard Gaines, the following slaves were to be distributed: Luerecy to daughter Susanna; Mary Ann to son Henry P. Gaines; Amy to son Reuben Gaines; and, in lieu of a slave, to son James Gaines the benefactor left \$250 dollars worth of land.

Rober Easley's will dated March 31, 1806, left slaves named Ben, Floro, Jo, Abram, Sam, Rose, Aley, Morning and James to be equally divided among sons Samuel Easley, John Easley and daughter Nancy Easley Blassingame, wife of Thomas Blassingame. Additionally, son John Easley was to also obtain ownership of two Negro men by the names of Ned and Daniel. To Mr. Easley's wife, Catherine (Benson)

Easley, he left a Negro woman named Suck who was to remain in the wife's possession as long as her father, Enoch Benson lived. Then, the slave was to be passed on to Mr. Easley's granddaughter, Polly Blassingame, daughter of Nancy (Easley) Blassingame.

The December 15, 1828, will of Joseph Reid contains instructions for the transfer of ownership of two slaves, Bose and Hannah, to his wife, Isabella Reid. To his son Thomas Baskin Reid, two Negro boys named Ransom and Gaston were given. A Negro man named Isaac and a woman named Prue were to be given to son Joseph Reid. Also, two slaves named Syntha and Mariah were to be passed on to daughter Sara Hartgrove Reid.

Elizabeth Reeder's will of March 15, 1851, stipulated that all her properties, including her slaves, were to be equally divided among her six brothers and one sister. Moreover, she wanted all her slaves kept in the family "if possible".

The March 3, 1837, will of Benjamin Perry contained a statement that the benefactor's wife, Nancy Perry, was to obtain possession of a Negro boy named Solomon, as well as slaves named Sal, Ned, Charlotte, Jack and Tom. To his son Nathan James Foster Perry, Mr. Perry. left all the slaves that were on loan to him. They were named Jane, Rachel, Clary, and Parpha. Moreover, son Benjamin Franklin Perry, who would later (1865) be appointed provisional governor South Carolina by President Andrew Johnson, was left the following slaves by his father: Sheriff and Lucy. To Josiah Perry, another son, Mr. Perry willed the following slaves: Sawyer, Truelove and Tilly and all their children.

According to the will of James Parson, dated October 25, 1855, his wife Marie L. Parson was to inherit two Negroes, a woman named Caroline and "my Negro Boy."

The will of Thomas Gassaway of November 8, 1853, provided for the ownership of a slave named Juliet to be given to wife Dorcas Gassaway. Also, Samuel F. Gassaway, son, was to receive a Negro boy named William, and a daughter, Lucinda (the wife of Allen Harbin), was to get a slave girl named Amy. Another son, Thomas E. Gassaway, was left a Negro boy named Elijah. A daughter of Mr. Gassaway, Dorcas Ann Gassaway, was left a Negro girl named Mariah, along with a cow and calf. Another son, Enoch B. Gassaway, was to receive a slave named Henry. A granddaughter,
