# Information extracted from the Winter 2009 issue of *The Hagood Family Newsletter:*For the descendants of Benjamin Hagood and Adaline Ambler of the Old Pendleton/Pickens District. Editor: Gary Hagood Brightwell. Permission granted to publish this article by Gary Hagood Brightwell.

# Dr. John Robinson (1792—1841) Family Patriarch

Father-in-Law of Elvira Caroline Hagood (1829-1905) who married <u>William Wickliffe Robinson (1827-1886) &</u>
Father-in-Law of of James Earle Hagood (1826-1904) who married <u>Esther Benson Robinson (1829-1889)</u>
(Note: Brother and Sister marrying brother and sister.)

John ROBINSON was born 26 April 1792 in Fauquier County, Virginia to John Robinson and Elizabeth Benson. (Birthdate confirmed through his widow's pension application for his War of 1812 service.) John's mother died about 1800 and his father married again, probably in Fauquier County, to Sarah, daughter of Joseph Smith. Sometime between 1810 and 1813, the family moved to Nelson County, Kentucky.

On 26 August 1813, at Bloomfield, Nelson County, young John enlisted in the United States Army for service in the War of 1812. He was a surgeon, so obviously received medical training, but nothing has been learned of where he received his education and/or training. His rank was Ensign, and he served in the Company commanded by Capt. James McCloskey, in a Regiment commanded by Lt.Col. Philip Barbour. He was discharged about 10 November 1813.

Cousin Ayliffe Robinson Jacobs (Bogle) of Marietta, GA researched information on Dr. John Robinson in Nelson County, KY. The courthouse there burned, and while some papers are still in existence, others are missing. Ayliffe found that there was a 'friendly' lawsuit filed in an attempt to sort out and make an equitable division of the estate of John Robinson, (father of Dr. John Robinson) the husband of Elizabeth Benson and Sarah Smith. The following is contained in the Nelson County papers, quoting from Cousin Ayliffe's transcription:

The Deposition of Wm Ferguson taken at the Tavern of Thos. R. Elder in Bardstown on Saturday the 28th day of August 1830 to be read as Evidence in a suit in Chancery now pending in the Nelson Circuit Court Wherein **Sarah Robinson** is Complainant and the heirs of **John Robinson** is defendant. This deponent being of lawfull age and first duly sworn deposeth & saith Question by complainant Were you or not acquainted with **John Robinson** decd and also his son John who now resides in South Carolina?

<u>Answer</u> I was acquainted with **John Robinson** decd and also with his son **John Robinson** who I have understood and believe now lives in South Carolina

By same do you or not know of **John Robinson** now decd giving his son **John Robinson** some property and if he did please State what that property was, and the value in Your Estimation?

Answer I was at **John Robinsons** now decd in his lifetime and when his son John started to South Carolina, he took with him a negro boy [slave] and the horse the boy rode How old the boy was I cant say he was large enough to catch horses & ride well, after John had started and got some little distance the old man said he had given John the boy and horse, and it was as much as he Expected he should ever give him I would suppose the boy and horse was worth three hundred & fifty or three hundred & sixty Dollars

By same what year was it that John started to South Carolina?

Answer in 1815 or 1816 as near as I can recollect ...

The excellent research work of Cousin Ayliffe Bogle gives us some very valuable information on the Robinson family.

The Pendleton (South Carolina) Messenger of Wednesday, 9 September 1818 printed this notice:

"Married on Thursday last by the Rev. Lewis Rector ,Dr. John Robertson [sic] to Miss Eliza Blassingame, daughter of Gen. John Blassingame all of Greenville District."

Eliza Blassingame (Robinson), widow of Dr. John Robinson, applied for and was granted a widow's pension based upon her husband's service in the War of 1812. The pension application documents include a statement that the information about her marriage and children is "according to the family record." One wonders if there was a Robinson Family Bible from this time which may still be in existence.

The *Pickens Sentinel* of 20 September 1951 mentions that in 1884, Easley had its own newspaper, The *Easley Messenger*, and on 12 September 1884 printed this letter, from W. H. D. Gaillard of Pendleton, evidently written at an earlier date to the editor of the Keowee Courier:

Dear Sirs: In your issue of August the 28th giving the early history of Oconee County, you say that the first licensed physician who settled in Pickens District was Dr. Robert Maxwell, who...commenced practicing...in the Fall of 1841, but he was not the first licensed physician who lived, and practiced in Pickens District. **Dr. John Robinson** moved from Greenville and settled at old Pickensville in 1823, before the old Pendleton District (the present Anderson, Pickens and Oconee Counties) was divided. He moved to Pendleton in 1823 where he lived a few years, and then moved back to Pickensville where he lived, and practiced in 1835. I know that to be a fact, having stayed at his house that year.

A sketch of **Dr. John Robinson's** life follows: '**Dr. John Robinson** was a native of Virginia. His mother was buried at Sudley Church (near where the first and second battles of Manassas were later fought). Dr. Robinson was a surgeon in the War of 1812. Sometime after that war he moved to the then small village of Greenville, S.C., and continued the practice of his profession in which he was successful. He moved to Pickensville about 1823 and bought 3,600 acres of land from a man named Jack Archer, which included much of the present town of Easley.... He has many prominent descendants in this section of South Carolina.

In the famous B. F. Perry and Turner Bynum duel fought on an island in Tugaloo River in 1832, and said to be the last duel fought in South Carolina, **Dr. Robinson** attended Bynum and assisted in burying him at the Old Stone Church.

During the summer of 1825, Caroline Olivia (Mrs. John Ball) Laurens traveled with her family to the South Carolina Up-country to escape the heat of Charleston. She kept a diary in which Dr. John Robinson was mentioned and follow on the next page:

June] 25th. Left Greenville after breakfast and had a very pleasant ride over to Pickensville about 13 miles. The scenery was pretty, and the fields by far the best cultivated we have as yet seen. We crossed the Saluda river over a well built toll bridge, which has been lately put up. In some places the river may be forded, but the water is extremely muddy and is so thick that the bottom can not be seen. Pickensville is a pretty little spot, and has a fine view of Paris and Piney Mountains. It is the property of **Dr. John Roberson (Robinson)** who has a house in it where he with his family reside. There is a shop & one or two small dwelling houses also, and an orchard a half mile square, which extends from the main str. to the Pendleton road. The Dr. offered Mr. Laurens a fine lot, if he would build upon it." When Henry Laurens was unsuccessful in obtaining lodging in Pendleton initially, the couple stayed at Dr. Robinsons. The account continues with journal entry of July 1, 1825. "Early this moming we were awoke by the bustling noises of the neighbouring people who were getting ready to go to Greenville where a Negro was to burned alive for stabbing a white man. This fellow had made an attempt to kill his master, but not succeeding, he ran away and lodged in the barn of an old farmer, who having occasion for some grain, went thither at night; not knowing anyone was there, upon his entrance (the Negro who had just awoke out of a sound sleep and thinking he was pursued by his master) instantly jumped up and killed the old man and made his escape, but after a few weeks was caught and sentenced to be burned."

"This morning Mrs. Robinson hearing me say how very fond I was of green-cheese immediately set about making one, which she did by first pouring boiling water over a small bit of calf's rennet, then strained it off, and after straining the milk, warm from the cow threw in the water from the rennet, which turned it immediately, then she dipped off all the whey, and picked out the specks and hairs, after which it was put into a cheese hoop and pressed."

Journal entry of July 2, 1825. "Left Pickensville breakfast and arrived at Pendleton to dinner."

Journal entry of July 17, 1825. "Before I awoke this morning Mr. Laurens was by my bedside. He had slept at Pickensville, and arose an hour before day light to begin his journey for Pendleton, 16 miles, which he accomplished in two hours. Went to church as usual; saw the vice-president Calhoun--a very ordinary looking man."

#### November 28, 1832

At the Convention in Columbia, Col. Anderson presented a petition from sundry citizens of Pendleton, praying a division of the lection district; and likewise, a statement of a number of managers of election that district, on the subject of the grounds on which the question of the necessity of calling a convention was discussed during the late canvas for representatives. The question of consideration was raised by Judge Harper and on taking the vote, the convention refused to consider the matter.

List of Members at the Convention of the People of South Carolina.

Charles Carroll of Carrollton, GA, died in the 77<sup>th</sup> year, on the 14<sup>th</sup> inst., the sole survivor of the signers of the Declaration of Independence. [Charles Carroll was a signer from Maryland.]

### December 5, 1832

The Convention was composed generally of men who had advanced to middle life, or beyond it. There were few young men, probably not one under 25, and very few under 30. There were several who lived in the days of the Revolution. Major Hamilton of Charleston, who served through the whole of the war of independence; Captain Baker?, the last survivor of the defenders of Fort Moultrie; Col Warren, well know to many of us, as one who suffered severely in the struggle for liberty; Col. Rodgers of Marlboro, who fought with Sumter, and distinguished himself at the Cowpens; Mr. Long, of Laurens; Mr. Heyward of Charleston, and some others, of the Convention were, we believe, soldiers in that eventful contest.

The Legislature elected E. Harris of Pendleton for a Tax Collector and Robert Creswell of Pickens and James E. Reese of Anderson as Commissioners.

The late Elizabeth ("Bettie") C'Dell of Liberty was born on May 3, 1875. She passed away on Jane 5, 1943. She was a daughter of a prominent resident of Pickens County, William Thomas Bowen (1843-1922). Her father served as a Confederate soldier, between 1861 and 1865, and he was elected state senator from Pickens County, serving in the S.C. Legislature from 1898 until 1902. Mrs. O'Dell's mother was Rebecca Allgood O'Dell (1848-1925).

Bettie Bowen O'Dell was the wife of Wade C. O'Dell (1873-1953), a rural mail carrier farmer, and owner of a considerable amount of property in the Liberty area. Wade O'Dell was a son of William Taylor O'Dell, who also served as a state senator from Pickens County, from 1890 until 1898 and again from 1914 until 1918.

One of Bettie O'Dell's brothers, THOMAS A. BOWEN, was county agent of Pickens County for many years, and one of her sisters, Mary Bowen Robertson (1877-1910), was the first wife of Benjamin Franklin Robertson Sr. (1877-1910) and the mother of Ben Robertson (1903-1943), a famous World War II correspondent and author of Red Hills and Cotton.

Mr. and Mrs. Wade C. O'Dell lived in a white frame house on Commerce Street in Liberty. The house was located on the lot on which the present Duke Power Company building stands. The O'Dells were neighbors of Mr. and Mrs. C.E. Bush who lived in a large green house that formerly occupied the corner lot at Commerce and Main streets. The lot is now occupied by Carolina National Bank. On the other side of the Odell house stood the old Parkins home. Long since torn down, the Parkins house was located where the Liberty Post Office building now stands.


Mr. and Mrs. Wade O'Dell were the parents of Dr. Alfred Taylor O'Dell (1899-1948), a professor of English at Furman University in Greenville. Dr. O'Dell's widow, Catherine, is now a resident of Greenville, S.C. Dr. and Mrs. O'Dell were the parents of one child, Elizabeth Geraldine O'Dell (1933-1939), who was run over and killed by an automobile in Greenville when she was six years of age.


Mary Bowen Robertson, Mrs. O'Dell's sister and the mother of Ben Robertson, passed away when the author of Red Hills and Cotton was seven years of age. Two years after Mary Bowen Robertson had suffered an attack of

typhoid fever, she died as a result of diabetes on Christmas Eve, 1910. She did not know that she had diabetes, and she was making and tasting pies, cakes, and candy that she was preparing for the holiday celebration.

After Mrs. Roberton's death, Ben and his sister, Mary B. (now Mrs. Julian M. Longley Sr. of Dalton, Ga.) came to live with their Aunt. Bettie O'Dell and Uncle Wade O'Dell in Liberty. At that time Ben was seven, Betty B. was five, and Alfred O'Dell, their Liberty cousin, was nine. Ben Robertson and his sister remained in Liberty at their aunt and uncle's home for two and one.





Carwell Hester (1832-1863), a resident of the Rices Creek area, died of smallpox January 21, 1863, while serving the Confederacy.

John Baylus Hester (1825-1865), a resident of the Oolenoy Community, died in April 1865, while serving in the Confederate Army.

Robert "Rob" Hester, who lived in the Oolenoy area, died of disease while at home on medical leave from the Confederate Army.

Samuel R. Hester (1830-1862) died of disease September 20, 1862, at Winchester, Virginia.

Waddy Thompson Hester (1839-1864) died while serving in the Confederate Army during the Civil War.

Asa Hill resided in the Dacusville Community and died of disease during the War of the Rebellion.

R A. Hill, who resided in the Crossroads Baptist Church area, died at Adams Run March 21, 1862.

T. W. Hill died at Manchester, Virginia, December 25, 1861, while serving in the Confederate Army.

Elias Hinkle (1836-1864) resided in the mountains of the eastern division of Pickens District, S.C. and died February 1, 1864, at Richmond, Virginia, while

- serving in the Confederate Army.
- William R. Hogsed was killed at Spotsylvania, Virginia, while serving in the Confederate Army.
- James R. Holden died of disease while serving in the Confederate Army during the War of the Rebellion.
- James H. Holland, who lived in the Zion Church Community situated south of present-day Easley, was wounded and captured at Spotsylvania, Virginia, and died of consumption at Fort Delaware while being held prisoner of war.
- Buck Hollingsworth of the Salubrity area (Liberty) was killed while serving in the Condederate Army during the Civil War.
- Elias Hollingsworth lost his life in battle while serving in the Confederate Army in Virginia, during the North/South conflict.
- John Hollingsworth died while serving in the Army of the Confederate States of America during the Civil War.
- Enoch Hood (1824-1864) was killed in action at Petersburg, Virginia, June 20, 1964, while serving in the Confederate Army.
- David Hopkins died of typhoid fever February 20, 1862, while serving in the Confederate Army.
- M. D. L. Howard (1834-1862), a resident of the Enon Church Community, was wounded during the Seven Days' Battle Before Richmond, and he died June 28, 1862, in Virginia at age twenty-three years, five months and twenty-three days.
- J. H. Hughes of Dacusville died of measles while serving in the Confederate Army during the Civil War.
- Harleston H. Hunt died of typhoid fever August 24, 1861, while serving in the Army of the Confederate States of America.
- John T. K. Hunt, a Confederate soldier, died in Tennessee during the armed conflict between the North and South.
- William Pickens Hunt (1838-1864) was killed at Gravel Run, Virginia, August 31, 1864, while fighting in the War of the Rebellion.
- Morgan Abner Hutchins (1845-1864), a Confederate soldier, died during the Civil War.
- Carrol "Carl" Jameson (b. 1830) resided in the Georges Creek area and died during the Civil War.
- General Taylor Jameson (Note: "General" was his name---not his rank.) resided in the Pickensville area and died during the Civil War.

- John S. Jameson resided in the Georges Creek area and died July 13, 1862, at Richmond, Virginia.
- Wesley Jameson resided in the Georges Creek area of Pickens District and died June 19, 1864, while rerving in the Confederate Army.
- William M. Jameson (1820-1864) resided in the Georges Creek area and was killed about May 12, 1864, at Spotsylvania Court House, Virginia.
- Willis Johnson of the Zion Church Community, situated south of present-day Easley, was killed December 13, 1863, during the Battle of Fredericksburg.
- James Harvey Johnston (1835-1862), who resided in the Salubrity area (Liberty), was wounded at Gaines' Mill, Virginia, and died of those wounds July 7, 1862, at Richmond.
- Robert D. Johnston (1841-1862), a resident of the Salubrity area (Liberty), was wounded during the Second Battle of Bull Run at Manassas, Virginia, and died August 30, 1862.
- Augustine Jones (b. ca 1833 d. 1862), a Confederate soldier, died during the Civil War.
- Bennett Cooper Jones (1821-1864), who resided in the Dacusville area, died in 1864, while serving in the Confederate Army.
- Garland F. Jones (1828-1862) resided in the Dacusville area and died of typhoid fever November 15, 1862, in Augusta County, Virginia.
- K. B. Jones, who served in the Army of the Confederate States of America, died of disease in 1862.
- Robert Smith Kay (1833-1862) was killed July 6, 1862, near Richmond, Virginia, while serving in the Confederate Army.
- **David Campbell Keasler**, a Confederate soldier, died September 30, 1864, during the War of the Rebellion.
- John Berry Keasler died September 26, 1862, while serving in the Confederate Army during the Civil War.
- Elliott Monroe Keith (1812-1864) might have resided in the Oolenoy section; died in 1864 in Pickens District, South Carolina.
- John R. Keith (b. ca 1840), who resided in the Oolenoy Community, died while serving in the Confederate Army.
- John Randolph Keith (1840-1862) resided in the Oolenoy section and died February 8, 1862, at Sullivans Island, South Carolina.
- Thomas Jefferson Keith (1833-1862), a resident of Oolenoy, died of typhoid fever August 4, 1862, at Richmond, Virginia.

- Elisha Kelley (1824-1865) resided in Twelve Mile Township and died in 1865 in a Union prisoner-of-war camp.
- **D. S. Kelley** died in Pickens District, S. C., while at home on medical leave from the Army of the Confederate States of America.
- Rufus C. Kennedy (b. ca 1841), who resided near Carmel Presbyterian Church in what is today southern Pickens County, was killed during the Civil War.
- Moses Kennemore (1824-1864) of the Enon Church Community was captured by Union troops during the Civil War and died at Elmira, New York, while being held there as a prisoner of war.
- David King, a Confederate soldier, was killed near Potomac, Virginia, during the War of the Rebellion.
- R. F. King was killed at Petersburg, Virginia, while serving in the Confederate Army during the Civil War.
- Jared E. F. Kirksey, Jr. (1822-1864), a Confederate soldier, was killed during the Civil War..
- James Madison Knox (b. 1840), who resided near the valley of the Keowee River, was killed while serving in the Confederate Army.
- John Craig Knox resided in the Keowee River Valley and died of wounds on June 2, 1864, in Virginia.
- William W. Lathem (1825-1864) died August 8, 1864, while serving in the Confederate Army during the War of the Rebellion.
- E. Henry Lawrence (1843-1864), a Confederate soldier, died May 24, 1864, at Goldsboro, North Carolina.
- Joseph N. Lawrence (1820-1863) resided in Hurricane Township and died September 28, 1863, while serving in the Confederate Army.
- Moses H. Lesley (1846-1864) was killed during the Wilderness Campaign while serving in the Confederate Army in Virginia.
- Aaron B. Lewis, a Confederate soldier, died of disease while home on medical leave during the Civil War.
- David S. Lewis (1843-1862) died June 24, 1862, while serving in the Confederate Army.
- Earle S. Lewis, a soldier of the Army of the Confederate States of America,, died in February 1863 during the Civil War.
- Robert O. Lewis, a Confederate soldier, died December 31, 1861, during the Civil War.

# **Cemetery Signs Ready**

County Will Create Brochure Identifying, Mapping Cemeteries


Signs identifying the cemeteries in Pickens County have been completed and will be placed in local graveyards soon. County Administrator J. Chappell Hurst said. "County officials formed a committee comprised of locals knowledgeable of county history and tasked them with creating a list of cemeteries in the county. "They met several times to determine which (cemeteries) had historical significance," Hurst said. "Then they came up with a sign that will document where those cemeteries are and the names of them, so that people could identify them."

The signs contain both the name of the cemeteries and an identifying number. "We're not stopping with just a sign," Hurst said. "We're putting together a brochure that tells what historical significance each cemetery has, whether there's Confederate veterans there, who's buried in that cemetery. Someone could take this brochure, ride around Pickens County and identify cemeteries that have historical significance or have meaning to them," Hurst said. "It'll give them some information about the cemeteries."

The signs also contain map and GPS coordinates to make locating them easier. 50 signs have already been placed in cemeteries. Hurst said. "You'll see them around the county as you travel," he said. Another 50 or so cemeteries have yet to receive signs, Hurst said. Committee members have been traveling with county sign crews to determine where best to place the new signage Hurst said. "Their list contains both public and private cemeteries, Hurst said.

An ordinance is also being formed that stress the importance of protecting local cemeteries. The list contains both public and private cemeteries, Hurst said.

"Their list is probably more extensive than you'd ever believe," said County Council Chairman G. Neil Smith. Smith said he would like to have the county work to make cemeteries more accessible especially for older residents doing research on their family history.



# JOHN C. SMITH




John C. and Amanda Smith.


