

Proceedings of the Convention. "The special order, an ordinance for the division of Pickens District, was taken up and passed by a vote of ayes 80, nays, 23. [Unable to read numerals.]

Division of Pickens. Page 2. Column 1-2. We publish below, the ordinance which passed the Convention, by an overwhelming majority, dividing Pickens into two judicial and election Districts—the Western District to be called Oconee, and the Eastern to retain the ancient name of Pickens. It will be seen from the ordinance that six Commissioners have been appointed in each new District, who are to select the localities of the Court House, make purchases & etc. These are gentlemen of integrity and discretion, who, we hope, will take advantage of the opportunity, afforded them to display their good taste and judgment. This age can certainly improve on the present selection. By a judicious course, they can also save the State much additional taxation. This is a measure long looked for and much desired by the majority of the people of the District and while it may be regretted at the present by some, yet we sincerely hope that it will ultimately prove success, and redound in the increased prosperity of both sections.

The following is the Ordinance as passed by the Convention:

We, the People of South Carolina, in Convention assembled, do declare and ordain and it is hereby declared and ordained, That Pickens District is divided into two Judicial and Election Districts, by a line leaving the southern boundary of the State of North Carolina where the White Water River enters this State, and thence down the center of said River by whatever names known, to Raveniel' a Bridge, on Seneca river, and thence along the center of the road leading to Pendleton Village and is intersecting the line of the District of Anderson. "That the Territory lying east of said line shall hereafter constitute the Judicial and Election District of Pickens and the Territory lying west of said line shall constitute a new Judicial and Election District called Oconee District. [Will finish in another edition.]

That Jas. Lewis, Jas. H. Ambler, J. E. Hagood, W.T. Field, Reese Bowen, and Thomas Price . . .

Wesley Pitchford, W.E. Holcombe, Bry Fretwell, M.F. Mitchel and Dr. O.M. Doyle be appointed Special Commissioners to select proper site, and locate and erect a Court House and Jail for Oconee District, which shall be either at Walhalla or some point on Town of Walhalla between that place and Perryville. Section 4. The two Boards of Commissioners acting together are authorized to sell the present Court House and Jail, with the public grounds of Pickens District and money same to the State; the proceeds shall be divided between the two Districts.



February 15, 1868.

Being desirous of changing my business, I propose to sell my farm known as the "Lay Place" lying on the north fork of Little River, in Cheohee Valley and 13 miles from Walhalla.250 acres. Good dwelling house containing 6 rooms, all necessary outbuildings including blacksmith shop. There are, also, four other settlements on the place, now occupied and being improved by tenants; also good grist mill, in excellent order, with a fine custom. This farm lying at the foot of the mountain, contiguous to a range extending for miles offers rare inducements to stock grower. It is within two miles of Kuhtmann's Gold Mine, and has been examined and tested by four experienced miners, all of whom pronounced specimens—found in several places—as rich as ever found anywhere. The GOLD is here to show for itself and miners are invited to come and see. Also for sell is mules, 3,000 bushels corn, peas, hay, fodder, shucks, wagons, farming implements, stock of cattle and hobs, household and kitchen furniture, etc. W. R. Smith. February 23, 1868

Article on John C. Calhoun. "It is still owned by his family, though repeatedly advertised in the district papers to be sold for debt. Mr. Calhoun left a considerable property, but the estate owning a large number of Negroes, and a great amount of money having been invested in Confederate bonds, little or nothing would have remained to those who bear his name but for General Canby's homestead law." "My friend, Mr. Smith, came from New England some time before the war; his means were so limited that himself and family were employed as hands in one of the factories of a neighborhood village. Some fortunate speculations, of which the proceeds were immediately and judiciously invested, enabled him to acquire wealth very rapidly. He now owns over \$50,000 worth of property, lives in a pleasant residence not far from the village, and is doing business which, bids fair rapidly to increase his wealth and resources."

following are the reasons for not making earlier application for a pension that on the 30th day of March 1820 he made an original Declaration before the Honorable David Johnson one of the associate Judge of the State of South Carolina setting out the facts as above related which was accompanied with the certificate of Captain Hix of his faithful service and that he had been discharged. He afterwards sent by Schedule and lately received notice that on the 8th of December 1820 his claim was suspended on account of the amount of his property, he is a very poor and infirm old man with no friends able to assist him, he made every inquiry in his power but being unable to obtain any information how to proceed until he received the letter _____ of Edward and accompanying instructions he had nearly dispared _____ assistance for his hard earned demands.

And in pursuance of the Act of the 1st May 1820 I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an Act of Congress entitled "An act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th Mar 1818. And that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me; nor have I any income, other than what is contained in the Schedule hereto annexed and by me subscribed. That since the 18th March 1818 no changes have been made but such as were necessary to support himself and family that he now hath as such real and personal estate as he then had or nearly so. And all his Estate now consist of 100 acres of land in Pendleton District of the third quality very poor, one horse, 4 cows, 4 small heifers, 3 sows, 14 shoats, 1 plow and gears, 1 gofer, 1 wedge, 1 mattock, 2 hoes, 1 pot 1 oven 1 broken skillet 2 pewter dishes 2 pewter 6 pewter plates 6 ten cups 1 tin bucket 2 delph plates 1 ax 2 chairs 2 chair frames 1 pail 2 pig 1 churn 1 small bell. He is by occupation a farmer but so old and infirm he cannot pursue it to advantage, his family consists of his wife Hannah about sixty eight years of age, his daughter Elenor is about twenty two years of age, and her child about four years of age, neither of them are able to contribute toward their support. He owes Jonathan Roider? For thirty one dollars fifty two and one fourth cents and Messer ___ Colhoun three dollars and seven and a half cents, besides several other small debts.

John Mason Revolutionary War Pension Application Pendleton District Records 1820-1827 py from South Carolina Department of Anchines and History

Copy from South Carolina Department of Archives and History

State of South Carolina, Pendleton District. On this 26th day of October 1820 personally appeared in open Court in the Court of General Sessions of the Peace Oyer and Terminer Assize and General Gaol Delivery being a Court of Record for the said District in the State aforesaid, John Mason, aged 66 years, resident in the said District in the said State, who being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary war as follows: That he enlisted on the 26th day of December in the year 1777 for the term of three years under Captain Isaac Hicks of the Third Regiment commanded by Colonel Scriven of the Georgia Line was at the Battles of Savannah, Brier Creek, and several other small engagements; and was regularly discharged after serving his full time of enlistment out.

An original declaration was made on the 30th day of March 1820. Before the Honorable Judge David Johnson. And I do solemnly swear that I was a resident citizen of the United States, on the 18th day of March 1818; and that I have not, since that time, by gift sale or in way manner, disposed of my property or any part thereof, with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress, entitled "An Act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary war" passed on the 18th day of March 1818; and ______ have not, nor has any person in trust for me, any property, or securities, _____ to me; nor have I any income other than what is contained ______ hereto annexed, and by me subscribed . . . 

May 1820 that he the said John Mason enlisted for the term of Three Years on the (no date listed) day of December 1776 in Mecklenburg County in the State of Virginia in the company commanded by Captain Isaac Hix in the regiment commanded by Colonel Seriven in the line of the State of Georgia on the continental establishment, that he continued to serve in the said corps or a prisoner, he was discharged from the service in Savannah in the State of Georgia. He was at Savannah at the time the British took it from there he went to the Battle at Brier Creek where he was taken prisoner with his Captain Isaac Hix, Major Lane and General Elbert that he hereby relinquishes every claim whatever to a pension except the present; that his name is not on the Roll of any State except by ______ of the first application he is on the United States of which he has never received any notice of its being so, and that the





Searching for Information on Davis and Carnes/Karnes

I am looking for information on the family of my GGG Grandfather **Thompson Davis**. He was born 26 March 1826 (or 27). According to family history, he was born in Greenville, but Anderson is listed as his birthplace in the 1860 Census. His father was a **Thomas Davis** married to possibly to **Jane and/or a Miss Boggs**. They were said to have a plantation near the Saluda River. Thompson's siblings were **Elizabeth (1832)**, **Joseph (1834)**, **Mary (1841)**, **and Louisa (1843)**. Thompson married **Elizabeth Purilla* Carnes (Karnes)** on 2 Dec 1850 or 1851 in Greenville. She was born 1 Aug. 1831(36). Her parents were **John and Emily Carnes**. She had a brother named **John**.

In the Pickens 1860 Census, **Thompson Davis** is listed as a farmer along with his wife and their first 3 children: James R. (age 5), **Christian G.** which is incorrect for **Christina J**. (female, age 4) and **John** (age 1). Christina is my GG Grandmother. Anderson is listed as their birthplaces except for John who was listed in Pickens. Two other children **Emily** (1861) and **William Levi** (1866) were born in SC before the family moved to Alabama after **Thompson** returned from the War. He enlisted in Pickens in Crawford's Co. B of the 2nd SC Rifles. His military records are very interesting!

An interesting story published in an Alabama family history book notes that during the War, after the Yankees destroyed all the owned, Elizabeth and her four children "had to move on to old man **Bob Craig's** place." I know Thompson and his family ended up in north Alabama. I am hoping to locate information on Thompson and Elizabeth's parents and siblings. 




