Lt. Robert Morgan receives Cross of Honor

Descendants of Robert Finley Morgan gathered at his gravesite in the Morgan-Cannon family cemetery near Six Mile to participate in Southern Cross of Honor dedication ceremony on Sunday, October 13.

Robert Morgan was born May 27, 1812, and grew up in Upper Pickens District. He was married to Malissa Cannon and the couple

had eight sons and three daughters. The families at the dedication ceremony traced their ancestry back through Robert and Malissa's children.

The event was sponsored by the Pickens County 150 Confederate Project, Central Heritage Society, Pickens County Historical Society and the Old Pendleton Genealogical Society.

In addition, the Sons of Confederate Veterans were represented by Jefferson Davis Easley Camp 7, 2nd South Carolina Lt. Robert F. Morgan's

Regiment Pickens Camp 71 and grave near Six Mile. the 16th Regiment Color Guard. The United Daughters of the

Confederacy members were from the James L. Orr and John C. Calhoun Chapters. The program began with a bagpiper leading members of the 16th Regiment Color Guard into the cemetery to post the Colors, followed by pledges and salutes to the flags led by Catherine Carson of the UDC.

Marion Ard Whitehurst spoke to the OPD group in October about a subject she has been researching for many years, Old Stone Church in Clemson.

She is a member of the Daughters of the American Revolution, the United Daughters of the Confederacy, the Colonial Dames, the Huguenot Society of Washington, D.C. and the Historic Properties Alumni Advisory Committee of Clemson University,

She brought several books, newspaper articles and handouts to the meeting, as well as a large picture of the church. She told the audience about the American Revolutionary and Civil War soldiers buried in the cemetery adjacent to the church, including Andrew Pickens and Robert Anderson.

She spoke of the history of the area and how the church came to be built from field stones, which helped earn the Hopewell congregation meeting house the name of the Stone Church.

Whitehurst had interesting stories of many of the members and families associated with the church in its early years.

President of the Central Heritage Society Beverly Cureton welcomed everyone to the ceremony.

The Central Heritage Society operates the Central History Museum which was built in 1893 and was originally the home of Jeptha and Minnie Morgan. Jeptha was one of Robert and Malissa's children.

Anne Sheriff, Curator for Central Museum and the Faith Clayton Family Research Center at Southern Wesleyan University, explained the Pickens County 150 Confederate Project to the audience.

She said that the Confederate 150 Project coincides with the 150th anniversary of the War Between the States. Members of this group travel to cemeteries all over Pickens County to attempt to locate all Confederate soldiers buried in Pickens County. The plan is to honor each soldier with a Confederate Cross of Honor at their gravesite. In addition, military information is being gathered along with GPS locations to ensure that these soldiers can be more easily located in the future.

Sheriff told them that in May of this year, 50 soldiers had received their Crosses of Honor and were remembered during the Confederate Memorial Day Service sponsored by the Pickens Historical Society.

She added that another 100 soldiers had been identified and would be recognized next year.

Betty Morgan Holcombe, a great granddaughter of Robert Morgan, through his son James Rufus Morgan, was the featured speaker. She read several newspaper articles and personal histories concerning her ancestor.

She said Robert, known as Bob, served as a Deputy Sheriff and Constable for the Pickens District. In addition, he operated a grist mill known as Morgan's Mill (later Jones Mill) on Six Mile Creek.

She said that Robert and his 17-year-old son William Lafayette, left their home for the muster grounds in Sandy Springs in 1861.

Robert, a First Lieutenant, would later resign his commission in 1863, due to a continued illness.

In 1866, he sold his share of Morgan's Mill and moved to Perryville, just east of Seneca where he operated a successful inn. His wife Malissa died in 1871. He stayed at the inn until his children were grown, then returned to the Jones Mill area where he died in 1884.

Mrs. Holcombe said that after his death, the family found ledgers with hundreds of small loans totaling thousands of dollars made by Robert to members of his community. His epitaph reads, "He was the poor man's friend."

To conclude the ceremony, Ken Nabors, Camp 17 Adjutant and President of the Pickens Historical Society, unveiled the Southern Cross of Honor at Lt. Morgan's grave.

Descendants Virginia Morgan Wilson of the William Lafayette line, Janice Evans Whitten of the Mary Emmaline line, and Alton Morgan and Betty Holcombe of the James Rufus line, placed a wreath upon the grave.

Jim Bay of Camp 71 performed a Canteen ceremony with the members of the 16th Regiment which included a drink of water for their fallen comrade poured at the grave site. This was followed by a Cannon and Rifle salute involving the 2nd S.C. Regiment before the Color Guard retired the Colors.

The murder of Daniel Doughty: A skeleton in my family closet

I was quite surprised to learn this story while tracing the ancestry of my grandmother, Virginia Doughty Hughes (1896-1978).

In 1804, my grandmother's direct line Doughty ancestors lived in the western part of the Pendleton District in South Carolina. The eldest was Joseph Doughty (1755-1815), who was my 4th great grandfather. His children included my 3rd great grandfather, Jeremiah Doughty Sr. (1777-1838) and Jeremiah's older brother, Daniel.

Daniel Doughty's will

Daniel Doughty's will, dated Nov. 24th, 1804. Towards the end of November 1804, Daniel filed a will saying that he was "sick and weak in body but of sound & disposing mind memory and understanding."

In the will he bequeathed "unto my dearly beloved wife Rachel Doughty one feather Bed with the furniture belonging to the same and her wearing clothes and no other part of my Estates." He left the rest of his estate to his sons, Joseph and Laban.

By the following February, Daniel was dead and his "dearly beloved wife" was in jail, accused of murdering him.

A second suspect named John Andrews was also in jail but the alleged mastermind of the crime — Rachel's father, Laban Oakley — had escaped from jail and was on the run.

South Carolina Governor Paul Hamilton issued the following proclamation on Feb. 19, 1805:

State of So. Carolina. By His Excellency Paul Hamilton Governor & Commander in Chief in & over the State aforesaid. A Proclamation. Whereas I have received information that Daniel Doughty late of the District of Pendleton has been most barbarously and wickedly destroyed by his wife Rachel, his step-father Laban Oakley, a certain John Andrews who disregarding all social, moral, & religious ties did most treacherously & cruelly combine and conspire together and did infuse into the drink, food and medicine of the said Daniel Doughty repeated doses of ratsbane or arsenic of the effects of which after the most excruiating tortures & lamentable suffering the said Daniel Doughty did at last die. And whereas the said Rachel the wife of the said Daniel Doughty and the said John Andrews have both been committed to Gaol under strong evidence of their guilt but Laban Oakley the step-father as above said who is believed to have been the first mover of this wicked conspiracy has fled & eludes the pursuit of justice. Therefore I deem it proper to issue this my Proclamation hereby offering a reward of \$400 to any person or persons who will apprehend & deliver to the custody of the Sheriff of the District in this State the said Laban Oakley to be paid on his being convicted of the said offence. And I hereby most earnestly call upon & require all officers civil & military and all other friends to the peace safety and happiness of the Community to the aiding & assisting to the utmost of their power in apprehending & bringing to answer with his accomplices to the Laws the said Laban Oakley to the and that this dreadful & wicked outrage on humanity may be followed by the punishment which is due to it and an example made which may deter others from

the perpetration of crimes of a nature so flagitious & detestable. Given under my hand and with the seal of the State this 19th day of February A.D. 1805 and of American Independence the 29th. Paul (L.M.S.) Hamilton. By the Governor Daniel Huges Secretary of State. Recorded 19th February 1805.

A document from Gov. Hamilton dated Dec. 13, 1805, indicates that \$400 had been paid "for apprehending Laban Oakley, a murderer under Proclamation who broke Gaol and fled in Tennessee."

After the death of Daniel Doughty, his sons went to live with their grandfather, and Laban Doughty's first name was changed to Daniel. By 1820 this Doughty family had moved

from the Pendleton District to the area around Tuscaloosa, Ala. Several of them are buried at Big Creek Cemetery. (My grandparents would meet, almost a century later, when Virgie Doughty wrote a letter to Arley Hughes, on behalf of her father, James Harvey Doughty, inviting him to apply for a job as a school teacher in Pickens County, Ala.)

According to sources I found online, Daniel Doughty the younger (the murdered Daniel's son) later changed the spelling of his last name to "Doty." Why he did this, I don't know, but it may have been an attempt on his part to stake a claim of descent from the Mayflower passenger Edward Doty.

He ultimately settled in Mississippi, where some say the community of Doty Springs was named after him.

Application for Pension by William Day Revolutionary War

Pendleton District. On the Twenty sixth day of October, 1820, personally appeared, in open court in the Court of General Sessions of the Peace Oyer and Terminer Assize and General Goal Delivery being a Court of record for the said District in the State **William Day** aged Sixty-four Years, resident in the District in South Carolina, who, being first duly sworn, according to law, doth on his oath, declare that he served in the Revolutionary war as follows:

That he Enlisted under Lieutenant George Holland of Captain Hawkins company of the Fourteenth Regiment Commanded by Colonel Lewis of the Virginia Line For the term of Three Years: Served about six months in it and was transferred or exchanged to the Fifth Regiment Commanded by Colonel Parker and served there Twelve months or more and in that time this Deponent was in the Battles at Brandywine, Germantown, & Monmouth and served the remainder of his time in the Third Regiment of the Virginia Line, only; just before discharged was sent from Philadelphia under Colonel Webb to convey Prisoners to Fredericktown in Maryland, and was discharged by Col. Webb there.

Made an Original declaration on the 26th day of August 1818. And received Pension Certificate No. 5357 dated 18th January 1819.

And I do solemnly Swear that I was a resident citizen of the United States, on the 18th day of March, 1818; and that I have not, since that time, by gift, sale, or in any manner, disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provision of an act of Congress, entitled, "An act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary war," passed on the 18th day of March, 1818; and that I have not, nor has any person in trust for me, any property, or securities, contracts, or debts, due to me; nor have I any income other than what is contained in the schedule hereto annexed, and by me subscribed.

On Mare, one cow and calf, three small hogs, one plough, two old axes, two old hoes, one pot, one oven, one saddle, one bridle, one pair plough Gear, one set of earthen plates, two mugs, two bowls, three knives and forks, three chairs one Jug & one bottle;

This Deponent saith that by means of a wound he received in his back in the Revolutionary war and his age he cannot follow his occupation as a farmer to do much, towards his support. Son **Reuben about 16** years old & **Lewis aged 14 years** who ought now to be sent to school and that he hath no other children living with him and his **wife is dead**.

And that he is hardly able to maintain himself in the most humble situation. And but for the assistance he gets from his friends and neighbors could not keep house at all.

Sworn to and declared on the 26th day of October 1820 before **Abm. Nott**, Presiding Judge. **William Day**

Witnesses: William Cox and James D? Satterfield before Joseph Grisham, Notary Public. 26 Oct 1820. Schedule is worth \$54.27 ½. Filed 26 Oct 1820

Revolutionary War Pension John Powell 25 Oct 1820

The State of South Carolina Pendleton District

On this Twenty Fifth day of October 1820, personally appeared in open Court, in the Court of General Sessions of the Peace Oyer and Terminer Assize and General Gaol Delivery for the said District in the State aforesaid, being a Court of Record **John Powell** aged Seventy one years, resident of Pendleton District in the said State, who, being first duly sworn according to law, doth, on his oath, declare that he served in the Revolutionary war as follows:

That he Enlisted at **Greenbrier in Virginia** in January 1775 under **Captain Matthew Arbuckle** of the Twelfth Regiment Commanded by **Colonel John Nevelle** of the **Virginia Line** for Three years, Served Two Years & Six Months, and then hired a Man to served the other Six Months; and was discharged at **Winchester in Virginia** in June 1777 by **Colonel James Wood** – lost his discharge—

made Original declaration as well as he recollects in January 1820 before **Chancellor Waddy Thompson** of **Greenville District South Carolina**, has not as yet received a return of his papers or Certificate. And I do solemnly Swear that I was a resident citizen of the United States, on the 18th day of March, 1818; and that I have not, since that time, by gift, sale, or in any manner, disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself with the provisions of an act of Congressed, entitled "An Act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary War," ____ on the 18th day of March, 1818; and that I have not, nor has any person in trust ____ securities, contracts, or debts, due to me; nor have I any _____ contained in the schedule hereto annexed, and by me ____.

Has no property except his wearing apparel, one bed & bedding about ten years ago he give up his property to settle his debts, has no owned any thing since; & is much affected with pains & cannot ride on horse back. By occupation a farmer, but cannot labour, to follow it, -seven in the family viz:

Wife **Polly** aged Fifty nine years not able to do much, **David Powell**, aged twenty seven years, **Thomas Powell** aged twenty five years, **Nancy Powell** aged twenty one years, **Elizabeth Powell** aged nineteen years, **Sally Powell** ages seventeen years, his sons are able to Labor & own a piece of poor Land which they work and do maintain the said John Powell. They own no slaves and but little other property, and the said **John Powell** saith he is Supported by private charity by his sons.







Searching for Thomas Jasper Davis and Mary Moore Davis

Editor's Note: This request for information was submitted by OPD member Barbara Clark on behalf of Ila Sosebee Lark. Information in this story came from "The Anderson Intelligencer" newspaper articles.

This is an inquiry from a Find-A-Grave member, who would like to find out where Thomas Jasper "Jap" Davis and Mary Moore Davis are buried. She thinks that Mary Moore Davis is buried at Mt. Pisgah in Anderson County and my research indicates that Jap Davis is possibly buried in Piercetown.

Barbara Clark

From IIa Sosebee Lark:

Benjamin F. Moore was my husband's great-grandmother's brother. Her name was Mary Moore and she was married to a man named Thomas Jasper 'Jap' Davis. The couple had four daughters and two sons.

It seems that Mary worked and raised the children. Her husband began showing what she thought was mental instability. He tried to kill himself with some sort of poison. Negligence of the children crept in and Mary, herself, suffered physical and mental abuse. She had him committed to the State Hospital for the insane. They released him after a short time with a diagnosis that he was not insane, so he went back to his family.

Things got worse. He wouldn't work at all. The abuse continued. Mary told him they should go their separate ways and she would continue to raise the children. He did leave for awhile but returned. When she refused let him live with the family, he said he would kill her.

She and the children began staying her brother, Benjamin and his young family at night, walking about quarter of a mile to their home in the mornings.

On a Friday in September, he stole a double barreled shotgun from his brother-in-law named Owens. That night, he paid Benjamin a visit asking to speak to Mary about reconciling. Benjamin told him he had hurt her too much but he could talk to her in the morning.

Davis went into the woods where he had hidden the gun, then ambushed her and the children as they were walking home from her brother's house. He shot her from the cover of the woods. Mary was struck in the head and face.

Mary was buried the next day. Eventually, her husband was taken into custody. Benjamin F. Moore went to the hanging at the court house in Anderson in spring of 1888.

Mary and Jasper's oldest daughter, Texiana, also spent time in the mental institution.

Their daughter, Lucinda, (Lula) grew up to become my husband's grandmother. History repeated itself, as it were, when she shot her husband and killed him in 1938 in Hall County, Georgia.

I know where Lula is buried. I know where the two youngest children are buried. A daughter, named July, hasn't been heard of since the 1880 census. A son, Theodore, went to the Spanish American War and was never heard from again.

Mary's parents were Augustus and Lucinda Moore. It would be great to know their burial sites. I don't know where Thomas Jasper Davis is buried. His body was given to someone named Leard Smith who was said to have been a brother-in-law.

Mary is said to have been buried at Mt. Pisgah. I created a Find A Grave memorial for her without a grave photo.


