President's Message:

Greetings to everyone! I want to further extend a warm welcome to our visitors at our last meeting, and I sincerely hope that all of you will be able to attend our upcoming meeting. Remember that October is Family History Month. Take time to help a friend or family member start work on their genealogy or take time to write down some of your favorite family stories. In my case the fondest and oldest memory I have is of seeing my Little Sister for the first time.

It was March 1988 and I was three years old. My Dad woke me up and dressed me in my Sunday best, and then placed me in our truck. I do not remember too much about the drive, for I fell asleep along the way. The next thing I remember is being taken out of the truck while holding my Dad's hand walking toward a large building. We proceeded to walk down a long white hallway and stopped in a room where my Mom was lying in a bed. I remember my Dad picking me up and placing me beside her on the bed. I was a little concerned about this, for I was not allowed to wear shoes on the bed at home. She hugged me and pointed to a basket against the wall. I was too short to look inside, but my Dad picked me up and I saw a tiny baby. It was my Sister!

I admit the story above is a little on the rough side, but now that I have written part of down I can go back and make some necessary corrections as well as add in some photos for around the time.

September Presentation:

At our last meeting our speaker was Nan Jones. She interwove her trip visiting the site of D-Day along with her Father's involvement on that momentous day in history. Most of the events she covered came from a report that her Father had written some days after D-Day. He detailed the various problems that occurred; in particular the issue of establishing and maintaining radio communication. As a former school teacher, Nan had the ability to grip us upon every detail as well as provided some interesting handouts and displays. One item in particular was very significant. It was a map that was given to her Father, and that only 200 copies were made at that time. A student brought this map to her attention, for he brought to her an article in National Geographic that discussed D-Day and had a prominent picture of the map. After the presentation various questions were asked. One person asked if her Father ever spoke about his time in the War. In short, like many men from that generation he did not discuss it. During the course of Nan's presentation, I remembered two messages from President Franklin D. Roosevelt and General Dwight D. Eisenhower.

President Roosevelt:

"They will need Thy blessings. Their road will be long and hard. For the enemy is strong. He may hurl back our forces. Success may not come with rushing speed, but we shall return again and again; and we know that by Thy grace, and by the righteousness of our cause, our sons will triumph... For these men are lately drawn from the ways of peace. They fight not for the lust of conquest. They fight to end conquest. They fight to liberate. They fight to let justice arise, and tolerance and good will among all Thy people. They yearn but for the end of battle, for their return to the haven of home..." General Eisenhower:

"Soldiers, Sailors and Airmen of the Allied Expeditionary Forces: You are about to embark upon the Great Crusade, toward which we have striven these many months. The eyes of the world are upon you. The hopes and prayers of liberty-loving people everywhere march with you...Your task will not be an easy one. Your enemy is well trained, well equipped and battle-hardened. He will fight savagely. But this is the year 1944. Much has happened since the Nazi triumphs of 1940-41. The United Nations have inflicted upon the Germans great defeats...I have full confidence in your courage, devotion to duty, and skill in battle. We will accept nothing less than full victory. Good Luck! And let us all beseech the blessing of Almighty God upon this great and noble undertaking."

The Jolly Side of the Family By Margaret McNab Gale

My mother died many years ago. Her death was devastating to my father, Robert F. McNab, Jr., and in order to relieve some of the pain of his loss, Dad and I spent a lot of time putting together a genealogy of his family. We really enjoyed this challenge and have reconnected with many of his Marlboro County kinfolk.

In recent years, I decided to delve into my mother's past. Mother's maternal side starts with my grandmother, who was named Ruth Moorhead, and was married to Joseph Patrick Grist. Grandmother was born in Cherokee County in 1897 on Halloween day. She died when I was very young, so I don't remember my grandmother at all; and, I don't have any photographs of her. But I was told she was from Gaffney, S.C. Dad and my mom's sister and I drove up to Gaffney one day to try and research mother's family. We knew the middle name of mother's maternal grandfather was Jolly; and we found out that the mayor of Gaffney was (and still is), can you believe it, Henry Jolly! We arranged to meet with Mayor Jolly, who used to be in the S.C. House of Representatives, and he turned out to be a very friendly fellow who we fully welcomed into our family!

My mother's sister passed away a few years ago, and her daughter started doing a lot of research on our Moorhead family. She told me that before coming to Gaffney, our Moorhead kinfolk lived in Anderson, S.C. This was quite a surprise to me. I contacted a friend of mine who attended Anderson College with me in the 1970's and is now a dean at Anderson University. (I guess he was destined to be a "dean" because his name is Dean Woods!) I emailed Dean and told him that I may have a connection to Anderson, S.C. I asked him if he had ever heard of the Moorhead family from that area. He told me that he had indeed heard of this family and that they were quite respectable and held prominent positions in the Anderson community. Along with Mayor Jolly, our family tree seemed to be growing in the right direction!

While researching Anderson, S.C. on the Internet, information on Pendleton, S.C. also kept popping up. My parents actually lived in Pendleton when I was born in 1954. Dad was a Clemson grad, and he did the electrical design for many textile mills in South Carolina, Georgia, and North Carolina. He also had dated a girl from Pendleton during his college days; I remember him telling me her family owned a plantation in that area. I felt I had connections with the Pendleton District, so I decided to continue trying to find possible familial links with my upcountry family members in Pendleton and Anderson.

I didn't know much about mother's grandfather but I did know his name, so I typed it into my computer "Mance (with a 'c') Jolly Moorhead". My innocent Google search resulted in nearly blowing up my computer with information on a man named "Manse (with an 's') Jolly, Terror of Yankees"! Now, my mother was a very religious person, and at one time she thought of becoming a missionary. How would she feel about being associated with a man who killed many "Yankees" AFTER the Civil War had ended! But my great grandfather's name, according to the Find A Grave memorial online website (www.findagrave.com) was spelled "Mance", not "Manse", as it is in the infamous Manse Jolly's name. I thought that the similar names were just a coincidence, but further research on Manse Jolly on Wikipedia (en.wikipedia.org) stated that his father's middle name was actually MOORHEAD!

I recently attended a conference of the S.C. Genealogical Society that took place in Edgefield, S.C., and I was talking to some of the well-informed genealogists from the Pendleton District. They tried to convince me to go forth with great courage and pursue the history of my kin, regardless of where that path may lead! I gave their opinions a lot of thought, but I'm not sure I need to delve much further into this "Jolly" side of my family!

New Road Will Open New Country

A staff correspondent of the Greenville Daily News recently visited Pickens County and wrote the following article about the Pickens-Brevard highway for his paper. It was published in the *The Pickens Sentinel*, on September 8, 1921.

One of the richest and most picturesque sections of South Carolina is soon to be opened to the outside world with the construction of the road through Eastatoe Gap connecting Pickens and Brevard.

The highway commission of Transylvania County this week informed County Supervisor J.T. McKinney that the North Carolina County would meet the road already started by Pickens County thus giving a top-soiled road thru the mountains.

Until this week no assurance had been received from North Carolina authorities that they would complete their part of the road, although the Pickens County officials were acting under that assumption. Had the North Carolina County not been willing to cooperate the object of the road would have been defeated and the new highway would have been of local benefit only.

As matters now stand, when the highway is completed it will give a through route from the lower part of the state to Western North Carolina. Lake Toxaway will be approximately 60 miles from Greenville by way of Pickens.

But of even more importance than the construction of a highway connecting the states of North and South Carolina is the development of a section of the state which long has been held back because of poor road facilities. This not said in a sense of reflection upon any of the officials of this county or of Transylvania, but it is a known fact that this section has never seen the kind and type of roads with which other sections have been blessed. The few roads in the mountains were poorly laid off, for the most part, and very often could scarcely be traveled because of mud.

The route, taken through the Blue Ridge mountains is the same surveyed many years ago for the Cumberland railroad, which it was proposed to build through the mountains to Knoxville. The survey was made before the Civil War and many other surveys have been made since that time but the route chosen by the original surveyor, whose name is unknown to the majority of present day residents of Pickens County, has never been improved upon. It called for the crossing of the Blue Ridge mountains by the Eastatoe Gap route and more than a half century later civil engineers selected the same route.

To Brevard 30 miles

The distance from Brevard to Pickens is slightly more than 30 miles, 22 of which are in Pickens County. The first eight miles of the route from Pickens has been put in good condition except for **two bridges over the**Twelve Mile Creek.

For beauty of scenery the new route cannot be surpassed in South Carolina. It opens up a country comparatively new, and where the picturesque beauty of the mountains has not been destroyed by advancing civilization.

Mount Pinnacle, the highest point in South Carolina, is in plain view from the new highway but the engineers very carefully avoided its steep sides, the roadway winding about through the adjoining valleys. While Mount Pinnacle is comparatively well known throughout the rest of the state, not so in this section. Not one inhabitant in ten in Eastatoe township knows Mount Pinnacle by that name. It is known locally as "Bald Rock" or "Bald Knob," because of the barren, rocky surface on the southern and eastern side of the mountain.

The fertile Oolenoy valley is to the right of the new highway and it is thickly populated by industrious people. The **head waters of Twelve Mile Creek** are also crossed while some of the tributaries of Saluda River are but a short distance away.

Eastatoe township has one distinction which perhaps no other township in South Carolina can claim. There is but **one family of Negroes in the entire township** and, as might be expected, there are **no families of foreign birth**. The population is 100 per cent American and the majority of them can date their ancestry back to the days when **Daniel Boone would sling his rifle across his shoulder and come a visiting his kin hereabouts.**

Mayor C.L. Cureton, of Pickens, who accompanied this correspondent over so much of the new highway as has been completed, is enthusiastic as to the possibilities of the new highway. It will mean much to Pickens and Pickens County, he thinks, but most of all he is glad of the opportunity it will give the residents of the Eastatoe section to have easy communication with the outside world.

The road should be completed before next summer and unless all indications are wrong many tourists will next year enter the Sapphire Country by the Eastatoe Gap Road. Source: *The Pickens Sentinel*, September 8, 1921.

Gant, Esquire and not answering to receive but after that came forward and bound himself in recognizance to answer to the sentence so left. Which was three weeks imprisonment and twenty dollars fine.

State vs. Thos. Bryce. Received of William L. Keith ten dollars in full of my part of the fine as informer against the said Brice. Daniel/ his x mark/ Burkett. November 7, 1831.



Labor of Love!

When I moved to Seneca in 1999, I was presented with the opportunity to manage the Oconee County SC GenWeb Homestead. GenWeb is a world-wide, non-profit, Internet organization that focuses on the posting of information for on-line genealogy research via a Personal Computer. Since January 1999, over 114,000 people have visited my Oconee WebSite. This Homestead has now grown into the largest that this organization has to offer! This was done with the help of volunteers from Alaska to Florida, from California to Virginia.

Not many of us have the physical and mental fortitude that it takes to stick with a monotonous project for over 20-years. Fortunately for Oconee County genealogy researchers, Ann Rogers of Walhalla was equal to that challenge! (Many people laughingly refer to her as the Queen-of-Compiling!)

Since the early 1980's, Ann Rogers has been visiting Oconee County cemeteries and recording their tombstone inscriptions - for approximately 250 cemeteries with 35,000 tombstones! Not only did she write these inscriptions down on paper, but she then typed the information on 35,000 index file cards! The Walhalla Library now has the cards in their Genealogy Department holdings. Why? Ann simply wanted to help preserve "the memories of love ones." The tombstones of our ancestors, have always meant to be lasting memorials to the lives of those gone before us. However, these tombstones are suffering the ravages of time, weather and vandals. These grave markers are becoming more & more difficult to read as time passes, and some have already faded to the point that deciphering them is next to impossible. Fortunately, many are still legible. But, of those we can read today, how many will still be legible in another 50 years? This was the driving force that kept Ann going.

When I physically saw the horrendous amount of index card work that Ann had done, I was determined that it just had to be electronically preserved, and I could do that by means of the GenWeb Tombstone Inscription Project.

I posted a Message Board call for typing help, and Jennie Boggs of Central responded (she didn't know what she was getting into!). I then contacted Bob McCall at the Walhalla Library and stated that I had wanted to electronically preserve Ann's work (with her blessing), and that I would like to borrow his index card file drawers. Well, 1.5 years later, Jennie Boggs is still typing fast-as-ever, and the project end was in sight. Then I put out another call for typing help and Tracy Bergeson, Rudy Northdorf, Vivian Parkway, Carolyn and Rachel Smith responded. With their extra help, the project was completed in 2 years.

After Ann completed her monumental tombstone task, she decided to document 100-years of published Keowee Courier newspaper announcements (birth, marriage, divorce, etc.)! Thanks to Ann, the Walhalla library now has a file of over 90,000 index cards on this subject! At this point-in-time, Ann purchased a Personal Computer and inputted all this information into a word processing document - along with typing up the index cards. Unfortunately, Ann did not know how to backup her datafile to floppy disks - and wouldn't you know it, her PC's hard disk crashed -- PC-101: Backup, Backup, Backup, Backup & Backup your important data files on a regular basis.

Ann's old XT style PC sat on top of her desk for many years collecting dust. While visiting Ann one day, I saw it sitting there. When I asked about this classic PC, she told me her sad story. How sad it was, because we're

talking about losing the info on over 90,000 index cards - that's a 105' high pile of cards! I took a chance and asked Ann if I could have the PC. "Take the darn thing", Ann shouted. Take it and I did!

I immediately went to see Casandra Simpson, who then owned the WerBAC Computer Company in Seneca. Her Geekness relieved me of the old classic, and promised to give it an electronic enema. What came out, was shockingly, 50% of Ann's work that I really thought was lost forever! I'm happy to say that this "restored information" is now available for on-line researching. However, the lost information will probably never be retyped, because it's just too large of a task for just a few people to do.

As of Apr-2005, the Oconee Homestead contains over 40,000 tombstone inscriptions, 20,000 Keowee Courier personal notices and 2,500 church/cemetery images.

Thank you Ann Rogers for helping to preserve Oconee County's rich heritage!

Here's a citation that places Samuel Frazer in Pendleton District in 1811.

A quit claim deed, Esther (x) McCoy alias Fraser, James Harvey Fraser, Polly (x) Fraser, John Humphrey Fraser, & Levina (x) Fraser, all of Mecklenburg, & Samuel Fraser of Pendleton Co., SC, all heirs & legatees of Joseph Fraser decd, to Isaac Fraser, also an heir & legatee of the sd Joseph, four tracts on Rocky River containing in all 1178 A viz: [1] 623 A on the south side of John Davis' Cr being the tract granted to John Long 27 Nov 1795 and deeded to the sd Joseph Fraser; [2] 225 A being the originally a grant to John Long and deeded to Joseph Fraser; [3] 230 A adj John Davis being the land granted to James Gardner 13 Nov 1795, Grant No. 1300; and [4] 100 A being the land bequeathed to Joseph Fraser by his father James Fraser 15 Oct 1787 [see WB-C, p 69 & BHH p 23] and being part of 259 A deeded to Joseph Fraser by Abner Nash. John McCoy, husband of Esther (Fraser) McCoy, freely allowed his wife to sign the within deed but barred himself from any costs related to the deed or to share in any benefits therefrom. Wit: Lucy Alexander & J. McK. Alexander, Jurat. Proven at Nov Court 1811, test Isaac Alexander, CMC. Reg 27 Jan 1812.



All SCGS Chapter members are invited to attend. Registration is not required.


