

#### 1868 – 2018 Pickens-Oconee County Sesquicentennial Articles from Keowee Courier Newspaper January 1868



January 4, 1868. Methodist Conference Ministers. Greenville District – A.B. Stevens, P.E. Greenville Station – Robert Harper Greenville Circuit – J.J. Workman Reidville – Wm. Bowman Pickensville – J.M. Carlisle Keowee – J.L. Stoudmire Walhalla – to Be Supplied Seneca and Tugaloo – R.R. Dagnall Anderson – S.A. Welber Anderson Circuit – W.A. Hodges Pendleton – G.F. Round

January 4, 1868, p.2. The Commissioner in Equity will sell at Fort Hill, on Thursday the 9<sup>th</sup> day of January, instant, the residue of the desirable Personal Property of the late A.P. Calhoun.

Advertisement: Floride Calhoun, T.G. Clemson, Administrator vs. M.M. Calhoun, et. al. Bill of Foreclosure, Account, Relief, &c. Under Decree of the Court of Equity sell to the highest bidder, at Fort Hill, on Thursday, 9<sup>th</sup> January, 1868. The remainder of the Personal Estate of the late Andrew P. Calhoun, deceased, consisting of Elegant Household Furniture, &c. Namely: \$3,000 Stock in Blue Ridge Road; Beds Bedsteads and Bedding, fine Bureaus, Sideboards, Tables, Sofas, Settees, Carpets, Arm Chairs, Rocking Chairs, Parlor & Plain Chairs, One Gold Watch, Silver, pure and good; Glassware, China, Crockery, Knives & Forks, Kitchen Furniture, and various other articles too tedious to enumerate. Also, the Library of the late Hon. John C. Calhoun, very valuable. Cash. Robert A. Thompson, C.E.P.D. December 23, 1867

January 4, 1868, p. 2. Col. J.R. Edie, our new post commander and who was formerly stationed at Salisbury, NC, is thus spoken of by the "Old North Station," published at that place: "Just and impartial in the discharge of his duties, his conduct as commander of the post at this place has met with the general approbation of all parties." We hope, however, that the duties of Col. Edie will be light, assured as we are, that the people of this section, knowing well their duty, will perform it, without recourse to the military authorities.

January 4, 1868, p. 2. Pickens Female Seminary. This institution will be opened on the first Monday in February next, at Walhalla, under the care and superintendence of first class teachers.

January 4, 1868, p. 2. The State Convention. The Charleston Courier [newspaper] learns from a reliable source, that the total official returns give a majority of a little over 8,000 for a Convention, and that General Canby, in a day or two, will issue his order for the assembling of a State Convention in that city, on the 24<sup>th</sup> of January next.

January 4, 1868, p. 2. Decisions of the Court of Errors. *The Greenville Enterprise* [newspaper] learns from a distinguished member of the bar, who was in attendance upon the Court, that the following legal principles were decided by the Court of Errors during its recent sitting in Columbia.

- 1. The Statute of Limitations was suspended by the Stay Law in South Carolina.
- 2. The ordinance of the Convention allowing parties to prove what was the consideration and value of all contracts, during the war, is not in violation of the United States Constitution, nor does it impair the obligation of contracts.
- 3. It is not in violation of the Constitution of the United States for the District Courts to try criminals without a presentment of a Grand Jury.
- 4. The Tax Collectors are not compelled to receive the bills of the Bank of South Carolina in payment of taxes.
- 5. That slavery was not abolished at the date of President Lincoln's Proclamation, but ceased to exist when the State was captured.
- 6. Express Companies are liable to be taxed on their income.

7. The tax on National Banks, and the validity of Negro debts, were postponed. The Court decided that the Columbia and Augusta Railroad might cross the South Carolina Railroad in Columbia. But the case was retained for a compromise between the two companies in regard to the crossing and other matters. The question of the validity and constitutionality of the organization of the juries under Military Orders was argued in the Court of Appeals, but no decision has yet been announced.

January 4, 1868, p. 2. The Amended Reconstruction Bill. ... Be it enacted, That so much of the fifth section of an Act passed March 23, 1867, entitled, "An Act supplementary to Act to provide for the more efficient government of the rebel States," passed March 2, 1867, and to facilitate their restoration, as requires, that a majority of all the registered voters of the district shall be east in favor of the ratification of the Constitution before it becomes valid be, and the same is hereby so far modified that a majority of the votes cast at the election for the ratification or rejection of the Constitution shall be considered as valid and as affirming or reject said Constitution....

January 4, 1868, p. 3. Married on the 31<sup>st</sup> ultimo, by Judge Wickliffe, at the residence of the bride's father, Mr. John Holden, of Georgia, to Miss Mary Emaline, eldest daughter of Capt. R.F. Morgan of Pickens.

January 4, 1868, p. 3. Married on the 25<sup>th</sup> ult., by J.E. Bellotte, Esq., at the residence of Henry Keasler, in Pendleton Village, Mr. Jas. E. Addis, of Pickens, to Miss M.A. Keasler.

January 4, 1868, p. 3. Married on the 17<sup>th</sup> ult., by Rev. W.B. Singleton, Mr. W.T. Bowen to Miss Rebecca Allgood, both of Pickens.

Studies, English and Classical. Two cents per day extra charged for day scholars. Academy situated six miles below Walhalla on the Blue Ridge Railroad. W.T. Cleveland. Published in paper beginning 12 Dec 1867.

January 4, 1868, p. 3. Pickens Female Seminary. Establish a Female Seminary at Walhalla. Opened for Boarders and Pupils on 1<sup>st</sup> Monday in February 1868. Apply to Rev. F.M. Morgan at Walhalla or to Rev. Fletcher Smith, the Minister in charge of the Walhalla Circuit. "The large and commodious building known as the American Hotel, is now being fitted and prepared for the reception of boarders and pupils, and every arrangement will be made for their health and comfort." Two lunatics at the asylum, one at home, who will probably soon have to be remanded to Columbia. The latter was brought home by the advice of the Superintendent, who considered her convalescent, and thought that the presence of her family and friends, of whom she often spoke, might restore her to perfect sanity. It is understood, however, that after a trial of several months, she is at this time in no better condition than when she left the institution.

Principal indebtedness for support of pauper lunatics amounts to something over \$700.

That is sufficient of corn and nearly enough of meat, have been produced on the farm.

The clothing of the paupers is also made on the premises.

Buildings at the Poor House are in good condition and a double-cabin has been erected for colored Paupers.

#### James Mansel Ferguson The Old Ferguson Home in Pickens County Foot of Glassy Mountain – Near the County Line to Greenville Typed by G. Anne Sheriff

Over in Pickens County where the Blue Ridge skirts South Carolina and has already broken into foothills, not far from Highway #29, there nestles an old gray farm house, facing south. There are great oaks at the picket gate, from which the wide sandy walk was laid at intervals with steps of stone, and five great granite slabs form the flight of steps leading to the square portals of the wide vine-clad porch.

On each side of the walk, there once were boxwood, lilacs and myrtle, Spanish bayonet, narcissus, white and purple iris, in fact almost every growing plant know 150 years ago, for it was considered nothing to drive 20 miles for some new plant or another old shrub not in that beloved old-fashioned garden.

Walking across the wide porch upheld by large pillars one entered the so-called "big room" as large as all the rest of the downstairs, and the great comfortable fireplace flanked on either side by windows. Two small bedrooms opened from the opposite wall and another of same sized opened from the porch. The dining room and pantry ran clear across the back alongside the back porch. There was one large room upstairs. The interior was sealed with plank stained walnut.

The massive furniture, such as cupboards, four posters and dressers, were of foreign make, the others were made at home by the slaves from walnut trees that grew on the farm. Some of these became very skilled workmen and their work is exhibited with real pride unto this day.

Mr. Ferguson owned Glassy Mountain and about 2,000 acres of land; he scarcely knew his boundaries and much land was uncultivated. Image a man of 5 feet 10 inches tall, slim and athletic figure, erect and vigorous, with cold-blue eyes, very direct, deliberate in every movement and a manner which gave confidence, such a man was Mr. Ferguson, "The Judge" as the Negroes still called him, for they gave it to honor him, not as a title.

But Mr. Ferguson was more, he was a man of simple faith and absolute uprightness of character, very determined as to right and wrong, inclined to independence of thought, with a very philosophic mind. He read every word of his three weekly papers, the Pickens Sentinel, the Baptist Courier and the Atlanta Constitution. And his granddaughter who gave this from her uncle's pen, adds – "I know he was never vexed with me. I never saw him vexed with anyone or out of patience."

There was very little money on the farm and money was about the only thing which there was not an abundance. But often he sent a wagon load of provisions to a needy family in or beyond the mountains. One small room, more like a large closet, has not yet been mentioned, this was the wine room on the front porch. There were always good wines in it, and the "old Marster" knew good wine, but he was not a drinker, he may have had his little wine glass before each meal, but as for drinking, no, at in his home!

One of the great celebrations was the "corn shucking", when the few neighbors would come over and all of the Negroes on the farm, the visiting friends would bring sometimes five or six men and women to help in the great shucking, for there was the great pile of corn, some 50 or 60 feet long, all waiting for the signal to begin.

Then when all was finished, Uncle Gabriel again sounded his horn and the great feast was served to all. Old Hannah and Big Hannah serving the colored people and it was a great time of joy, for when supper was over, all of the Negroes danced in "Massas yard" until a late hour when all the Negroes would go to make their curtsey and say good night to "old Massa" and "old Miss", as only plantation Negroes could.

And this happy picture gives a glimpse of the old slaves who were so happy for "Massa" took care of them fed them and clothed them.

The Nationwide Gravesite Locator includes burial records from many sources. These sources provide varied data; some searches may contain less information than others. Information on veterans buried in private cemeteries was collected for the purpose of furnishing government grave markers, and we do not have information available for burials prior to 1997. The Arlington National Cemetery provides information on service members buried in overseas cemeteries.

The U.S. Geological Survey (USGS) National Geospatial Program is scanning published USGS 1:250,000-scale and larger topographic maps printed between 1884, the inception of the topographic mapping program, and 2006. The goal of this project, which began publishing the historical scanned maps in 2011, is to provide a digital repository of USGS topographic maps, available to the public at no cost. For more than 125 years, USGS topographic maps have accurately portrayed the complex geography of the Nation. The USGS is the Nation's largest producer of printed topographic maps, and prior to 2006, USGS topographic maps were created using traditional cartographic methods and printed using a lithographic printing process. As the USGS continues the release of a new generation of topographic maps (US Topo) in electronic form, the topographic map remains an indispensable tool for government, science, industry, land management planning, and leisure.
