The Chapter meets every month, except July, August and December. Meetings are held on the third Tuesday of the month from 7 to 9 p.m. at the Central-Clemson Library.

The Chapter's genealogical and historical archives are housed at the Clayton Family History Center, located in the lower level of the Rickman Library on Southern Wesleyan University campus in Central, SC. This collection contains about 3,500 books and files on family histories, state and county sources, military histories, cemetery records, immigration and passenger lists. Keowee Courier Newspaper, January 11-February 1, 1868

Abstracted by G. Anne Sheriff



January 11, 1868, p. 1. Calling for new Constitutional Convention

At the election held on November 19-20, 1867 the SC voted on the question of holding a convention. Therefore, "delegates elected thereto, in conformity with the provisions of the fourth section of the Act of Congress of March 23, 1867, to assemble in convention in the City of Charleston, South Carolina, at noon, on Tuesday, the 14th day of January, 1868, for the purpose of framing a constitution and civil government according to the provisions of the aforesaid act. . . "

STATE OF SOUTH CAROLINA, Pickens District, September 5, 1865.

January 11, 1868, p. 2, col. 2. The editor of Keowee Courier, after 15 years, resigns or turns over the paper to Mr. Robert Young, a resident of the state.

January 11, 1868, p. 2, col. 2. Commissioners of Boards levied a tax of 75% on the State tax; for the Poor, the Commissioners levied 16 and 2/3 cents; and for Public Buildings, 5% was levied. Making, altogether, 96 and 2/3 cents on the general tax.

Some portions of it will be agreeable and acceptable to the people, whilst other parts will, doubtless, be indignantly rejected. The effect it produced on this assembly will, ere long, be disclosed."

February 1, 1868, p. 2, col. 1. Mr. William Murphy, of Greenville, will be in village to tune pianos.

February 1, 1868, p. 2, col. 1. Store of Mr. D. Biemann, of Walhalla, was robbed.

Delegate from Pickens yesterday in the Convention, that it was impossible to obtain a meal's victuals or a drink of whiskey at the Court House town of this District. (From Charleston Mercury Newspaper) Just a short reply from the editor of the Keowee Courier.

Charleston. January 28, 1868. Proceedings of the 1868 Convention. "An ordinance for the division of Pickens District was discussed and finally made the special order for Monday next, at 1 o'clock."

Charleston, January 24, 1868. "Before he had finished reading, the President announced that the hour had arrived for the consideration of the special order, namely, an ordinance for the divisions of Pickens District.

Dr. Johnson took the floor and warmly advocated the division of Pickens District. He describe [sic] the people, the country, its extent, its wants. He said it was a benighted place, and wouldn't improve until it was 'cut in two;' and when he got fifteen miles beyond the Court House he couldn't find a decent meal of victuals or drink of whiskey. It was essentially in need of reconstruction in a practical sense, and the people generally agreed with him that, to bring it out of the slough of Despond, some action like that proposed was needful on the part of the convention.

... After much rambling discussion, the further consideration of the question was postponed until Monday next, at 1 o'clock.

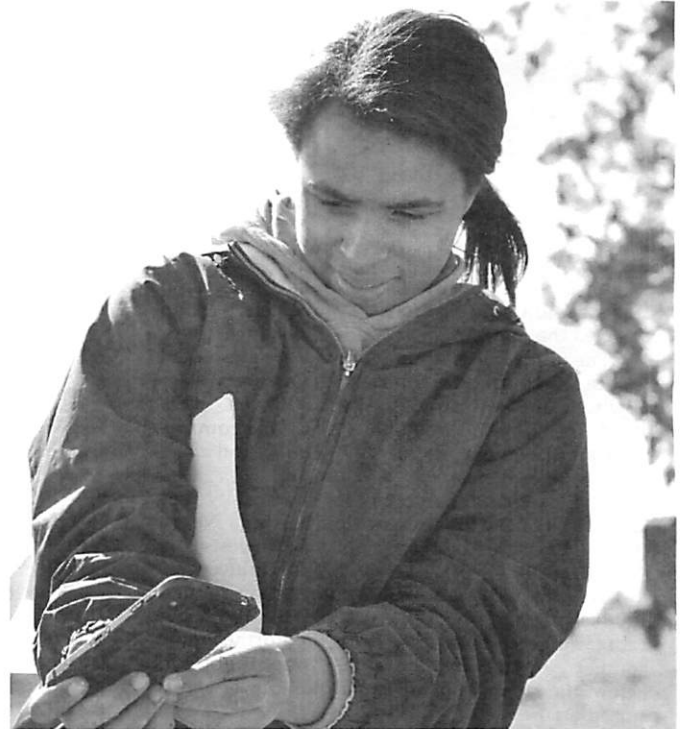

DIVISION OF PICKENS DISTRICT

An act of 1868 divided Pickens District into Pickens and Oconee counties. The eastern portion retained the name Pickens but had no place to go.

The following leading citizens were appointed to locate a courthouse for Pickens County: James Lewis, James H. Ambler, Reese Bowen, W.T. Field, J.E. Hagood and T.R. Price. This committee was appointed on July 27, 1868, and there their troubles began.

The geographical center of the county was found to be near the present Cold Springs Negro Baptist Church, about four miles northwest from the present town of Pickens. The committee went to work faithfully and spent many days in their saddles around the center of the county, while being watched closely by both the northern and southern areas. Since the center of population was below the geographical center, the lower area raised a row.

The committee went into a huddle for a while and then did a lot of saddle work below the center, and finally located on the Bethlehem Ridge where Hillcrest Memorial Park is now located. When the people of the northern areas heard about this they raised more than a row.

The committee went home in a very discouraged mood and stayed there a long time.

As time passed, nothing was done. People mixed and mingled, and talked a lot. A great many questions were asked and various speculations were made. Of course, the committee came in for a full share of criticism.

Finally, a prominent citizen, Elihu Griffin, who lived on his farm where the home of Mrs. Ann Christopher now stands on Ann Street in the present town of Pickens, played a major role in

settling the dispute. Owner of a great deal of land between Town Creek on the north and Wolf Creek on the south, he offered to let the committee have a site for the courthouse and the town.

The committee agreed, and as soon as the two belligerent areas came to a compromise, the committee began to lay plans for the courthouse site and a town.

In order to keep from building two bridges, one over Town Creek and the other over Wolf Creek, a circle with a radius of one-half mile was laid out with the center a few feet back of the new monument erected recently on the corner of the present courthouse lot.

East and west, north and south, lines were laid out passing through this center. With these four segments established, the citizens began to lay off roads. This batch of roads opened in the Griffin farm lands was called Pickens.

As soon as possible a small courthouse was begun at the crossing of the two lines and a small, wooden jail was built on a lot now occupied by the residence of Mr. D.C. Garrett. A farm was purchased on Twelve Mile River and cabins were erected for the use of the poor. Since then it has been known as the "Poor Farm."

Just as a great portion of Pendleton moved to Pickens on the Keowee, so now much of "Old Pickens" — a composition of Pendleton and Pickens, began to move to "New Pickens."

Several of the residences and a few of the business establishments were literally moved to Pickens. Each piece of the wooden building housing Masonic Hall at "Old Pickens" was numbered, moved to Pickens and re-erected.

The cornerstone, with contents intact, was stored in a locker room and many years later was laid in the arch over the entrance to the stairway between the Pickens Drug Store and the Sample Department Store. It is easily observed from the sidewalk.

Two other prominent "Old Pickens" houses were removed to Pickens. The Thornley Hotel that stood until a few years ago on the corner now occupied by Cantrell's Gulf Station, came from "Old Pickens." The home formerly occupied by Judge and Mrs. T.J. Mauldin near the present Winn-Dixie Store came from "Old Pickens."

We recall that there was not a manufacturing plant of any kind, more than a few saw mills, in the whole area of Pickens County. The nearest small line of railway was the Columbia and Greenville Railroad.

There were no schools except the few "old field" schools which were paid for by the more able community groups. They were open only a few weeks during the summer and were known as "lay-by" schools. (George E. Welborn)

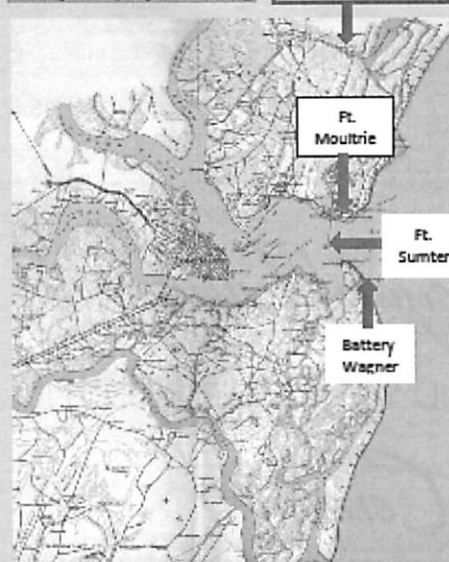

Follow the men of the 20th South Carolina Infantry Regiment from when they mustered in for SC service in 1861 until their surrender on April 27, 1865 at Greensboro, NC. The regiment was formed by Congressman and "Firebrand" Laurence Maselon Keitt of Orangeburg Dist., SC. From the beginning Keitt's ambition was to become a Brig. Gen. in the Confederate army but the President of the Confederacy, Jefferson Davis, blocked his way. After helping defend Charleston

from January 1861 until May 1864, including the early attacks on Battery Wagner, the regiment was ordered to Virginia and assigned to Brig. Gen. Joseph Kershaw's famous South Carolina brigade. The moment of truth came at the Battle of Cold Harbor where Col. Keitt was mortally wounded leading Kershaw's brigade in a disastrous frontal attack on June 1, 1864. The 20th SC Vols. would go on fighting during the siege of Petersburg and numerous battles in the Shenandoah Valley, including Cedar Creek. In early 1865, the regiment was ordered south to defend their home state



against the mighty army of General William Tecumseh Sherman. Unable to stop Sherman's army as it devastated South Carolina, the 20th South Carolina was surrendered to Sherman at Greensboro, NC as part of Gen. Joe Johnston's Army of Tennessee on April 27, 1865 after which the officers and men returned to their South Carolina homes. By James B. Clary. Published by Broadfoot Publishing Co. 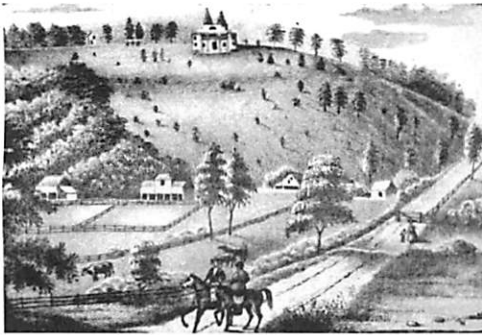
