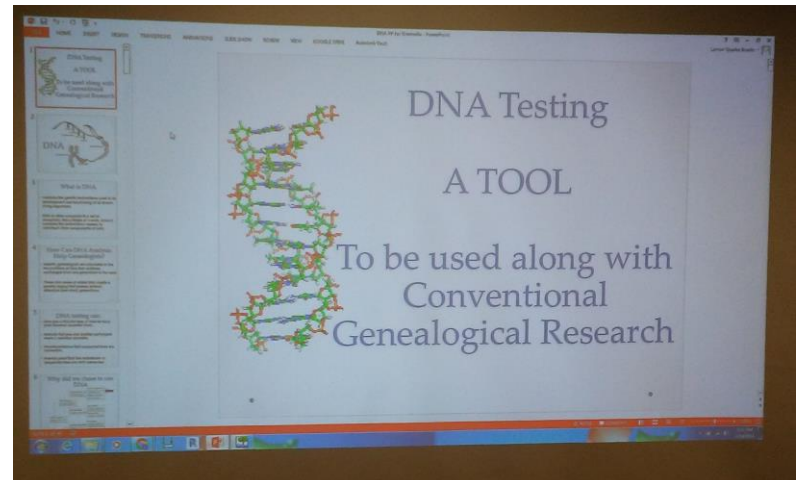

## Robert L. Perry Collection

**Rob Perry from Hanahan, SC donated the collection. He is the son of Robert L. Perry Jr. (1905-1981), the Berry Family and the Bowen Family from the Georges Creek Area in Pickens County. His father had “accumulated 108 acres which I [Rob] developed into the Heathwood subdivision during the 1980’s. My grandparents’ home and accompanying lands lay on the east side of Saluda Dam road between Prince-Perry Road and Georges Creek Baptist Church. Their property was sold out of our family after the death of my grandmother Olive Bowen Berry Perry (1877-1959.” Rob1960123@comcast.net**

Perry III wrote the following concerning the development.</p> <p><b><i>“My dad and I began the development of Heathwood in 1976. He and my mother had already built a retirement home theater in 1970.</i></b></p> <p><b><i>My Dad had owned this land for a long time (See deeds and plats) but most of it had previously belonged to my grandparents and extended up to their home facing Saluda Dam Road.</i></b></p> <p><b><i>After my father died in 1981 I continued the development which ultimately included 96 lots. I built most of the homes.</i></b></p> <p><b><i>My family and I built our own house in 1978 in section 1. My two sons were ages 2 and 6 at that time, and we lived there for the next 12 years.”</i></b></p>
Ca. 2005	(Copy) “Photo in recent years. After death of my grandmother Olive Berry Perry in 1959. The house and its adjacent land were old out of our family. About 2005 at a family reunion, the then owner graciously let us (about 40 folks) tour the inside of the house. It was the first time any of our family had been inside since 1959. Today the home is the parsonage for a church located near the Saluda Dam. Sorry, I can’t remember names regarding this.” Written by Robert L. Perry III

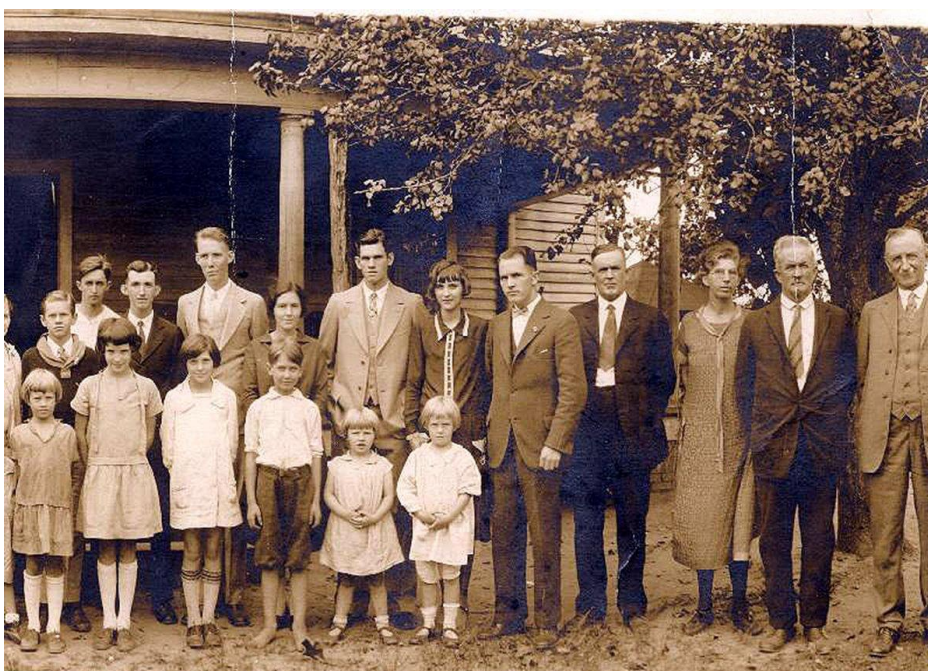

**The State vs. Joel Durham, James Thompson, Daniel Durham.** Indicted for Assault and Battery. Thompson, Solicitor. Daniel Durham, one of the defendants defends the case. Jury No. 2. All three are Guilty. "But we view a number of Paliating (sic) circumstances in favor of Daniel Durham and do recommend him to the clemency of the Court.

**The State vs. Austin Day.** Indicted: Aiding a Slave in running away. John Ferguson, Prosecutor. Thompson, Solicitor. B.F. Perry for Defendant. Jury No. 1. Not Guilty.

**p. 145 The State vs. Jeptha Norton.** Indicted: Assault and Battery. Thompson, Solicitor. Defendant pleads guilty.

**The State vs. Robert Fulleton, James Fullerton.** Indicted: Assault and Battery. Thompson, Solicitor. Both defendants plead guilty.
