

Judy introduced our speaker of the evening, Professor Tim Drake. Dr. Drake presented the group to the history and immigration of the French Huguenots. The first use of the term Huguenots was at the turn of 1520 to describe French dissenters within the Roman Catholic Church. They tried to "purify" the church before they left. There were eight bloody wars before peace was attained.

Between 1685 and 1700, an estimated 200,000 to 900,000 left France for other parts of the world... only 1,000 to 1,500 remained in all of France. New York, Virginia, and South Carolina were the preferred places for settlements in 1685-1710. In South Carolina most settled along the Santee River (known then as the "French Santee") and were successful in rice production. The Huguenots contribution was social, economic, agricultural and religious to the colony of Carolina.

Refreshments for the meeting were provided by LaMarr Brooks and Judy Long.

15 Jan 1869. p. 2, col. 1. The sale of Town Lots in Walhalla, advertised for the 18th, has been postponed until the 25th.

15 Jan 1869, p. 2, col. 1. The County Commissioners have divided Oconee into eight townships. The Surveyor is now engaged in preparing plats of the same.

15 Jan 1869, p. 2, col. 1. Jim Williams, alias Rafe, Colored, was arrested under charge of burglary. Sent to jail in Anderson.

15 Jan 1869, p. 2, col. 1. William Talbot, long time resident of Edgefield County, but more recently of Abbeville, surrendered himself to one of the deputies of State Constable Hubbard, as one of the murderers of the late B.F. Randolph.

15 Jan 1869, p. 2, col. 2. W.W. Stribling planted (1866) about %'s acre of poor new ground in tobacco and sold it for \$140 besides using it two years myself. The same land would not yield more than ten bushels of corn.

15 Jan 1869, p. 2, col. 2. (Columbia, Jan 11 1869). Tolbert, who is charged with the murder of Randolph and Martin, has been brought into the city on the evening train and lodged in jail.




