It was settled in 1784 by Capt. Benjamin Cleveland

Fair Play is a small farming community. The old school is now used as community center. The town is located near the Cherokee Trading Path and three miles from the Tugalo River. It borders Anderson County and has abundant creeks for trade.

Some of the resources used to write her book were *The Pendleton Messenger*, *Keowee Courier*, *Anderson Intelligencer* and the website: *Chronicling America* sponsored by the Library of Congress.

There are 34 unique surnames listed in her book, 395 pages and took six years to write.

Julia A. Holloway lived in Candler, NC and was born in 1852 in Greenville Co., SC. Both her mother and father were born in Greenville. (Volume 1, p. 49)

John H. Sutherland, a white man, testified in James L. McDonald case. His mother, Martha, said that Annie or Nancy Blythe was a quadroon or half-breed Cherokee Indian. Oo-sta-alle adopted Annie Barnes who married Jonathan Blythe. "My mother said that the Indians left Greenville after Annie Barnes' marriage and moved to Toxaway and then to the little Tenn. River." (Vol. I, p. 63)

James Lewis McDonald, son of Angus McDonald and Sallie Blythe, said he was a grandson of Annie Blythe. His mother was born in South Carolina near Old Choy Fields in NC but close to SC. (Volume 1, p. 66-67)

Martha Ann Meroney was granddaughter of Annie Blythe/Barnes. She was born in England. She came to SC with her father and mother and married Jonathan Blythe in SC. (Volume 1, p. 68)

Martha A. Hughes was daughter of Mary Ann Blythe, granddaughter of Johnathan and Annie/Nancy Blythe. Mother was born in SC. (Volume 1, p. 68)

Thomas C. McDonald is son of Johnathan McDonald and Harriett McDonald. "Heard it said that Annie/Nancy Blythe came from someone near Greenville, SC." (Volume 1, p. 69)

Sarah Jane Reece said her father Anderson Green Franklin was born in 1823 in SC. (Volume 1, p. 103)

Bettie Cecilia Ayres said her grandmother was born in SC. (Volume 1, p. 115).

Ned Sizemore probably came from SC. (Volume 1, page 127)

Martha J. Box said her grandparents lived in SC where her mother was born. (Volume 1, p. 176)

George W. Sizemore said a local man named Holmes who lived in Morgan County, told that he knew his great-grandfather Ned Sizemore in SC. (Volume 1, p. 177)

Mary C. Ernest said she was born in Lawrence Co., SC. Her mother, Harriet G. Adams, was born in Aug 1825 and married Squire Williamson in 1842 in Lawrence District. . Known as colored man but was three quarters white. William Bad owned "us" in slave days. (Volume 1, p. 185)

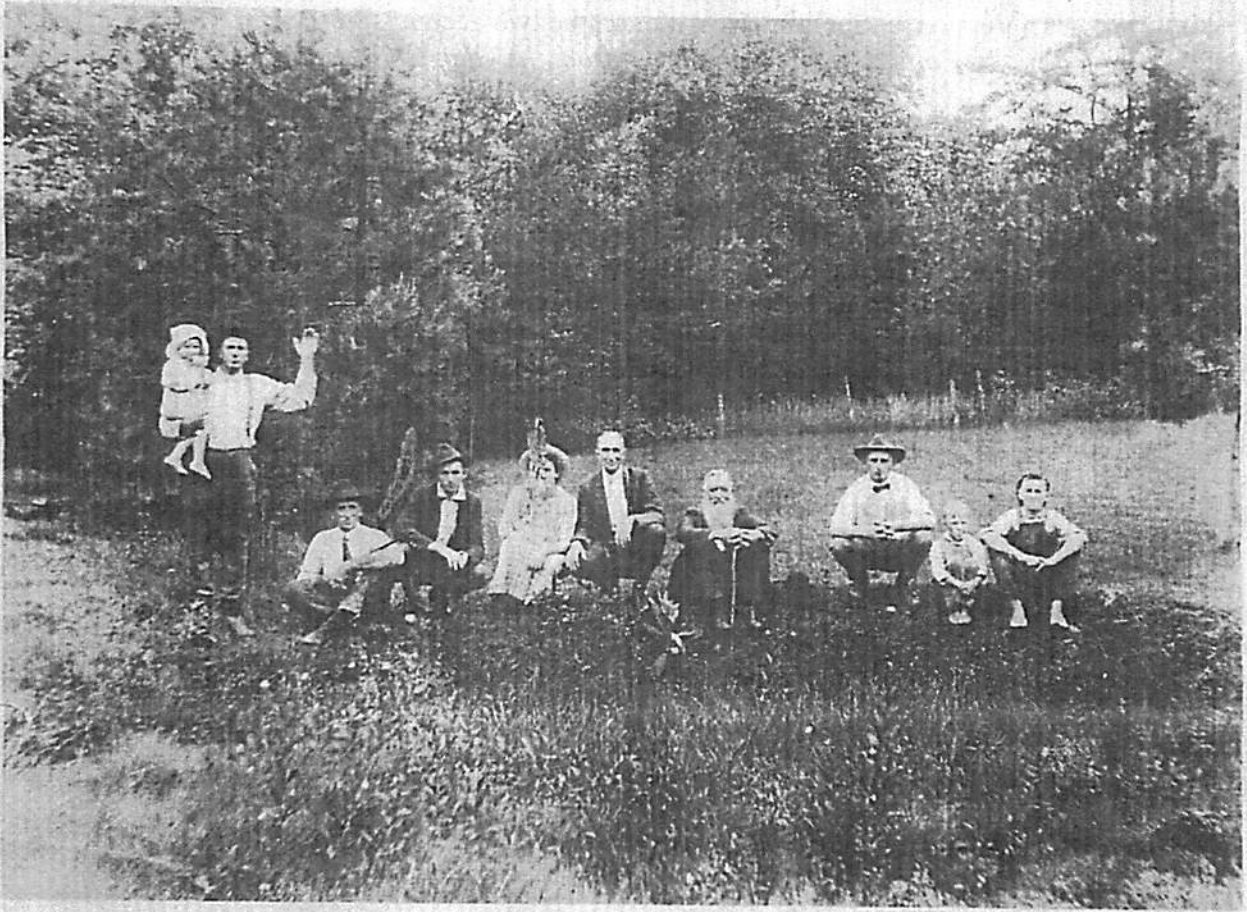
Rachel A. Higdon is the granddaughter of Jess George Campbell, who was born in SC. (Volume 1, p. 225)

Mark A. Cook, daughter of Zilpha Campbell, and granddaughter of Jesse/George Campbell, who was born in SC. (Volume 1, p. 226)

Robert Avery claims ancestry through his mother, Myrom Avery, who was born in Greenville District, SC and lived in Bibb Co., AL in 1851. Luke and Polly Crompton lived in Greenville District and were married in 1817 or 1818 according to Isaac Avery. (Volume 1, p. 284)

After considerable trouble in getting up and making necessary preparations for our party we left Pendleton for the Table Rock July the 18th 1871.

Our first point was New Pickens C.H. a distance of 20 miles where we arrived about 3 o'clock all as wet as downed rats as we were caught in a thunder storm not being sufficiently prepared for it.

We did not mind the wetting though, as we were on a pleasure trip and determine to have a gay time at all hazards.

Page 51-52.

We sheltered the Ladies under the hospitable roof of our friend Mr. James Hagood who treated us all very kindly and begged [p. 52] us to spend a day or two with him, but having the mountain fever on the brain we could not think of stopping short of the Table Rock.

So we were up bright and early the next morning the 19th making ready for a Continuation of our journey.

We left Mr. Hagoods about 6 O'clock and after a very pleasant ride of about 15 miles and arrived at the foot of the noted place Table Rock.

We put up with Mr. Keith the Hotel keeper where we found ample accommodations for our own party.

I forgot to mention in the beginning the number of the party

It consisted of 16 Ladies, 15 gentlemen and 1 child and 2 Colored Brethren on [p. 53] who attended to the wants of the party generally.

We arrived at the Hotel about 12 O'clock a M and after resting ourselves we spent a few hours very pleasantly twisting/tasting the fantastic often excellent music.

We retired our selves with sleep that we might be better prepared for the ascension of the Mountain the next day. 20th we were up and had breakfast and ready for our march by 7 o'clock.

We reached the summit of the mountain [p. 55] about 10 o'clock after a very fatiguing walk though it was attended with a great deal of fun and pleasure.

We first wended our way to the steps reviewing as we passed along the mighty works of nature by which we were surrounded.

Letter of Anne McCann at Equality to John M. Glenn in Pendleton. August 27, 1871.

“Our trip was quite a success arrived in Slabtown last night at 7 O’clock. The whole party enjoyed themselves hughly. We staid at Table Rock hotel three nights – my enjoyment would have been completed if my Johnnie had been there. I thought of you and wished you was there all the time we were having so much fun. Your absence was all that marred my pleasure. If I couldn’t see the original, I had something that looked very much like him. Dreamed about somebody too.

The grandener and sublimity of the mountain seen ___ for Ppurpose my descriptive powers. I can tell you better than write it. I am so near fainting when I started down the mountain. I turn sick and had to sit down and shut my eyes – my head became dizzy. West was escort and a very good one too so strong. I shall always feel under obligation to him for his kindness

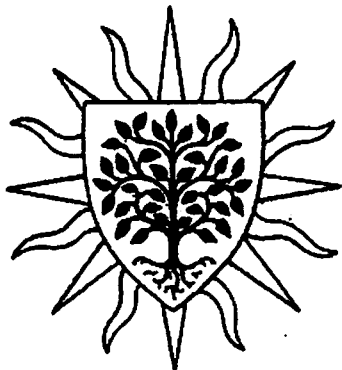

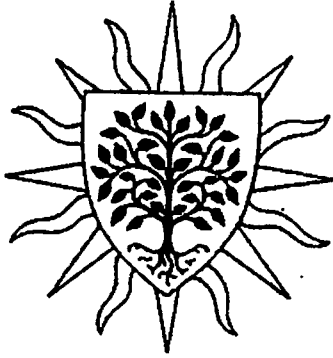

WHEREAS a genealogy group from Anderson, Oconee and Pickens Counties, meeting in Clemson, South Carolina, has petitioned the SOUTH CAROLINA GENEALOGICAL SOCIETY for membership as a constituent chapter and,

WHEREAS, pursuant to the By-Laws of the SOUTH CAROLINA GENEALOGICAL SOCIETY, a chapter charter may be granted by unanimous vote of the Board of Directors, and


WHEREAS the Board of Directors of the SOUTH CAROLINA GENEALOGICAL SOCIETY did vote unanimously on 19 June 1976 to admit to its membership the genealogy group named above as a constituent chapter,

NOW, THEREFORE, effective this nineteenth day of June of the Year 1976, said group is now a member in good standing with said Society and is, therefore, vested with all rights, duties and obligations accorded a constituent chapter pursuant to the By-Laws of the SOUTH CAROLINA GENEALOGICAL SOCIETY and henceforth shall be known as the

BY-LAWS

BY-LAW I
NAME

The name of this Chapter shall be "The Pendleton District Chapter of the South Carolina Genealogical Society."

BY-LAW II
CONSTITUTION

The basic governing statute of this Chapter shall be the current Constitution of the South Carolina Genealogical Society.

BY-LAW III
CHAPTER BY-LAWS

Sec. 1. MEMBERSHIP - Membership in the Pendleton District Chapter shall be by application. The application shall be submitted to the Chapter, which, after investigation and approval by a two-thirds vote, shall forward the name of the member to the South Carolina Society.

Institutions, Societies and Individuals within and outside the State of South Carolina shall be eligible to nonvoting membership in the Chapter on payment of annual dues.

Sec. 2. OFFICERS - The Officers of the Chapter shall be:

President
Vice-President
Secretary
Treasurer
State Board Member

Sec. 3. ELECTIONS - All Officers shall be elected annually by the membership. Said election shall be held on the day of the annual meeting. The term of office for elected officers shall be one (1) year commencing January 1.

Sec. 4. Board of Directors - The Board of Directors shall consist of the Officers of the Chapter. The retiring President of the Chapter shall be an ex-officio member of the Board. The Board of Directors shall have authority to transact the affairs of the Chapter during the interim between meetings. The current President and Secretary of the Chapter shall serve as Chairman and Secretary of the Board of Directors.

Sec. 5. MEETINGS - Monthly meetings will be held at 7:30PM on the third Tuesday Night of each month at a place designated by the Chapter. Meetings will be held Monthly, September thru June, with no meetings in July and August, unless desired by the membership.

The annual meeting will be held in November. At the annual meeting, the following shall be the order of business:

- A. Report of the Officers
- B. Report of Special Committees
- C. Unfinished Business
- D. New Business
- E. Election of New Officers

Sec. 5. Quorum - A quorum shall consist of Twenty-five Percent (25%) of the members in good standing at all meetings of the Chapter.

Three members of the Board of Directors shall constitute a quorum to transact the business of the Board meeting.

Voting on all questions coming before the Chapter shall be "Ayes and Nays" and shall be entered upon the minutes of such meetings, and a decision shall be determined by the majority of the votes of those present and in good standing.

Sec. 6. DUES - The annual Dues for membership in the Chapter shall be the annual dues for the South Carolina Genealogical Society. Additional Dues for Chapter operation shall be voted on by the membership.

Sec. 7 Committees - Committees shall be appointed by the President or Board of Directors as required for special projects.

A Nominating Committee consisting of three (3) members of the Chapter shall be appointed by the President to serve for one (1) year. The nominating committee shall report to the membership their proposed slate of officers at the October meeting prior to the election to be held in November. Members of the Chapter in good standing shall have the privilege of submitting additional nominees to be considered, at the October meeting.

The will leaves his land to his wife to raise children on. It does not state how many children or names.

We can find nothing more. Our questions are:

- 1) Who are the parents of Richard?
- 2) Who is Thomas that bought the land with Richard?
- 3) When did (if he did) Thomas sell his 1/2 tract of land
- 4) If Thomas sold his land when did he do so and where did he go? Not that I expect you to know where he went. I found a Thomas in Pulaski Co. but only found him that one year. I have no idea if it is him or not.

My husband has done his DNA and has matched with a Family in MO. They are related to a Robert Walters born in Pulaski County in 1813. We never heard of a Robert until the DNA match. Richards wife Polly married (in 1816) to a SNEED and moved to MO in by 1840. They are in that census.

We are trying to figure out who is the father of Robert. Since we cannot find any proof of who Robert's father is, I wonder if he could be the son of THOMAS. I think the DNA would be the same if Robert is a child of Richards or Thomas. (I think Thomas and Richard are brothers but again no proof) This is a total guess on my part.

Any help you can offer I would be grateful for and be thrilled to me have. I had a Les? in the Clayton Room/Pendleton Historical Commission look for information for me, but he could find nothing more that I already had.

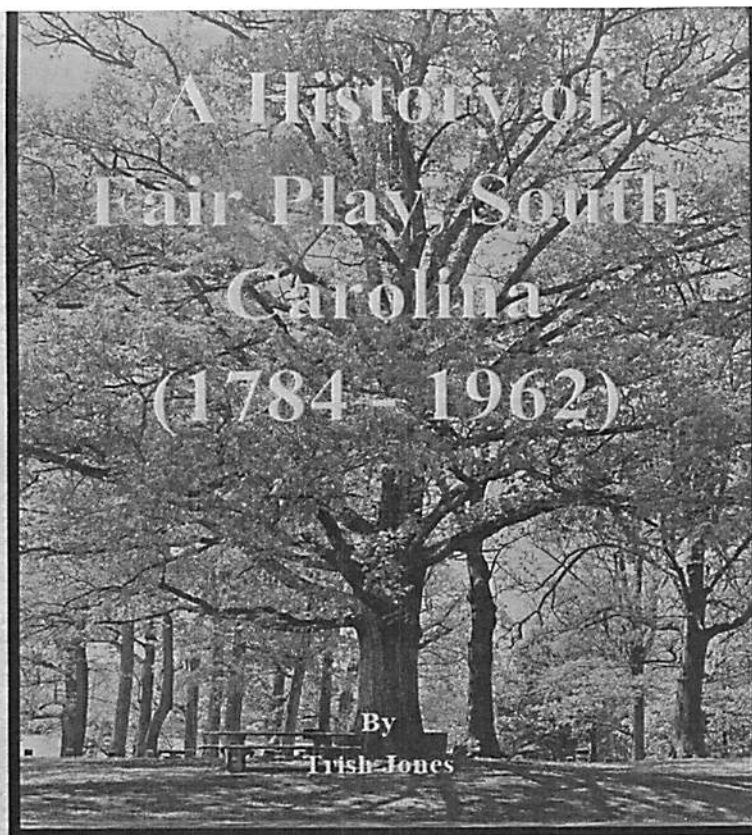
I know there are at least two Richard Walter/Walters in the area I have doc for them also but do not believe they are our Richard because of the dates of the documents.
