The Chapter's genealogical and historical archives are housed at the Clayton Family History Center, located in the lower level of the Rickman Library on Southern Wesleyan University campus in Central, SC. This collection contains about 3,500 books and files on family histories, state and county sources, military histories, cemetery records, immigration and passenger lists. 28 May 1869, p.1, col. 1.

- 1.If a man faints, place him flat on his back and let him alone.
- 2.If any poison is swallowed, drink a heaping teaspoonful each of common salt and ground mustard stirred into it; this vomits as soon as it reaches the stomach; but for, fear some of the poison might remain, swallow the whites of one or two raw eggs or drink a cup of strong coffee, these two being antidotes for a great number of poisons than any dozen other articles known, with the advantage of their being always at hand; if not, a pint of sweet oil, or lamp oil, or "drippings," or melted butter or lard, are good substitutes, especially if they vomit quickly.
- 3.The best thing to stop the bleeding of a moderate cut instantly is to cover it profusely with cobweb, flour and salt, half and half. (My grandmother **put suet from the flue** on my brother's cut (from an ax) when he was about 13 years old. [Anne Sheriff Story].
- 4.If the blood comes from a wound by jets or spurts, be spry, or the man will die in a few minutes, because an artery is severed; tie a handkerchief loosely around, near the part between the wound and the heart; put a stick between the handkerchief and the skin, and twist it around until the blood ceases to flow; keep it there until the doctor comes, if in a position where the handkerchief cannot be used, press the thumb on a spot near the wounded, between the wound and the heart; increase the pressure until the bleeding ceases, but do not lessen the pressure for an instant before the physician arrives, so as to glue up the wound by coagulation or cooling of the hardening blood.
- 5.If your clothing takes on fire slide the hands down the dress, keeping them as close to the body as possible, at the same time sinking to the floor by bending the knees; this has a smothering effect upon the flames, if not extinguished or great headway gotten, lie down on the floor and roll over and over; or better envelop yourself in a carpet, rug, bedcloth, (sic) or any garment you can get hold of, always preferring woolen.
- 6.**If the body is tired, rest; if the brain is tired, sleep.**
- 7.If the bowels are loose, lie down in a warm bed, remain there, and eat nothing until you are well.
- 8.If the action of the bowels does not occur at the usual hour, eat not an atom until they do act, at least for thirty-six hours; meanwhile drink largely of cold water or hot teas, and exercise in the open air to the extent of a gentle perspiration, and keep this up until things are right; this suggestion, if practiced, would save myriads of lives every year, both in the city and country.
- 9.**The three best medicines in the world are warmth, abstinence and repose.**

28 May 1869, p.2, col. 1. **Mr. J.J. Lee**, a merchant in Walhalla, sold 4,127 dozen eggs, 1,000 and fowls (ducks, geese turkeys) to merchants in Charleston, SC.

28 May 1869, p.2, col. 4. Married, on 18th of May 1869, at the residence of bride's father, by **Rev. Mr. Spear**, **Mr. J. F. Burton**, of Georgia and **Miss Cecelia C. Cobb**, daughter of **J.W. Cobb Esq.** of Oconee.

28 May 1869, p.2, col. 4. Advertisement. **Robert A. Thompson**, Agent for Greenville and Columbia Railroad Company, will sell the following at Walhalla Depot on June 1, 1869.

- 1 box, supposed to be books
- 1 box, books for Indians
- 1 package
- 1 parlor stove and pipe

28 May 1869, p.2, col. 4. **R. Lewis**, Justice of Peace in Oconee County, announces that **W.H. Trapier** has made suit to grant him Letters of Administration with will annexed on the Estate and Effects of **M.H. Pyatt**, deceased. Relatives and creditors of **Martha H. Pyatt**, deceased, to appear in Probate Court on 5 June at 11 o'clock.

4 Jun 1869. p. 2, col. 1. Property of **Mrs. Knice** will sell, at auction, on the first Monday in July, several lots in the town of Walhalla.

4 Jun 1869. p. 2, col. 1. **J.M Bryson & Co.** moved from their old stand to the house formerly occupied by **Mr. Ostendorff**, on the corner of Main and Tugalo Streets.

4 Jun 1869. p. 2, col. 1. Post Office, heretofore known as **Anderson's Mills**, in Pickens County, has been reestablished, and **W.G. Field Esq.**, appointed Postmaster. It retains its old name.

4 Jun 1869. p. 2, col. 1. Last week a murder was committed in the settlement known as **Salubrity**, in Pickens County, which exceeds in fiendishness and cowardice anything we ever heard of. The barn and stables of a **Mr. Willard** was discovered to be on fire at a late hour at night, when he and a man

by the name of **Rampey** hastened to the scene of conflagration, to arrest, if possible, the devouring flames. On reaching the spot it was found that the fire had made such headway that it could not be stopped, and **Willard and Rampey** rushed to the stables to rescue the horses and other stock, and while thus engaged were fired upon by unknown persons without. **Mr. Willard** was struck in the neck by a ball, which resulted in his death in a few minutes. **Rampey** was struck on the leg, causing a painful wound. We are not informed of any clue as to who the perpetrators were.

4 Jun 1869. p. 2, col. 1. Blue Ridge Railroad. We learn from **W.H.D. Gaillard, Esq.**, Superintendent, . . . the Blue Ridge Railroad Company will take charge of their road, and run daily trains from Anderson C.H. to Walhalla. . . .

4 Jun 1869. p. 2, col. 2. Election was held in Pickens County to fill unexpired term of **W.T. Field**, resigned, and for Coroner.

4 Jun 1869. p. 2, col. 2. A descriptive list of the burial places of the remains of Confederate soldiers, who fell at the battles of **Antietam, South Mountain, Monacacy**, and other points in **Washington and Frederick** Counties, in the State of Maryland, has been published in pamphlet form by the direction of His Excellency Oden Bowie, Governor of Maryland. . . . The charter of the **Antietam National Cemetery**, granted by the Legislature of Maryland at the January session of 1864, and amended and reenacted at the January session of 1865, provides for the purchase, enclosing, and ornamenting of **ten acres of land – a part of the battlefield of Antietam** – as a burial and final resting place for soldiers who fell in the battle of Antietam. . . . “The remains of the soldiers of the Confederate army to be buried in a part of the grounds separate from those of the Union army.” . . . Friends of the Confederate dead can obtain copies of the pamphlet, free of charge, by addressing **Thomas A. Boulton, Hagerstown Maryland.**

4 Jun 1869. p. 2, col. 4. Poem in memory of **Rebecca Hollingsworth**, who died on the 6th November last, near Townville, Anderson District, SC in the 23rd year of her age. (Poem followed: M. T. P.) Chicago, January 8, 1869.

Old Picture County Court House

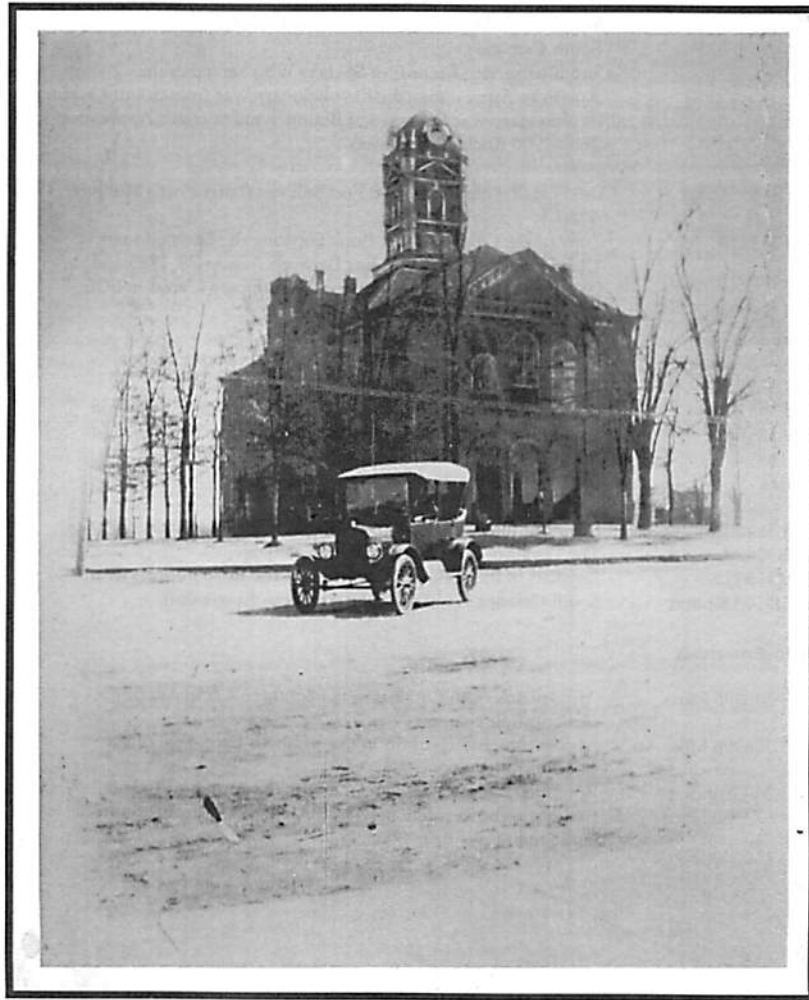
Old Pickens County Court House was practically new when this photograph was made. It was six years old in 1898. The photograph was taken from the top of an old building which stood near the location of the present Pickens Drug Co.

The Street running in front is Main Street and the one along the side is known as Court Street. A close look behind Court House, one can see the home of Sheriff J.H.G. McDaniel.

The Old Furnace burned wood and you can see poles. Burned wood and cord wood piled beside the Old Court House.

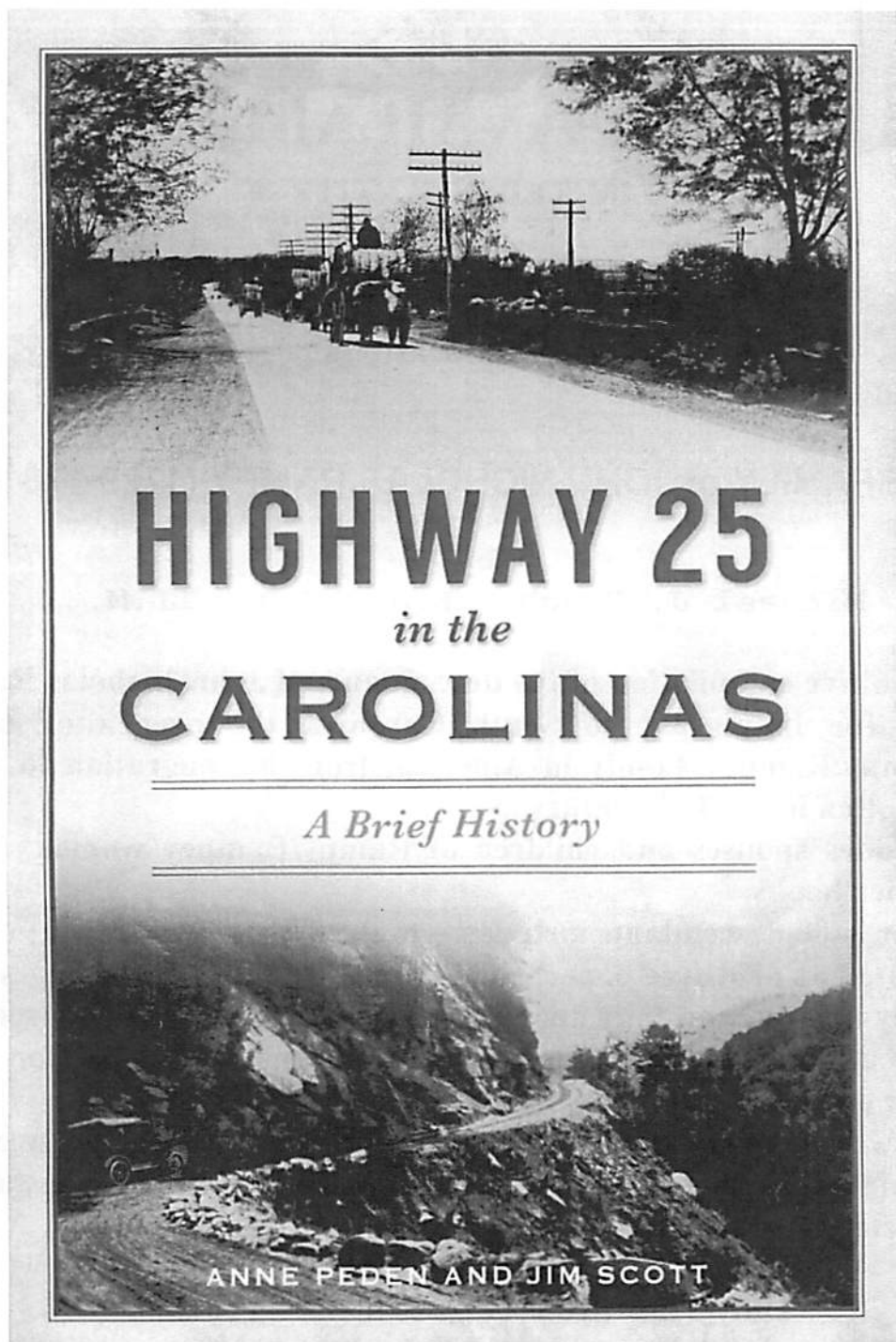
