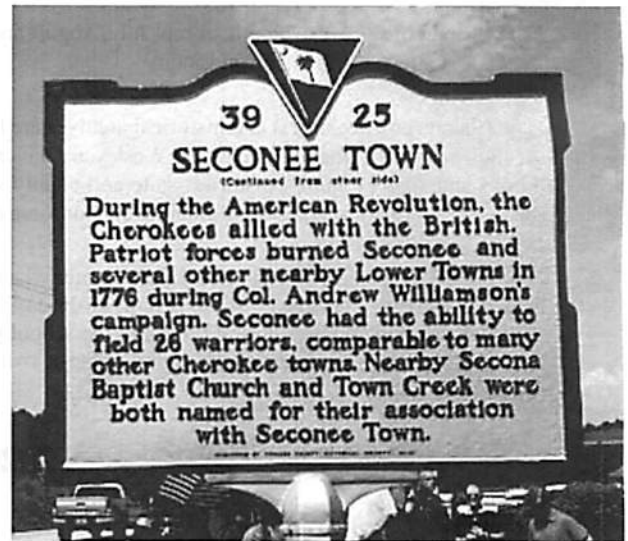

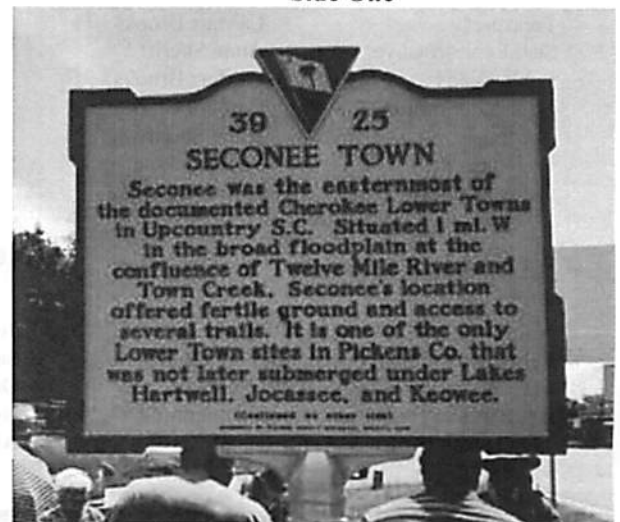

Judge T. J. Mauldin **Pickens Sentinel (27 May 1926)**

Among the ablest and most distinguished men which Pickens County has produced in which it has just pride is Thomas Joab Mauldin, now and for some years past circuit Judge of the 13th Judicial Circuit of South Carolina, a district composed of Greenville and Pickens Counties.

Coming of an honored parentage, being the son of the late Mr. and Mrs. Joab Mauldin, who did their part nobly and bravely in public and private, Judge Mauldin is by heritage a gentleman and by rearing, education and disposition eminently fitted for the high and responsible position which he holds.

Judge Mauldin did not encounter a path of roses in his boyhood days. The South had been devastated by hostile troops in the War Between the States, and even under the best of conditions a young man of those days had to be possessed of an indomitable will to accomplish any noble objective. His parents were not rich in goods of the world, but they gave to him and his brothers and sisters a heritage more valuable than gold and silver – inbred character and a determination to develop their inherent qualities.

After attending local schools, Judge Mauldin was admitted as a student in the Citadel, the military college of South Carolina, where he graduated with high honors.

After graduating, Mr. Mauldin came back to his home town, among his own kith and kin, to begin a career. He entered into the active practice of his profession that of an attorney-at-law, and because of his knowledge of the legal lore was so well grounded he immediately won recognition as a practitioner of ability.

Judge Mauldin has always manifested a friendly interest in his home county. He has always stood four square for the movements which to him seemed designed for the betterment of the people morally and materially and the up-building of the county and betterment of the people morally and materially and the up-building of the county and state. A grateful people recognized his ability and depended upon him as a leader, on several occasions electing him to responsible positions. Mr. Mauldin was elected to the State Senate and for several terms represented the people of this district with signal ability, manifesting all the attributes of statesmanship. For a while Mr. Mauldin edited "The Peoples Journal", a publication that has since suspended, and in this field he showed marked ability.

Thomas Joab Mauldin was elected as Senator to the 70th General Assembly South Carolina Senate (1913-1914). He resigned after the second session upon his appointment as Assistant U.S. District Attorney.

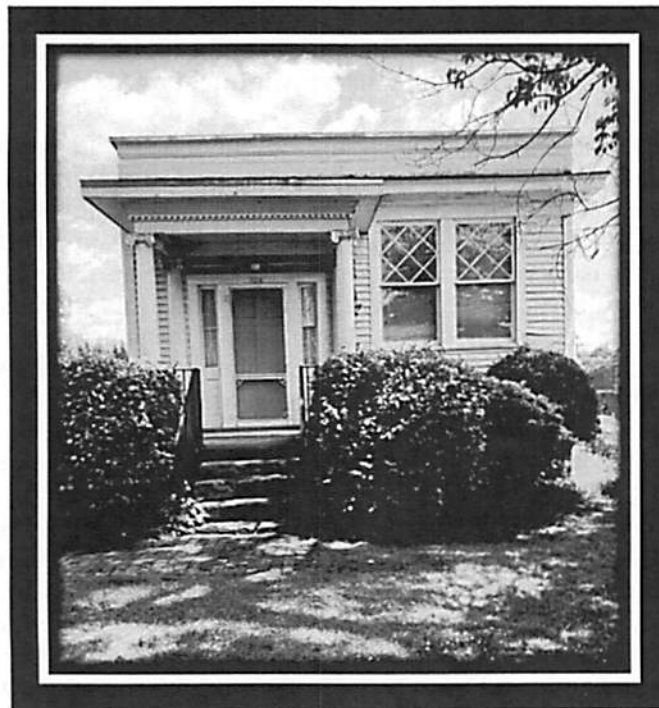
In 1914 Mr. Mauldin was elected judge of the 13th judicial circuit. A man of handsome and striking personality, of amiable disposition and fine sense of humor, coupled with rare intellect, splendid education and a deep rooted sense of justice and equality of all men before the law, he possesses in an eminent way the requisites of an ideal judge. And Judge Mauldin has justified his election term in and term out by his judicial career. His record is most pleasing to his friends and the encomiums he has received should be gratifying to him. A great jurist – and more than that – a great judge, who understands human nature, its weaknesses, its temptations, the shaping influences of environment, and who can understand with knowledge of all of these things how to deal with erring men who have been overtaken in a fault by the law, he fits gracefully and graciously the exalted place which has been given him, tempering justice with mercy were deserved, and preserving among a free people that proper and necessary respect for the laws and their courts.

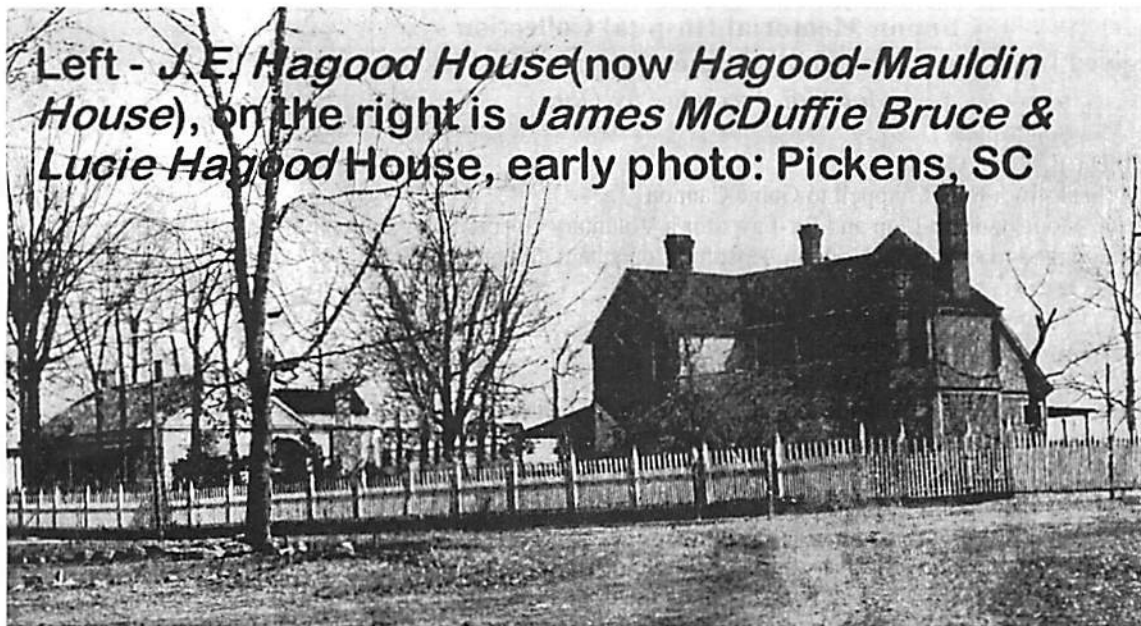
In early life Judge Mauldin formed a co-partnership which, according to his own admissions, has helped to shape his career thus far. He was married to Miss Frances Miles Hagood, a daughter of the late Colonel J.E. Hagood, one of South Carolina's outstanding characters in political and civil life. Mrs. Mauldin is also very prominent in public life of the Palmetto State, being president of the South Carolina Division of the United Daughters of the Confederacy. She is also prominently connected with the Daughters of the American Revolution. Mrs. Mauldin is loved by hundreds of people in Pickens County for the good that she has done in giving her support to the worthy movements designed to promote the moral and material progress of the community and its people.

Thomas Joab Mauldin (Cousin of William Harrison Mauldin; cousin of William Lawrence Mauldin; cousin of Earle Elias Morris). Pickens County. SC House of Representatives 1904-1914, resigned on election as judge of 13th Judicial Circuit 27 Feb 1914, serving until death. Thomas Mauldin was born 21 Jul 1870, the son of Joab Mauldin and Deborah Reed Hollingsworth. Attended Piedmont Institute; graduated from The Citadel, B.S., with second honors, 1891; read law in office of uncle, Col. C.L. Hollingsworth, and admitted to SC Bar 16 Dec 1892. Teacher in rural school, 1892-1894. Principal of private school in Laurens, 1894-1896. Editor of *Pickens Sentinel*, 1897. Entered the practice of law in 1897. Married Frances Miles Hagood 28 Sep 1904. Captain of Pickens Rifles, SC Bar Association. Shriner. Mason. Sons of Confederate Veterans. Sons of American Revolution, president of chapter, 1925-1931. County Red Cross chairman during World War I. Knights of Pythias. Member of Grace Methodist Church; steward, trustee; superintendent of Sunday School, 1910 to death. Died 22 Oct 1931, in office as circuit judge; buried in family cemetery north of Pickens. (Source: *Biographical Directory of Senate of the State of South Carolina 1776-1964*, p. 264.)

Warrant Pack 144. Number 6. On October 2, 1879 **Thomas Westly** made oath that he has good reason to believe that **James Hunter** will do him some bodily injury or cause the same to be done and that he has threatened to kill him, and he craves securities for the peace.

Warrant Pack 145. Number 1. One June 28, 1873 **Thomas G. Boggs** made oath that he has reason to believe and does believe that **Susan Boggs, Dick Hadden, Wesley Johnson and Charley Lemmon?** did on the night of 26th June inst. break and enter his meat house and take therefrom eight pieces of bacon and otherwise commit burglary and theft all within the curtilage of his mansion or dwelling, and he believes that the said stolen property is now concealed and in the possession of the above and he craves a warrant to search their houses for the stolen property.

Warrant Pack 145. Number 2. At a court of sessions at Pickens on March 1, 1890, **Ervin Ellison & Corbin Medlin** did on the 5th Oct. 1889 did willfully and maliciously disturb and interrupt a congregation convened for the purpose of religious worship at **Twelve Mile Camp Ground** in said county by then and there fighting and talking in a loud tone of voice . . .

State of South Carolina

Pickens County.

Having heard that certain parties have been presented by the grand jury for misconduct &c. As **Irwin C. Ellison** is one of the number and I being a neighbor of his and know this to be the first time he has been guilty of such misconduct, and his father being a member of church in good standing, and I cannot think the young man **Ellison** at fault from the fact that he was assaulted by two men & had to defend himself. I think he is to be pitted (sic) for being caught in bad company and hope you brethren will sign this petition to be presented to the Hon. Solicitor in his behalf.

Warrant Pack 145. Number 3. On March 21, 1884 a complaint was made by **W.S. Kirksey** that **Frank Crane** a citizen of Pickens Township was assigned to the section of road running from **H.B. Hendricks to ford of Wolf Creek and snake road** and was legally warned to work said road on March 21, 1884, said notice was given by virtue of authority vested him by a commission as overseer, and that **Frank Crane** did willfully refuse to work said road. . . In court **Frank Crane** stated, "I am an entered or subscriber student at **Miss Hudgens School**. Was regularly attending school until I was taken sick, as soon as my health will admit I intend to resume school for the remainder of the year . . .

Warrant Pack 145. Number 4. On Sept. 8, 1879 **T.W. Young** made a complaint that one **Jack Connor** did unlawfully & willfully refuse to labor on the Public Highway. In court **V.A. Ferguson** stated that he went to the house of **Jack Connor** to warn him to work on the road and **Jack** was not at home and told his wife to tell him, she said that she would. I heard **Jack** say he would not work the road any more as long as **Mr. Young** was overseer. **Jack** did not work when I warned him. The court found **Jack Connor** guilty and sentenced him to 5 days in jail or a fifty dollar fine.

Warrant Pack 145. Number 5. On Dec. 18, 1882 a complaint was made by **B.D. Garvin** that at **J.J. Garvins** in Pickens County on the 18th Dec. 1882 one **Jobe Smith** did abduct & forcibly (sic) take from the custody of **J.J. Garvin**, 2 minor children **Nettie & Cora Smith**. In one place written **Nettie and Mary Smith**. **J.J. Garvin** states that he had in his custody the 2 minor children **Mary & Nettie Smith** age 2 and 3 years (the 2 years also looked like

a 3) & that they were abducted from him by **Job Smith** on or about Dec. 18, 1882, he states that he was not in the house but the children were & that he saw **Smith** coming out of the house with the children and they were crying & saying that they did not want to go. He had gotten near his house with the children & I told him to let the children alone and he said mind your business and the last he saw of them they had the children in their arms carrying (sic) them away. (Note: The word they might have been meant for he.) **Mary Collins** sworn said that she and **Lizzie Jameson** were sitting by the fire in the house of **J.J. Garvin** and that **Job Smith** came into the house and carried the children away, they were crying and saying that they did not want to go. **J.J. Garvin** said that children are his daughters and were left in his custody at her death and that he was served with a writ of Habus (sic) Corpus & the case was tried & the court held that he the said **J.J. Garvin** was the proper person to take the children in charge . . .

Warrant Pack 145. Number 6. The number was not listed.

Warrant Pack 145. Number 7. On June 1, 1882 **John W. Ellis & Mary Pilgrim** was arrested for adultery.

Warrant Pack 150. No. 1. James P. Brooks states that on June 13th 1889 **Joseph Sloane** did commit an assault upon his wife **Amanda Brooks** with intent to ravish by getting up out of his room where he was sleeping & going into her room & to her bed and take hold of her. . . **Amanda Brooks** sworn saith (sic), "I live in Pickens County, South Carolina. I know **Joseph Sloane**. On the night of the 13th of last June between 12 & 1 o'clock, **Joseph Sloane** got up out of his bed in the dining room at my house and came into my room where I was and took hold of my arm. I was in bed, I jerked loose from him & struck at him & hit him on [one] of his shoulders & called to **Mr. Brooks** (my husband). **Mr. Brooks** was in another bed in another portion of the house, asleep, I could not wake him by calling him, then I got up and went to his bed and waked him up, and told him what had happened after I struck **Sloane** he went back into the dining room and layed down. My husband said that he would get up and fix him. I begged him to consider my condition & not to raise any fuss, in my presence, I was preganant (sic). **Mr. Brooks** went off to see a doctor that day and never came back until near 10 o'clock at night. I had done ate supper & gone to bed before he got back. There was no one at my house except myself & small children & **Joseph Sloane** until my husband came back. I heard him ask **Sloane** the next morning what he went into my room for last night, he said he went in there to get his knife, said that he had left it in there at dinner time the day before on the lounge. He did not leave his knife on the lounge that evening & I didnt (sic) see any knife for I spread the cloth on the lounge that evening, and I saw him have his knife in the dining room that night while I was fixing supper.

James P. Brooks sworn sayeth, I live in Pickens County, S.C. on **Dr. Doyles plantation**. I know **Joseph Sloane**. On the 13th of last June between 12 & 1 o'clock my wife came to me where I was lying in bed, asked me why I didn't come to her when she called me. I told her I didn't hear her and asked her what was the matter. She said that **Sloane** had come to her bed and taken hold of her and tried to pull her out of the bed. I told her then to lie down in my bed and keep quiet & I would get up and settle it with him. She begged me to remember her condition and get some one else. I got up then and lit the lamp and set it the fireboard in the room where me and my wife was at that time to make a fire in the kitchen. He was sleeping in the kitchen, he was in his bed when I called him, the kitchen is an adjoining room to my wifes room. He got up and made a fire. I went in to the kitchen and stayed in there 10 or 15 minutes, then I went back into my wifes room and sat down on the side of the bed where my wife was. She seemed to be scared, I tried to quite her. I sat on the side of the bed till 4 o'clock the next morning. I called **Sloane** then and told him to take a plane that I had borrowed of (cant make out) and carry it to him. When he started with the plane I went after **Mrs. Alfred Holcombe** & found **Mr. McKeer**? there and asked them both to go down home with me & when **Sloane** came back I asked him what he went into my wifes room for. He said that he had went in there to get his knife that he had left on the lounge the day before at dinner time. I asked him if he was hunting his knife what business he had with his hands on my wife, he said he stumbled and got his hands on the bed, said he wanted his knife to open some sores on his legs, then I told him to get his clothes on and leave & he done so. He pulled up his pants and said he could show us where the sores was, but I didn't see any. I had been away that day and it was about 9 o'clock or a little after when I got home. I did not see any thing of **Jo** when I got home nor hear any thing of him. On being cross examined **Brooks** said, I don't know recollect of **Jo** asking me any question when I went into the kitchen after he had made a fire. I might have told **Jo** that I had the headache but I don't know, but I know that he had his knife open in his hand and went back and payed down on the pallet with it open.
