Marker Dedicated at the Grave of John Miller at Old Stone Church Cemetery

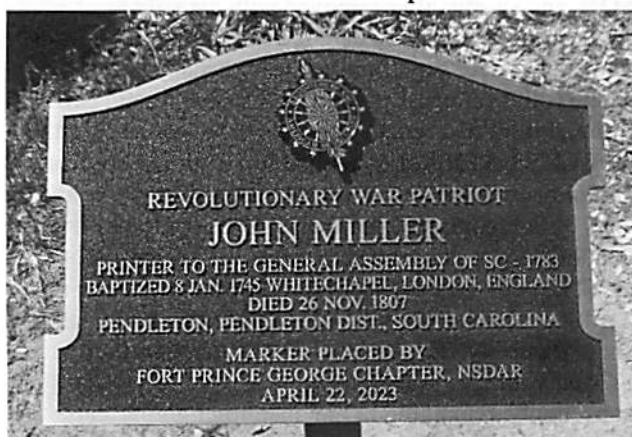
John Miller was an English printer who believed in a free press, and because he was rather outspoken regarding many political topics in London, he ended up in jail. Miller was fond of saying “laziness in politics is like laziness in agriculture, it exposes the soil to noxious weeds.” He immigrated to South Carolina in 1783 – and found his American dream – a free press.

Sandy Foster, Miller’s sixth-great-granddaughter, wanted Miller to receive the recognition he deserved as a Patriot of the Revolutionary War. Foster, a member of the Fort Prince George Chapter (FPG) of the Daughters of the American Revolution (DAR) gathered at the Old Stone Church and Cemetery, with her family and more than 65 people for a dedication service to place a DAR marker at his grave on Sunday, April 23, 2023.

Turner has a special affection for her ancestor because she has the same printer’s ink running through her blood. She was one of the creators of the Pickens County Courier and was previously the editor and general manager for the Pickens Sentinel, the Easley Progress, and the Powdersville Post.

Carolyn Nations, SCDAR State Chaplain, Regent of the Fort Prince George (FPG) chapter, and Chair of the Pickens County 250 Committee, welcomed the guests.

Harriet Nash, Historian for the FPG Chapter, gave a brief biography of Patriot John Miller. “When Miller started his newspaper career at the age of 15, strict libel laws in Great Britain and the American colonies made printing anything that offended the king or government a risky business. But a young, intrepid Miller took the risk. Jail and fines became an occupational hazard as he helped forge the path for America’s First Amendment



and more favorable libel laws we still enjoy today. Despite being arrested at least five times, he stuck to his convictions that everyone had a right to know what their government was doing.”

Foster gave personal impressions of Miller and the impact he had on newspapers in America. “Without John Miller we would not have a free press. We have a right to know what our government is doing.” Foster’s daughter and DAR member, Selena Turner, read an article Miller had written for the London Evening Post stating that “any esteemed true Englishmen will ever give their consents to the supporting of such violent measures against our fellow-subjects on America.” This

may be one of the articles that landed him in jail. Donnie Foster, Sandy’s husband and local musician, played *Jesus Savior Pilot Me* on the violin.

Erica Cooper, Fort Prince George Chapter Chaplain and Nations led the audience in the Marker Ritual. Part of the ritual states: “History tells us that what is needed today is not just a show of greatness and a parade of power, but a dedication to great ideals and a high endeavor.”

After the Benediction, the audience proceeded to the gravesite for the unveiling of the marker and Foster’s granddaughter, Skylar Simmons, spread rose petals on Miller’s grave.

JOHN FERGUSON-FROM THE OLD PENDLETON DISTRICT DATA BASE

Among the distinguished citizens of Greenville, S. C., **JOHN FERGUSON**, the subject of this sketch, is a prominent figure. He was born in Pickens County C. H., on the 26th of July, 1841.

He is the son of **JUDGE GRIMKE FERGUSON** the maiden name of his mother being **JANE MANSELL**. Both of his parents were natives of Pickens County, S.C., the father having been born in the same house in which John first saw the light.

It is worthy of mention that the father lived in this same house for seventy-five years. It was erected about the year 1790, by James, father of Judge Ferguson who also occupied it fifty-eight years. He was born in county Antrim, Ireland, and emigrated to America with his parents, **JAMES AND MARY (STRAIN) FERGUSON**, when he was only four years of age. They landed at Charleston and first located at what is known as **Strawberry Ferry, S.C.** Prior to the Revolution, however, they removed to Laurens County, S.C., and located at **Cross Anchor**. The great grandparents of John Ferguson spent the remainder of their lives in Laurens County, both reaching a ripe old age. The great-grandfather and all of his sons served in the continental army throughout the Revolution. Immediately after the war for independence, he removed to Pickens County, where he died in 1848.

JUDGE GRIMKE FERGUSON, father of John, was born 7 Feb 1807, and resided, as above stated, seventy-five years in the same house in which he was born. On the 16th of June, 1835, he was united in marriage to **JANE MANSELL** born in 1814. She was the daughter of **JAMES AND SARAH (THOMPSON) MANSELL**, the latter of whom was born in Greenville County, some miles south of the city of Greenville, where she resided until her marriage.

JAMES MANSELL was born in London, England, and was left an orphan in his childhood. He was bound out, to a saddler whom, however, he did not like, and at the tender age of eight years he ran away and embarked on a vessel bound for America. He was destitute of money and was consequently compelled to work his way on the vessel. He landed at Philadelphia, where he remained until about seventeen years of age, working at the saddlers' trade. He then came to Greenville County, where he was married to **SARAH THOMPSON**, and shortly after removed with his wife to Pickensville. During the remainder of his life, he followed farming. From Pickensville here moved to a point known as "The Trap," [Dacusville] in Pickens County, when about 1849, he died, his wife surviving him until 1864.

The parents of **John Ferguson** had four children of whom he is the youngest. There were two sons and two daughters, all of whom are now living (1892). Their names are **Anna, James M., Sarah and John**. **Anna**, the eldest, is the wife of **DR. JESSE L DEAN**, having first been married to **ROBERT LATHAM**, who died in 1855. Dr. Dean is a distinguished physician, residing at Waco, Texas. **James M.**, the second, graduated at Charleston medical college, and at once took a high position as a physician. He, however, now devotes his attention to farming, his tastes calling him in that direction. He resides near the foot of Pike's Peak, Colorado. **Sarah**, the third, has been twice married, her first husband being **ABNER T. GRIFFIN**, and her second **WILLIAM A. McFALL**; both are now deceased. She resides seven miles south of Anderson Court House. The mother of this family died in 1863, and the father 17 Mar 1884. She was a member of the Methodist Episcopal Church, and he a member of the Masonic fraternity. His occupation was that of a farmer.

John Ferguson resided on the old homestead in Pickens County until he was fourteen years of age. He then entered Thalian Academy, better known as Slab Town, in Anderson County, remaining in that institution three years. He subsequently became a student of Furman University for a single term. In 1860 he entered the law office of **MAJ. B. F. PERRY**, of Greenville, under whose direction he pursued his legal studies for about a year, leaving them to enter the services of the Confederate army. He joined the **Brooks Troop Cavalry Company**, which was a part of the **Hampton Legion**. He served through the entire war, mostly in the commissary, quartermaster and ordnance departments.

April 19, 1865, he was joined in marriage to **MISS HARRIET M. GRADY**, daughter of **JOHN WOODFINE** and **LOUISA WARD (JOHNSON) GRADY**. Miss Grady was first cousin to the late **HENRY W. GRADY**, the distinguished orator and editor of the Atlanta Constitution. The father of Mrs. Ferguson was born in Buncombe County, NC, and was the son of **HENRY AND LEAH (KING) GRADY**, natives respectively of Virginia and North Carolina. The paternal great-grandfather of Mrs. Ferguson was also a Virginian, his wife's maiden name being **SAMONS**.

Mrs. Ferguson's mother was born in Charleston, SC, in 1821, and was the daughter of **TIMOTHY WARD JOHNSON**, a native of New London, Conn. His wife's maiden name was **LOUISA BENNETT MILLER**, of Charleston, daughter of **JOHN MILLER**, whose wife was a Miss **BENNETT**. Her mother's maiden name was **BORNEAU**. Mrs. Ferguson's father and mother were married in 1840, and had seven children, three sons and four daughters. Two sons and three daughters yet survive. Their respective names are **HARRIET M., AGNES L.,** wife of

JACOB P. MILLER, of Greenville; **HENRY C.**, who resides on the old Ferguson Homestead; **WILLIAM S.**, a lumber man by occupation and one of the aldermen of Greenville; **LILLIE D.**, wife of **ROBERT TERRELL** of Hendersonville, N. C.; **JESSIE**, who in her lifetime was the wife of **ROBERT ALLEN**, of Greenville, and **JOHN M.**, who was accidentally drowned when only seven years of age. The father of this family died in 1877. He was a lifelong merchant. His widow still survives and is a member of the Baptist Church.

Mr. Ferguson has been a resident of Greenville ever since his marriage, and for twenty-four years succeeding 1865, he lived at the old home of Mrs. Ferguson. Ever since the war, Mr. Ferguson has given his attention to merchandising, and has been eminently successful, having become one of the most widely and favorably known merchants in the state. Enterprise, uprightness, honesty, and integrity have been the characteristics of his business career. The greater part of his attention has been paid to the grocery and provision trade. His mammoth establishment is in the Ferguson and Miller block, the best-known business block in the city. It was erected by **Mr. Ferguson and Mr. Jacob P. Miller**, his brother-in-law, in 1886, they have been partners in business for over twenty-four years.

Mr. and Mrs. Ferguson have had eight children: **HENRY GRADY**, **LILLIE DEAN**, **JOHN**, **JAMES MANSELL**, **FRANK**, **ANNA DEAN**, **HATTIE MAY** and **JANIE LOUISA**, all of whom are living, except **Lillie Dean**, who died at the age of eleven months. **Henry Grady Ferguson**, the eldest, prepared for college in **Patrick's Military Academy**, remaining there four years. Then entering **Furman University**, he graduated at twenty, with first honors. He had determined in early boyhood to enter the ministry, and following his collegiate course, he entered the **Southern Baptist Theological** seminary, of Louisville, KY., from which he graduated in 1890, among the foremost members of his class. He is now pastor of the Baptist Church at Waynesboro, VA. He is a young man of bright intellect and rare talents.

Mrs. Ferguson is a member of the Baptist church. Mr. Ferguson is a devoted partisan in the Democratic Party, and has reached his ninth degree in the Masonic order. While an active politician, he has persistently refused to be a candidate for office, though many offers have been tendered him in that direction. He is a strict abstainer from the use of spirituous liquors and tobacco, and is one of Greenville's most worthy and honored citizens. [Cyclopedia of Eminent Men....1892]

A Look at Court Square's oldest building.

The Charming Brick building on the southeast corner of **Court Square** has seen much of Greenville's history pass before it's front doors-even the Civil War. It existed before city directories began in 1876, which listed the building as **Ferguson & Miller's Groceries & Provisions**.

John Ferguson and **Jacob Miller** started out in partnership with their father-in-law, **John Grady**, at the store in 1866. According to a Greenville Enterprise notice, Grady, then in a dry goods business partnership with **Robert**

Goodlett, built this new store opposite their old stand in 1856. Among nonresidential downtown structures, only Christ Church Episcopal is older.

Ferguson and Miller's longstanding and successful partnership dissolved in the 1890s, and by 1896 **Eugene F. Bates** set up his expanding wagon business in the building. At the turn of the century, **Ellis & Pope** wholesale grocers occupied the storefront, followed by **W.H. Pool & Co.**, by 1907. The building continued as a grocery store run by **J.H. Bagwell** until the time of WWI. After the war, Standard Furniture Co. occupied the building for five or six years before Jones Furniture Co. moved out of its smaller store on North Main to take over the historic building in 1929.

MR. JOHN FERGUSON KILLED BY A BULL

Gored to Death on Pickens Farm
by Infuriated Animal.

A FINE CITIZEN AND SOLDIER

Formerly a Prominent Merchant of the
Piedmont and a Highly Re-
spected Citizen.

Greenville, May 31.—Major John Ferguson, formerly a merchant of this city, was gored to death by an infuriated Guernsey bull early this morning at his country home in Pickens county.

Mr. Ferguson was 65 years of age. At one time he was probably the largest merchant in South Carolina, outside of the big wholesale houses in Charleston. His firm, Ferguson & Miller, sold goods over the entire upper Piedmont section and as far down as Abbeville.

Several years ago Mr. Ferguson closed out his business in Greenville and retired to his old family home in Pickens county, near Glassy mountain, where he continued to live until his untimely death this morning. He was devoted to farming and paid particular attention to raising blooded cattle, and among his most valuable animals was the thoroughbred bull. His farm, comprising 1,000 acres and including the granite spur known as Glassy mountain, has been in the Ferguson family since the Revolutionary war, and the very house in which Mr. Ferguson breathed his last this morning was for 65 years the home of his father, Judge Grimke Ferguson, and also the home of his grandfather, James Ferguson, both of who died beneath its roof.

While engaged in business in this city Mr. Ferguson maintained a sum-

mer home on the summit of Glassy mountain and there he spent the warm months with his family. There he entertained lavishly, giving a barbecue each year to which the people of the entire country were invited. Several governors of South Carolina have been entertained there.

Mr. Ferguson married Miss Harriet Grady, daughter of John W. Grady, a cousin of the late Henry Grady of Atlanta.

Mr. Ferguson is survived by his wife and the following children: John Ferguson, Jr., James M. Ferguson, Mrs. Andrew Wardlaw, Dr. Frank Ferguson, all of Greenville; Mrs. Harry Valentine of Trenton, N. J., and Mrs. Kemble White of West Virginia. His eldest son, Rev. Henry Grady Ferguson, died at his Virginia home several years ago.

Mr. Ferguson served throughout the four years in the Confederate army. He was a member of the Hampton Legion, his genius for business soon making him invaluable in the commissary department.

No man was more genuinely liked than Mr. Ferguson. He took deep interest in the welfare of young men and many of them who no doubt consider themselves benefactors of his will be grieved to know of his death.

The interment will take place tomorrow at 5 o'clock in Springwood cemetery in this city.

SORROW IN PICKENS.

Tragic Death of Mr. Ferguson a Shock
to Community.

Pickens, May 31.—A gloom was cast over the town of Pickens when it heard the news that their beloved citizen, John Ferguson, who lives near town was gored by a Guernsey bull. He had just finished feeding, when the bull attacked him and knocked him down and gored him to death. His wife, Mrs. Hattie Ferguson, heard him cry out. She was sick in bed, but she jumped up and ran to the piazza. John Simpson, a colored man who was working for Mr. Ferguson, heard him and also saw the bull goring Mr. Ferguson. He secured a pitch fork and fought the animal away. Earl Stephenson, another one of Mr. Ferguson's hands, who was near, ran up and pulled Mr. Ferguson's head out from under the barn. The animal crushed his skull and pushed his head under the barn. He was carried into the house and died a few minutes afterwards. He never spoke after he was hurt.

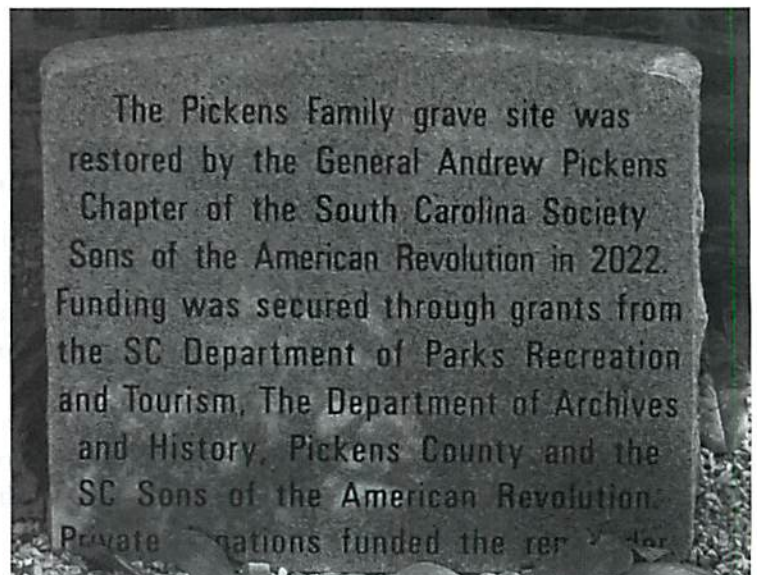
Pictures of the Restored Andrew Pickens Plot at Old Stone Church

6th Cobb in the series of Cobb Cotton Mill Superintendents of Old Pendleton District

From: *A Little Place Called Cateechee, SC* by Jerry L. Alexander-May 9, 1981

One of the best-known mill superintendents in all upper South Carolina was **W. W. Cobb**. He came to Cateechee on June 14, 1920 and served as "Super", judge and father-confident for 29 years until his retirement at age 73 on June 30, 1949.

A native of the Concross Community in Oconee County, he became associated with Norris Cotton Mill after having worked at Union-Buffalo Mills at Union for a number of years. He's first wife was the former **Lille Morrow** of Tryon, Ga. She died in February 1943. His second wife was **India Montgomery**, a Cateechee school teacher.

Tributes were paid him by **G. F. Norris**, mill president and **T. A. Folger**, vice-president, at a retirement dinner in his honor at the Poinsett Hotel in Greenville where he was presented a gold watch during the evening. The directors of the mill passed a resolution expressing appreciation of Mr. Cobb's long service with the company.

He was asked to stay on as technical advisor. **R. A. Taylor**, who had been assistant superintendent for the last few years, was named to succeed Mr. Cobb. Taylor was connected with the mill for some eight years. Mr. Cobb lived until he was 90 years of age, passing away in 1965.

He was well-known among citizens of the village for his famous "Monday morning court" or "Mr. Cobb's Court" as it was sometimes referred to. Usually, he dealt with employees who had gotten a bit unruly over the weekend by celebrating too much. He was said to be stern but fair in his reprimanding of employees and would often give two or more warnings before issuing dismissal paper. The "court" was usually held in his office located adjacent to the mill entrance.

Many employees still say today that Mr. Cobb "straightened Cateechee out" during those early years and his name is spoken for and wide with awe.

Cateechee has had a number of plant superintendents over the years, and while we do not know all of them, we will try and list several.

An early superintendent was a Mr. McSheared, Mr. Ward, and a Mr. Thompson. Following Mr. Taylor was Mr. Brissey, Ernest Washington and Broadus Duncan. The present superintendent is Mr. Vinson (1981).



Mr. and Mrs. W. W. Cobb

Mr. Cobb is credited with "setting a high moral plane for the life of the community" by his Christian character as stated in a resolution commending his work by the company's board of directors. This photo of he and Mrs. Cobb was taken in the early years. She was known as a kind, gentle, dedicated Christian woman. They had a large family of children, some of whom still live in Pickens and surrounding counties.

WARREN WALTER COBB-1930-South Carolina. A native and lifelong resident of northwestern South Carolina, Mr. Cobb has been identified with the cotton mills industry in his native State since his boyhood. During his connection of more than four decades with this industry, he has gained a most thorough knowledge of all its branches and today he is and for many years past, he has been regarded as one of the most expert cotton mill superintendents in this part of the State. For more than a decade he has not served with characteristic ability and efficiency as superintendent of the Norris Mill at Cateechee, Pickens County. Ever since coming to this town he has taken as active and helpful part in its affairs and in many ways has made important contributions to the welfare of the community, its people and its institutions.

Walter Warren Cobb was born in Oconee County, November 10, 1875, a son of **Andy Andrew** and **Matilda (Alexander) Cobb**, both natives of Oconee County. His father, who was born June 5, 1848, was for many years engaged in farming. Mr. Cobb's mother, born in 1844, died in June, 1928. One of a family of nine children, of whom six are now living, Mr. Cobb received his education at the Coneross School and later, as a young man, attended Clemson College for three years. At the age of twelve years, he started to work in a cotton mill and ever since then he has been actively connected with the cotton industry in this part of South Carolina. In 1920 he came to Cateechee, Pickens County, as superintendent of the Norris Mill, in which capacity he has continued to serve with marked success ever since. He is active in civic and religious affairs, and is chairman of the local school board. In politics he is a supporter of the Democratic Party, while his religious affiliations are with the Methodist Episcopal Church, of which he is a steward.

Mr. Cobb married, September 20, 1903, **Lillie Morrow** of Alabama, a daughter of **James** and **Monterey (Welch) Morrow**. Mr. and Mrs. Cobb had twelve children, of whom nine are now living: Ruth, Elizabeth, Chester, Edward, Frances, Catherine, Talmage, Sue Ellen, and John Carlisle. The three children who died were July May, Douglas and Hewitt, the last two having been twins.

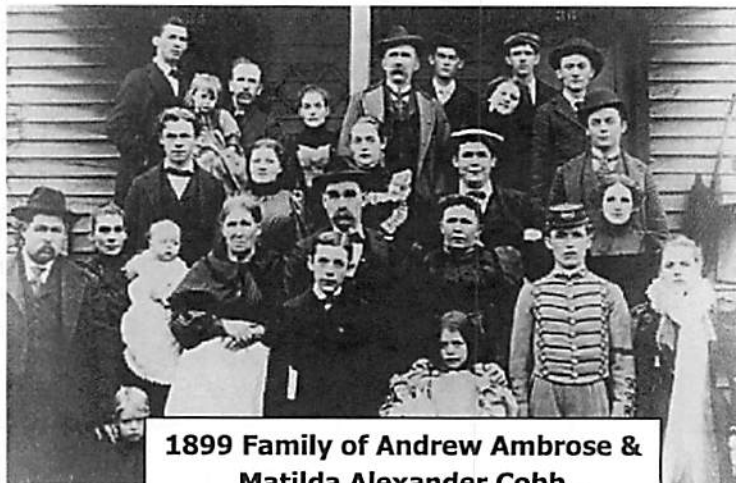

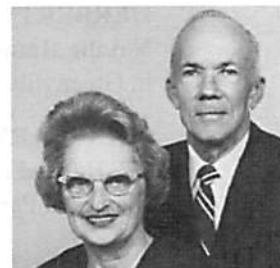

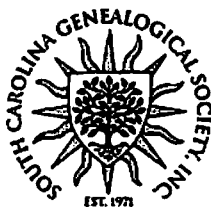
