MAY SPEAKER: PAT McNEELY

spoke about her new book, "Historic South Carolina Ghosts and Legends." Pat stated that South Carolina is one of the most historically haunted places in America. This is evidenced through her many stories told in 32 of the Counties in South Carolina. Pat chose to focus as much as possible on the ghost stories that were linked to public and preferably historic places for her new book.

Pat shared the ghost stories that have been reported in our Old Pendleton District area. Those included Anderson County's Cry Baby Bridge at 2806 High Sholas Road, the resident ghost at Hunter's Store in Pendleton; Pickens County's Hagood Mill's Cherokee witches and the County Museum's (the Old Jail) Lady in the Tower; Oconee County's Stumphouse Tunnel in Walhalla and the Newry Mill ghosts; Greenville County's Poinsett Bridge, the oldest surviving bridge in the state, Campbell's Covered Bridge, the only remaining covered bridge in the state, the ghost of Fannie Heldmann in the downtown Greenville Springwood Cemetery and the ghosts of the Greenville Tuberculosis Hospital. The most haunted cemetery, according to Pat, is Oakwood Cemetery in Spartanburg County. Pat also talked about the ghosts at the Chester Historical Society once the old jail and the Darlington County Museum, also built as a jail.

Pat was Professor Emerita for 33 years in the University of South Carolina College of Journalism teaching writing and reporting. Before joining the faculty, she was a reporter and editor for the *Greenville News*, *The State* and *The Columbia Record*. She is the author of nine other books, some include: Sherman's Flame & Blame Campaign, Lincoln, Sherman, Davis & the Lost Confederate Gold and John C. Calhoun and Andrew Jackson and The Petticoat Affair.

Dear staff members of Congressman Jeff Duncan and Senator Lindsey Graham,

Thank you for taking the time to meet with me. My goal is to bring to your attention an important initiative called "Operation 85", which is aimed at identifying the remains of unrecovered crew members of the battleship U.S.S. Arizona BB-39, who were removed from the ship, and are currently buried in "unknown" commingled graves at the National Memorial Cemetery of the Pacific, 10 miles away from Pearl Harbor.

- Operation 85 is a grassroots effort that has been entirely funded and lead by the families of the missing crew members. Its mission is to find and request DNA Family Reference Samples (FRS) from the direct bloodline family members of the unrecovered crew members, in order to potentially identify 85 or more of those buried in the "unknown" graves. The FRS is being collected by the US Navy & Marine Corps Casualty offices and stored by the Armed Forces Medical Examiners System in Dover, DE. Operation 85 does not collect or facilitate any DNA testing or samples.
- While our main mission is to identify the USS Arizona unknowns buried in commingled graves, our work being done today by the families could be used decades in the future to identify the remains of our fallen family members that may still be entombed inside the ship itself should the integrity of the ship one day fail. A feasibility study conducted by the National Park Service does show that the integrity of the ship "could" last for another 75 years. So there is likelihood that more "unknown" remains could come to the surface in the future, as the ship loses its integrity due to time, and the elements of being in sea water.
- While the US Navy and the US Marine Corps Casualty Offices have been extremely helpful partners in the
 process of getting the FRS kits to the family members we have located, the Defense POW/MIA Accounting
 Agency (DPAA) has refused to acknowledge Operation 85's efforts on this project. The DPAA's sole
 agency mission is to find, recover and bring home "every" missing American service member around the
 world.
- The DPAA has delayed taking action on the missing or unknowns from the U.S.S. Arizona by claiming that the work is too expensive or difficult. Budget planning through fiscal year 2026 does not include <u>any</u> funds for this issue. While it was initially believed that locating family members could cost tens of millions of dollars, Operation 85 was able to find over 90 bloodline-connected family members in under 30 days, with a total cost of \$1,600. plus volunteer hours. Operation 85 has built an online portal submission form that streamlines the information collection process from family members. By utilizing social media, outreach and awareness partnerships, AI, and creative thinking, this investigative work has been done efficiently and cost-effectively with achieving measurable and positive results.
- Operation 85 now represents over 90 family members of the missing U.S.S. Arizona crew members, and
 this number continues to grow daily. However, the DPAA refuses to meet or even have a phone call with
 Operation 85's Executive Director, Kevin Kline. We believe having open communication between the
 government and private organizations can only improve the efficiency and results of what both
 organizations have as the exact same goal.

Included in this package are details and a bio about nine U.S.S. Arizona crew members who are from the State of South Carolina and whose remains were never recovered or identified. One or more of these crew members may be identified with the efforts of Operation 85 and your help!

- (1) Providing outreach and raising awareness to your constituents about Operation 85's mission to find living bloodline family members of the nine missing U.S.S. Arizona crew members from South Carolina.
- (2) Assisting in arranging a meeting between the Director of DPAA and the Director of Operation 85, as well as establishing ongoing communication channels for updates on missing and identified USS Arizona crew members from South Carolina.
- (3) "Opening the Door" and connecting us with other senators and congress members who share our mission of identifying the "unknowns" from the U.S.S. Arizona and may be interested in supporting our cause. We appreciate Mr. Neal Collins' introduction that made this connection possible.
- (4) Support our family efforts to identify all the unknown USS Arizona crew members by helping us urge the DPAA to categorize the U.S.S. Arizona as a "Working Priority" within its organization and budget.

Thank you for your time, and I look forward to working together to continue the success of this effort.

James Gartand Nations was a young mun with a strong sense of duty and a deep love for his country. Born on July 22, 1918, in Hurricene Township (now known as Six Mile) in Pickens County, South Caroline, he grew up in a family of hard-working individuals. His father, its Ble Nations, was a former and a corporter, and his mother, Floy Rampey Nations, worked protessly to care for their family.

As a young man, James was known for his love of hunding and his adverturous spirit. He was a been outdoorsman, and he spent countiess hours exploring the woods and fields near his home wever, his discrime and appretions extended for beyond the boundaries of his small town. He was determined to make a difference in the world, and he knew that serving his country was the best way to do so

In May 1938, James enlisted in the United States Navy with a Itland. He was determined to do his part in defending the country that he loved, and he worked trajectly to prepare for his naval cerver. Over the years, he rose through the ranks, overstantly becoming a fire control-man and petty officer second class on the USS Argona.

Howaver, his premising career was out short on December 7, 1941, when the Japanese launched a surprise attack on Pearl Harbor, James was on board the USS Actions when the ship was hit by multiple bombs, and he was reported missing in action. His family was devestated by the news, and they held out hope that he would somehow be found and brought home safely.

As the days turned into weeks, and the wooks turned into months, the family's hope began to fade. Just before Christmas, the box that they had cont to Jamos was returned unopened and with no explanation. It was a cruel blow, and it left them with more questions than answers.

The official notice of James's death cidn't army until early February. He was just 23 years old Despise their hearthreak, his family took comfort in the knowledge that he had ded defendent the country that he loved. He was honored at a momorial service at his church. Praters Creek Beptist, on February B, 1942.

Jemos's memory lives on, and his sacrifice will always be rememb ered with gratilude and respect. Although his remains were never recovered, he will always be remembered as a true American hero, who selfleesly gave his life in defense of our freedom. His courage and dedication will forever be etched in our hearts, and his memory will never be forgotten.

Some of his remains were identified just a few years ago through DNA my mom sent. We were able to have a funeral for him and place him with his family. It means a lot to family members. Operation 85 is looking to do the same for those who lost their life on USS Arizona during the Pearl Harbor attack. They are looking for family members to submit their DNA so that they can either identify or rule out remains.

South Carolina has 9 men on the list. One, James Garland Nations, is from Six Mile. His next of kin was his father, Blansoo Ila Nations, who was a farmer and carpenter in Six Mile (in the 1930s). Attached should be a letter and bio on the 9 men. Any help locating current family members would be appreciated.

Continued...Another outstanding citizen of the community was FELIX ROGERS. He and his wife raised four children who were orphans, among them was the wife of A. M. Mauldin (Laban Augustus Mauldin). He was a good man and did much for his community. M. P. (Milton Parkins) Rogers was a son of Felix Rogers. He lived in the community in the year 1842. (This must be a typo because Milton Parkins was not born until 1840). He was the father of John, Dave and Henry, also the late Laban Rogers. John and Dave Rogers are members of Enon Baptist Church. Dave is clerk of the church and John is one of the deacons. Henry is one of the active members of the First Baptist Church of Easley. To be continued....

Felix Rogers came to the Mauldin Community from Abbeville District in 1852. From Walnut Grove Baptist Church Records, Abbeville Dist., SC "Felix Rogers, along with daughter Elizabeth joined Walnut Grove Church of Christ, now in Greenwood County, SC (near Ware Shoals), on July 26, 1850. They were both dismissed by letter on Nov. 27, 1852 to join Enon Baptist Church, Pickens County, SC (near Easley).

In the 1850 Census, Felix Rogers is living in the Saluda Regiment of Abbeville District with all of his eight children (that included twins) plus 4 children with the last name Pickens (meant to be Parkins): Daniel age 12- b. 1838, Thomas age 10 -b. 1840, James age 8- b. 1842 and Amanda age 6 -b. 1844. Two of them have the same names as their own children and Amanda was born the same year of their Amanda. These children do not appear with Felix and Cassandra

FELIX M. ROGERS was born on 29 Dec 1803 in Edgefield County, SC. He was the son of REV. DANIEL ROGERS, JR (1761-1843) and LUCRETIA BROMFIELD HARRIS (1765-1844) both born in Edgefield Co., SC. He died on 27 Jan 1863 in Pickensville, Pickens Co., SC. He married CASSANDRA PARKINS, daughter of DANIEL PARKINS (1758-1817) and MARY PETERSON (1790-1815), on 31 Jul 1828. She was born on 22 Sep 1808 in Newberry Co., SC. She died on 13 Sep 1884 in Easley, Pickens Co., SC buried @ Enon Baptist Church Cemetery.


Felix Roger's father was a Revolutionary Soldier from Edgefield Dist., SC:

Another Revolutionary Soldier Gone.—Died on the 22d ult., at his residence, near Saluda River, in Edgefield District, in the eighty-fourth year of his age, DANIEL ROGERS. Been in this State, and having lived in Edgefield District nearly the whole period of his long life, no one was more universally beloved, respected, or possessed of greater confidence and esteem, having served his country faithfully as a revolutionary soldier, in General PICKENS' Division, under Capt. RYAN, and other officers of the army, and for about thirty-four or five years, a fervent member of the Baptist Church.

Felix M. Rogers and Cassandra Parkins had the following children:

1. ELIZABETH ROGERS was born on 20 Nov 1828 in Edgefield District, SC. She died on 11 Nov 1890 in Anderson, Anderson County, SC. She married AUGUSTUS M. HAMILTON, son of CYRUS EARLE HAMILTON and MARY. He was born on 13 Apr 1829 in Anderson District, SC. He died on 29 Dec 1891 in Anderson, Anderson County, SC. Both are buried at Slabtown Memorial Cemetery, Anderson, SC.

2. **DANIEL ROGERS** was born on 07 Aug 1831 in Edgefield County, SC. He died on 11 Mar 1901 in Grand Cane, DeSoto Parish, LA. He married **HARRIET SAMANTHA HARMAN** on 13 Aug 1873 in Panola County, TX. She was born on 03 Jun 1853 in Chambers County, AL. She died on 23 Oct 1921 in Grand Cane, DeSoto Parish, LA. Both buried at Grand Cane Cemetery, Chamber County, AL.

3. **LUCRETIAHARRIS ROGERS** was born on 11 Nov 1833 in Edgefield District, SC. She died on 11 Mar 1863 in Arial, Pickens County, SC and buried at Enon Baptist Church Cemetery.

4. MARQUIS SULLEY ROGERS was born on 28 Jul 1836 in Abbeville District, SC. He died on 14 Sep 1861 in the Civil War.

5. MILTON PARKINS ROGERS was born on 23 May 1840 in Abbeville District, SC. He died on 15 Mar 1914 of Dropsy or kidney trouble, in Easley, Pickens County, SC. He married MARTHA ANN ZANIE HUNT, daughter of JEREMIAH JACKSON HUNT (1815-1906) and FRANCES E. MCALLISTER (1821-1863), on Dec. 7, 1865 at the home of her parents by Rev. T. R. Gary. She was age 14 at this time. She was born on 12 Feb 1843 in Anderson County, SC and moved to Pickens County near Secona Baptist Church site. She died on 30 Mar 1913 in Easley, Pickens County, SC. Both are buried at Enon Baptist Church Cemetery.

Civil War Record: About two years before the war the young men of Williamston, SC formed a company of militia, which they named Gist Rifles, in honor of the Gov. of the State. When war was declared the company, though always retaining its own name, became officially Company D Hampton Legion. It saw hard service. One day on the anniversary of the 1st Battle of Manassas (Bull **Run**) June 21, 1861, MILTON ROGERS fell into reminiscent mood and told of a RAW company's 1st experience of war. There were about 600 men who boarded cars late that Saturday afternoon at Richmond, VA for Manassas Junction. After traveling all night and reaching the Junction a little before day, they were immediately put in motion for the battlefield about 6 miles away. They knew not where they were going but most of them felt there was a fight someplace. Nearing the battlefield well up in the day they could hear the hissing of cannon and the rattle of small arms. That meant business. The men were weary from the terrible heat & loss of sleep. However, they toiled painfully along in columns of 4, anxious, silent but steady the menacing sounds grew more distinct. Milton Rogers was a member of the Gist Rifles of the Hampton Legion & served in the above battle, and later in the Calvary Company on the coast of SC. War records show he was wounded. Information from Eme O'Dell Banister.

Obituary: Mr. Milton P. Rogers died at his home near Easley. 15th inst. in the 74th year of his life, and was buried the day following at Enon Church, funeral servies being conducted by his former pastor, Rev. D. W. Hoitt, in the presence of an immense throng of sympathizing friends. Mr. Rogers was one of our best citizens. He had been a member of Enon Church since his boyood and had served as a deacon for many years. His wife, who was Miss Martha Hunt, died last March. His eldest son, Daniel, died in March 2 years ago. Mr Rogers leaves four sons and two daughters, Laban, John, Henry of Easley, and David, of Greenville; Mrs. Fred O'Dell, of near Easley, and Mrs. C. S. Hall, of Anderson county. He also leaves one brother, Francis Rogers, of near Liberty, and one sister, Mrs. Laban Mauldin, of Easley. Mr. Roper was a Conferate soldier, and it was a bearutiful sight to see his old comrades carry his body to the grave.

"Soldier of Christ, well done; Rest be thy new employ. The battle fought, the vistory won, Enter thy Master's joy!"

He also raised and bred fine horses. Because of his fine horses and carriages, his handsome sons were known over the County as "The Lady's Choice" or dudes of the section. In 1962, Mr. Roark ex-sheriff of Pickens County made this statement: "There was no finer Christian gentleman than Milton Rogers."

From Eme O'Dell Banister: Martha Ann Zanie Hunt went to subscription or private schools in Anderson & Pickens Counties, SC. She joined Enon Baptist Church by letter from Secona Baptist Church in July 1866. She was an immaculate housekeeper and devoted mother.

Civil War Record by Eme O'Dell Banister. I have often heard my Grandmother, Martha Ann Hunt Rogers tell of the War at home during the War Between the States or Civil War. While the men were serving as soldiers the women at home did their part toward maintaining the families & sending the supplies to the front. In the first years it was not hard, but after a time supplies on hand when the war started gave out and so close was the blockade that little could get part. The spinning wheels were brought out of Garrets and girls and women learned to use them. They planted flax and cotton then spun it & made dyes from herbs, roots & berries or buried the material in mud for a while. Little wheat could be raised so cornbread was the ususal food. Parched grain or okra seed ground up were used as a substitute for coffee. The greatest problem was getting salt. The earthen floors of old smokehouses were scraped, the dirt boiled and strained off, then the water left and the salt would settle to the bottom. Corn cobbs were burned to make soda substitutes. Homemade syrup was used almost entirely for sweetening. Pins & needles were scarce and treasured. Tea was made from various leaves & roots; sassafras was preferred but any spicy roots or leaves were used. Buttons were made of persimmon seed or pieces of gourd cut out the desired size and shape and covered with bits of cloth. Ink was made of oak balls or the mashed out jucie of green walnut hulls. Paper was greatly treasured and any old yellow piece was put carefully away. All that history tells us was quite true & I loved to hear grandmother Rogers tell about it. So you can see she too had a war record. She was small of statue, petite, very pretty, happy disposition, and a keen sense of humor and was loved by all who knew her,

6. MARY (MOLLY) AMANDA ROGERS was born on 27 Jul 1844 in Abbeville District, SC. She died on 06 Aug 1914 in Easley, Pickens County, SC. She married LABAN AUGUSTUS MAULDIN, son of VARDREY MAULDIN (1814-1885) and MARY DACUS, (1821-1876) on 11 Jan 1866 in Pickens Co., SC. He was born on 06 Feb 1842 in Pickens County, SC. He died on 10 Aug 1915 in Easley, Pickens Co., SC. Both buried at West View Cem.

7. FRANCIS MARION ROGERS (twin) was born on 10 Jun 1847 in Abbeville District, SC. He died on 25 Nov 1921 in Liberty, Pickens County, SC. 



Enon Baptist Church-Easley, SC

Thanks to member Judith Addis of Anderson for the book "A History of Enon Baptist Church" complied by Mrs. Ethel Rogers Bracken. No date but the last entries were 1982. Many of the Mauldin Community members were buried at the Enon Baptist church cemetery. This is the early history of the church taken from the book.

EARLY YEARS CHAPTER 1-page 1

Enon Baptist Church was organized on June 21, 1851, by L. R. Jennings and Harvin Vandavier with fourteen members, five men and nine women. The members elected Reverend L. R. Jennings as the first Pastor. Reverend John Arial was also elected as first church clerk. In a period of time, three deacons were elected. They were Reverend John Arial, Mr. J. R. Gary and MR. FELIX ROGERS.



Reverend John Arial donated four acres of land on which a brush arbor was built. Services were held in this arbor until a wooden structure was built of hand-hewed logs. This building served the congregation until 1874 when a brick church was erected. The brick were handmade near the home of **ABE MAULDIN**, a faithful member of Enon Church. This small, sturdy church was used as built for sixty-four years. (Until 1938) During the first meeting, the twelve rules of decorum were read and adopted. Also, the church appointed **Elder A. Vandavier** and **Reverend John Arial**, two of the charter members, to carry a petition to the Twelve Mile River Association to be accepted as a member there. Enon Church was accepted into the association in August 1851.

Miss Amanda Craine was the first member to be baptized in the new church. Later, three Negro slaves presented themselves as candidates for baptism. On September 4, 1853, Lewis, a black man belonging to E. Griffin, presented himself as a candidate for baptism. Then in July 1854, Griffin's black slave, Lewis, was expelled from the fellowship, because he was stealing and concealing his master's produce.

Reverend John Arial owned most of the land surrounding Enon Church and the land where the Arial Mill now stands. He owned **Arial Mountain**, and, in fact, most of the land for miles around belonged to his estate. He was licensed into the ministry in July 1851, and ordained to preach the gospel on March 31, 1854. He preached many years and was clerk of the church and a deacon for some time. He was one of the leading Baptist ministers of that day in the community. He married **Miss Perthinice Blassingame** and to this union was born several children. Among them was **Mr. W. H. Arial**, father of **Mr. Tom Arial**, who lived near Enon Church and was owner of the Oak Grove Dairy, which was situated at the old home place of his parents. **Mr. Tom's daughter, Cecil Long**, owns it now, and his granddaughter, **Phronise McNealy**, lives there and is a member of Enon Church. Her sons, Tom and Ben, are also members of Enon Church. There were other wealthy families in the Enon Church Community, although there is no information about them. However, they did their part to carry on the Lord's work, which made Enon Church a living church for each of us to serve in today. In September 1851, Elder James Humphery was called as pastor and served until October 1852. During this time, John Arial and L. R. Gary were elected deacons of the church. Beginning in July 1852, Reverend H. Vandiver served as supply pastor for the remainder of the year. In October 1852, Elder J. R. Hunnicutt was called as pastor for the years 1853, 1854, and part of 1857. In 1854, FELIX ROGERS was elected deacon of the church.

During the early years of the church, the people were punished for their misdeeds. No one was spared from church discipline. Member's accused of unchristian conduct, such as drinking, stealing, dancing, cursing, and even family troubles were brought before the church for discipline. If found guilty, some were turned away from the church. For many years discipline was a strong policy of the church, but as time passed, this policy changed.

When the union meeting of the church was held, it began at nine o'clock on a Sunday, and lasted all day, continuing all week until the next Sunday at six o'clock. The first Sunday school was organized in March of 1854 with a few members. **Reverend W. B. Singleton** was pastor for Enon Church from 1855 to 1859, and then again in 1885 was supply pastor many times. He was evidently a very likeable person and was fondly called "Uncle Buck" by most of the people. He was born in North Carolina on January 28, 1821, and was married August 13, 1840. He joined the Mount Carmel Baptist Church on November 23, 1842 and was ordained to the ministry in 1852.

The work continued during the Civil War, but with several of the men away serving the Confederacy. The pastor. Reverend John Arial, continued the church work with less help. The women and children did all they could at church, and sacrificed in their homes. Reverend T. R. Gary was called to the church during the periods 1863 to 1866, and 1869 to 1876. The church set aside pages in the church minutes to record tributes to those of its number killed in the Civil War. It was with grief that the church recorded the deaths of our honored and beloved men who fell victims in the terrible war of 1861 until 1865.
